16	SECTION 2. EMERGENCY CLAUSE. It is found and determined by the		
17	General Assembly of the State of Arkansas that the law provides no notice of		
18	cancellation of a motor vehicle insurance policy to a lienholder that is not		
19	a bank or other lending institution; that the liens on motor vehicles of good		
20	faith lenders other than banks and lending institutions are in jeopardy of		
21	becoming uninsured for lack of notice of cancellation of the owner's policy;		
22	and that the passage of this act is immediately necessary to ensure the		
23	ability to protect motor vehicle liens from losing insurance coverage due to		
24	lack of notice of cancellation. Therefore, an emergency is declared to exist		
25	and this act being immediately necessary for the preservation of the public		
26	peace, health, and safety shall become effective on:		
27	(1) The date of its approval by the Governor;		
28	(2) If the bill is neither approved nor vetoed by the Governor,		
29	the expiration of the period of time during which the Governor may veto the		
30	bill; or		
31	(3) If the bill is vetoed by the Governor and the veto is		
32	overridden, the date the last house overrides the veto.
