19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

21 SECTION 1. Arkansas Code § 20-76-602(a), pertaining to members of the
22 Community Services Oversight and Planning Council, is amended to read as
23 follows:

24 (a) The Community Services Oversight and Planning Council shall be
25 composed of the following ~~eleven (11)~~ thirteen (13) members ~~appointed by the~~
26 ~~Legislative Council~~ as follows:

27 (1) Three (3) members of the Senate recommended by the President
28 Pro Tempore of the Senate;

29 (2) Three (3) members of the House of Representatives
30 recommended by the Speaker of the House of Representatives; ~~and~~

31 (3) Five (5) members to be appointed by the House of
32 Representatives and Senate cochairs of the Legislative Council as follows:

33 (A) Two (2) providers of community-based developmental
34 disability services licensed by the Division of Developmental Disabilities
35 Services of the Department of Health and Human Services appointed as follows:

36 (i) One (1) member to represent the Developmental



1 Disabilities Provider Association from a list provided by the association;
2 and

3 (ii) One (1) member to represent the Community
4 Developmental Disabilities Provider Network from a list provided by the
5 network;

6 (B) One (1) member who is a provider of community-based
7 services for individuals with behavioral health needs from a list provided by
8 the Mental Health Council of Arkansas;

9 (C) One (1) member who is a provider of community-based
10 services for youth from a list provided by the Arkansas Youth Services
11 Providers Association; and

12 (D) One (1) member who is a provider of community-based
13 services to the aging from a list provided by the Arkansas Association of
14 Area Agencies on Aging; and

15 (4) Two (2) members recommended by the Behavioral Health Private
16 Providers Association of Arkansas to be appointed by the President Pro
17 Tempore of the Senate.
