29	DEVELOPMENTAL DISABILITIES - GRANTS TO COMMUNITY BASED PROVIDERS. Funds
30	allocated under the appropriation for community-based services, for Grants to
31	Community Providers, in the Developmental Disabilities Services - Grants-in-
32	Aid appropriation in this act shall be used only to provide services through
33	private community based services licensed or certified by the Arkansas
34	Division of Developmental Disabilities Services (DDS). Non-profit community-
35	based programs licensed by the Division of Developmental Disabilities
36	Services are quasi-governmental instrumentalities of the state which provide

supports and services to individuals who have a developmental disability or
 delay, who would otherwise require supports and services through state operated programs and facilities owned by the State of Arkansas. When DDS
 licensed providers are involved in delivering services which are Medicaid
 reimbursable, they must enroll as a provider with the Arkansas Medicaid
 Program and must bill the Arkansas Medicaid Program for all covered services
 for eligible individuals.

8 Services which are covered by the Arkansas State Medicaid Program or under 9 the Alternative Community Services Waiver Program (ACS) will be utilized to 10 the maximum extent possible for any individual who is eligible for Medicaid 11 coverage. It is the intent of this section that DDS, as a general policy, 12 maximize the use of Medicaid funding available for appropriate services. 13 The State shall require each provider funded from this Appropriation for 14 community based services, including funding from the Grants/Patient Services 15 Line, in the Developmental Disabilities Services - Operations appropriation, 16 or from the Grants to Community Providers Line, in the Developmental 17 Disabilities Services - Grants-in-Aid appropriation, to screen each individual to whom services are provided for a determination of eligibility 18 19 or ineligibility for Medicaid coverage within thirty days of the first date 20 that services are provided. It is the intent of this section to insure that 21 wherever possible and appropriate, Medicaid funds are utilized for covered or 22 waivered services to individuals who are eligible for coverage under the 23 Arkansas Medicaid Program or the ACS Waiver.

Nothing in this Act shall prevent the Division or any provider from extending emergency services when appropriate measures have been taken in a timely manner to secure Medicaid eligibility.

27 In the event that components of community based services now funded 28 from state and/or federal funds are extended to unserved or underserved areas 29 of the state, or in the event that new services categories/codes are made 30 available, to be funded from state and/or federal funds all non-profit 31 community programs licensed by the Division of Developmental Disabilities 32 Services shall be granted an opportunity to make application to expand their service base to unserved or underserved areas or shall be granted an 33 34 opportunity to make application to offer new services that the State intends 35 to offer. When the Division of Developmental Disabilities Services

36 determines that state and/or federal funding for new or expanded services are

1 to be available, it shall provide written notice by certified mail of its 2 intent to existing licensed providers who are already providing services. If 3 no existing licensed providers respond in writing to Division of 4 Developmental Disabilities Services within thirty days that they will provide 5 the new or expanded services, Division of Developmental Disabilities Services 6 shall provide notice to the general public that a new entity will be allowed to develop services and obtain licensure to provide the new or expanded 7 8 services. Nothing in this Act shall restrict the Division's discretion to 9 award new or expanded services to the existing community based service 10 licensed providers making application for the same pursuant to this section. 11 The intent of this section is to avoid unnecessary duplication of 12 administrative costs and services in the extension or expansion of services. 13 The provisions of this section shall be in effect only from July 1, 2005 14 2007 through June 30, 2007 2009. 15 16 SECTION 13. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. 17 DEVELOPMENTAL DISABILITIES - VOCATIONAL TRAINEES. The Division of 18 19 Developmental Disabilities Services of the Department of Health and Human 20 Services is hereby authorized for the 2005-2007 2007-2009 biennium to provide 21 employment opportunities for people with developmental disabilities residing 22 at the Human Development Centers who work less than a competitive employment 23 level. 24 The provisions of this section shall be in effect only from July 1, 2005 25 2007 through June 30, 2007 2009. 26 SECTION 14. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 27 28 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. 29 DEVELOPMENTAL DISABILITIES - CARRY FORWARD. The unexpended balances in 30 appropriations made from federal funds, for Developmental Disabilities, as provided for in this Act on June 30, 2006 2008 shall be carried forward and 31 32 made available for expenditures for the same purpose for the fiscal year 33 ending June 30, 2007 2009. 34 35 Any carry forward of unexpended balance of appropriation and/or funding as authorized herein, may be carried forward under the following conditions: 36

3	its reason(s) for the need to carry forward said appropriation and/or funding
4	to the Department of Finance and Administration Office of Budget;

8	the first fiscal year of the biennium to the second fiscal year of the
9	biennium by the September Arkansas Legislative Council or Joint Budget

11	report shall include the name of the Agency, Board, Commission or Institution
12	and the amount of the appropriation and/or funding carried forward from the
13	first fiscal year to the second fiscal year, the program name or line item,

17	(3) Each Agency, Board, Commission or Institution shall provide a written

2 appropriated for Grants to Community Providers in the Developmental

3 Disabilities Services - Grants-in-Aid appropriation of this Act, and as a4 condition of receiving such funds they shall:

5 1. Meet minimum standards of performance in the delivery of services to
6 people with disabilities as defined by the Department of <u>Health and</u> Human
7 Services, Developmental Disabilities Services.

8 2. Supply statistical and financial data to the Department of <u>Health and</u>
9 Human Services, Developmental Disabilities Services.

3. Establish and maintain a sound financial management system in
 accordance with guidelines as set forth by the Department of <u>Health and</u> Human

4. Establish and maintain community support programs designed to provide coordinated care and treatment to ensure ongoing involvement and individualized services for persons with disabilities. Every community support program shall provide services for persons with disabilities who reside within the respective area of the program.

21 SECTION 16. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 22 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. 23 DEVELOPMENTAL DISABILITIES - TIMBER AND LAND SALES PROCEEDS - CAPITAL 24 IMPROVEMENTS AND EQUIPMENT. The Division of Developmental Disabilities 25 Services is authorized to use the administrative operating have each fund 26 accounts for capital improvements to physical plants and for the purchase of 27 capital equipment. , and for the operation of the six human development 28 centers operated by the Department of Human Services, Division of 29 Developmental Disabilities Services. The cash funds shall be held by the 30 Department of Health and Human Services, Division of Developmental 31 Disabilities Services from the proceeds of the sale of land and the sale of 32 timber that may be harvested from land owned by the Division of Developmental 33 Disabilities Services. All funds deposited and all expenses shall be tracked 34 separately. The sale of land and the harvesting of timber is specifically 35 authorized to provide funds to finance capital improvements to the physical plants, for the purchase of major capital equipment., and for the operation 36

1 of any of the six human development centers from which the land or timber is
2 sold.

3 The Division of Developmental Disabilities Services shall report all income 4 derived from the sale of land and timber management to the Chief Fiscal 5 Officer of the State and the Arkansas Legislative Council. Any contracts 6 initiated for the sale of land or the harvesting of timber shall be submitted 7 to the Review Subcommittee of the Arkansas Legislative Council for prior 8 review. All expenditures of funds derived from the sale of land and the sale 9 of timber will be expended in accordance with relevant state purchasing laws. 10 The provisions of this section shall be in effect only from July 1, 2005 11 2007 through June 30, 2007 2009.

SECTION 17. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS

16 The Developmental Disabilities Services Board or the Department of (A) 17 Health and Human Services shall not close any of the state administered Human 18 Development Centers that provide therapy and residential services. 19 The Department of Health and Human Services shall continue to accept (B) 20 clients for whom it has determined that therapy and residential services are 21 needed at state administered Human Development Centers and Community Programs 22 licensed by DDS shall continue to accept clients for whom it has been 23 determined in accordance with federal law that are in need of services in the 24 community.

(C) Except for use as federal matching funds, no funds for community based services licensed by DDS shall be transferred from Grants to Community Providers line item of the Developmental Disabilities Services - Grants-in-Aid appropriation unless the transfer(s) directly benefits community based services for persons with developmental disabilities or from the appropriation for the Human Development Centers unless the transfer(s) directly benefits the Human Development Centers.

32 (D) Nor shall any general revenue funding as of March 1, 2005 2007 from the

SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 7 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. SPECIAL 8 PROVISIONS FOR SHIFT DIFFERENTIAL AND WEEKEND PAY FOR PERSONNEL AT HUMAN 9 DEVELOPMENT CENTERS. SHIFT DIFFERENTIAL. Personnel employed in areas 10 providing critical support and care to Patient Units at the state operated 11 human development centers during evening and night shifts shall be eligible to receive up to twenty percent (20%) of the hourly rate paid as a shift 12 differential. Personnel required to provide critical and support care to 13 client units during weekend hours shall be eligible to receive up to twenty 14 15 percent (20%) of the hourly rate paid as weekend differential. When 16 facilities use shifts other than traditional eight-hour shifts, shift differential may be paid for those shifts exceeding the normal day shift of 17 the facility. When shift and weekend differentials are provided to employees 18 19 as herein described, the total compensation may exceed the maximum annual 20 rate for the assigned pay grade for those positions included in this Act. 21 22 The Agency shall identify the shift(s) and job classifications applicable for the differential and the shift differential percentage for which each 23 24 classification is eligible within each shift. The shift schedule, job 25 classification listing and the percentage of shift differential for which the 26 job titles will be eligible shall be submitted to the Office of Personnel 27 Management for approval by the Chief Fiscal Officer of the State. 9 SECTION 20. LEGISLATIVE INTENT. It is the intent of the General Assembly that any funds disbursed under the authority of the appropriations contained 10 11 in this act shall be in compliance with the stated reasons for which this act 12 was adopted, as evidenced by the Agency Requests, Executive Recommendations 13 and Legislative Recommendations contained in the budget manuals prepared by the Department of Finance and Administration, letters, or summarized oral 14 15 testimony in the official minutes of the Arkansas Legislative Council or 16 Joint Budget Committee which relate to its passage and adoption.

SECTION 21. EMERGENCY CLAUSE. It is found and determined by the General 18 Assembly, that the Constitution of the State of Arkansas prohibits the 19 appropriation of funds for more than a two (2) year period; that the 20 21 effectiveness of this Act on July 1, 2007 is essential to the operation of 22 the agency for which the appropriations in this Act are provided, and that in 23 the event of an extension of the Regular Session, the delay in the effective date of this Act beyond July 1, 2007 could work irreparable harm upon the 24 proper administration and provision of essential governmental programs. 25 26 Therefore, an emergency is hereby declared to exist and this Act being 27 necessary for the immediate preservation of the public peace, health and 28 safety shall be in full force and effect from and after July 1, 2007. 29 /s/ Joint Budget Committee 30 31 32 33
