21 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

22

23 SECTION 1. REGULAR SALARIES - OPERATIONS. There is hereby established for
24 the Arkansas Agriculture Department - Operations for the 2007-2009 biennium,
25 the following maximum number of regular employees whose salaries shall be
26 governed by the provisions of the Uniform Classification and Compensation Act
27 (Arkansas Code §§21-5-201 et seq.), or its successor, and all laws amendatory
28 thereto. Provided, however, that any position to which a specific maximum
29 annual salary is set out herein in dollars, shall be exempt from the
30 provisions of said Uniform Classification and Compensation Act. All persons
31 occupying positions authorized herein are hereby governed by the provisions
32 of the Regular Salaries Procedures and Restrictions Act (Arkansas Code §21-5-
33 101), or its successor.

31 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. CARRY
32 FORWARD. Any unexpended balance of appropriation provided in the Brucellosis
33 Control and Eradication Program, which remains at the close of the fiscal
34 year ending June 30, ~~2006~~ 2008, shall be carried forward and made available
35 for the same purpose for the fiscal year ending June 30, ~~2007~~ 2009.

36 Any carry forward of unexpended balance of appropriation and/or funding as

1 authorized herein, may be carried forward under the following conditions:

2 (1) Prior to June 30, 2008 the Agency shall by written statement set forth
3 its reason(s) for the need to carry forward said appropriation and/or funding
4 to the Department of Finance and Administration Office of Budget;

5 (2) The Department of Finance and Administration Office of Budget shall
6 report to the Arkansas Legislative Council all amounts carried forward from
7 the first fiscal year of the biennium to the second fiscal year of the
8 biennium by the September Arkansas Legislative Council or Joint Budget
9 Committee meeting in the second fiscal year of the biennial period which
10 report shall include the name of the Agency, Board, Commission or Institution
11 and the amount of the appropriation and/or funding carried forward from the
12 first fiscal year to the second fiscal year, the program name or line item,
13 the funding source of that appropriation and a copy of the written request
14 set forth in (1) above;

15 (3) Each Agency, Board, Commission or Institution shall provide a written
16 report to the Arkansas Legislative Council or Joint Budget Committee
17 containing all information set forth in item (2) above, along with a written
18 statement as to the current status of the project, contract, purpose etc. for
19 which the carry forward was originally requested no later than thirty (30)
20 days prior to the time the Agency, Board, Commission or Institution presents
21 its budget request to the Arkansas Legislative Council/Joint Budget
22 Committee; and

23 (4) Thereupon, the Department of Finance and Administration shall include
24 all information obtained in item (3) above in the biennial budget manuals
25 and/or a statement of non-compliance by the Agency, Board, Commission or
26 Institution.

27 The provisions of this section shall be in effect only from July 1, 2005
28 2007 through June 30, 2007 2009.

29
30 SECTION 66. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
31 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. FUND
32 TRANSFER. The Executive Director of the Livestock and Poultry Commission,
33 with prior ~~review~~ approval of the Arkansas Legislative Council or the Joint
34 Budget Committee, the approval of the Chief Fiscal Officer of the State, and
35 for the reimbursing of documented expenditures designated by law to be made
36 from the transferred special revenue, may transfer funds among the Livestock

1 and Poultry Equine Infectious Anemia Control Fund, Livestock and Poultry
2 Commission Disease and Pest Control Fund, Livestock and Poultry Special
3 Revenue Fund, Livestock and Poultry Commission Swine Testing Fund, and the
4 Poultry and Egg Grading Fund or from these funds to the Livestock and Poultry
5 Fund Account. The purpose of these transfers shall only be for accurate
6 allocation of incurred costs between the funds. Requests for fund transfer
7 will at least include the total amount to be transferred, to and from which
8 funds, the nature, purpose, and time period of the expenditures being
9 reimbursed, and any other information requested by the Legislative Council or
10 the Joint Budget Committee.

11 Determining the maximum number of employees and the maximum amount of
12 appropriation and general revenue funding for a state agency each fiscal year
13 is the prerogative of the General Assembly. This is usually accomplished by
14 delineating such maximums in the appropriation act(s) for a state agency and
15 the general revenue allocations authorized for each fund and fund account by
16 amendment to the Revenue Stabilization law. Further, the General Assembly
17 has determined that the Arkansas Agriculture Department - Livestock and
18 Poultry Commission may operate more efficiently if some flexibility is
19 provided to the Arkansas Agriculture Department - Livestock and Poultry
20 Commission authorizing broad powers under this Section. Therefore, it is
21 both necessary and appropriate that the General Assembly maintain oversight
22 by requiring prior approval of the Legislative Council or Joint Budget
23 Committee as provided by this section. The requirement of approval by the
24 Legislative Council or Joint Budget Committee is not a severable part of this
25 section. If the requirement of approval by the Legislative Council or Joint
26 Budget Committee is ruled unconstitutional by a court of competent
27 jurisdiction, this entire section is void.

28
29 The provisions of this section shall be in effect only from July 1, 2005
30 2007 through June 30, 2007 2009.

31
32 SECTION 67. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
33 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. TRANSFER
34 PROVISION - PEST ERADICATION. During either fiscal year of the 2005-2007
35 2007-2009 Biennium, if the State Plant Board determines that the demands of
36 pest eradication efforts require additional personnel expenses, with the

1 approval of the Chief Fiscal Officer of the State and ~~review~~ approval by the
2 Legislative Council or Joint Budget Committee, appropriations may be
3 transferred from the Pest Eradication Program special line item to the line
4 items for Regular Salaries, Extra Help, Overtime, and Personal Services
5 Matching.

6 Determining the maximum number of employees and the maximum amount of
7 appropriation and general revenue funding for a state agency each fiscal year
8 is the prerogative of the General Assembly. This is usually accomplished by
9 delineating such maximums in the appropriation act(s) for a state agency and
10 the general revenue allocations authorized for each fund and fund account by
11 amendment to the Revenue Stabilization law. Further, the General Assembly
12 has determined that the State Plant Board may operate more efficiently if
13 some flexibility is provided to the State Plant Board authorizing broad
14 powers under this Section. Therefore, it is both necessary and appropriate
15 that the General Assembly maintain oversight by requiring prior approval of
16 the Legislative Council or Joint Budget Committee as provided by this
17 section. The requirement of approval by the Legislative Council or Joint
18 Budget Committee is not a severable part of this section. If the requirement
19 of approval by the Legislative Council or Joint Budget Committee is ruled
20 unconstitutional by a court of competent jurisdiction, this entire section is
21 void.

22 The provisions of this section shall be in effect only from July 1, 2005
23 2007 through June 30, ~~2007~~ 2009.

25 SECTION 68. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
26 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. EXTRA
27 HELP PROVISION. No employee of the Arkansas Forestry Commission who is
28 employed as "Extra Help" may receive an amount to exceed 3/4 of the maximum
29 annual salary for a comparable position as authorized by Arkansas Code 21-5-
30 201 et seq. during any fiscal year, nor may such employee be employed for a
31 period of time to exceed nine (9) months in any single fiscal year.
32 Provided, however, that no employee of the Arkansas Forestry Commission who
33 is employed as "Extra Help" may receive an amount to exceed seventy five
34 percent (75%) of the maximum annual salary for a comparable position as
35 authorized by Arkansas Code 21-5-201 et seq. during any fiscal year, nor
36 shall such employee be employed for a period of time to exceed fourteen

1 hundred (1400) hours in any single fiscal year.

2 The provisions of this section shall be in effect only from July 1, 2005
3 2007 through June 30, ~~2007~~ 2009.

4
5 SECTION 69. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
6 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. TRANSFER
7 PROVISION. During either fiscal year of the ~~2005-2007~~ 2007-2009 biennium, if
8 the State Forestry Commission determines that temporary firefighters,
9 dispatchers, or pilots are required to meet the demands of a wildfire season,
10 and upon approval of the Chief Fiscal Officer of the State, appropriations
11 may be transferred from either Extra Help or Professional Fees and Services
12 to the proper character code for the employment of such personnel.
13 If the State Forestry Commission determines that the deployment of air
14 tankers for fighting wildfires requires additional Professional Fees and
15 Services, and upon the approval of the Chief Fiscal Officer of the State,
16 excess appropriation in Regular Salaries or Personal Services Matching may be
17 transferred to Professional Fees and Services in Section 3 and 47.

18 If the State Forestry Commission determines that the most effective way for
19 it to cooperate in the growing and distribution of forest planting stock is
20 by contracting work with private vendors and/or hiring temporary employees
21 for seasonal work, the Commission is hereby authorized, upon approval by the
22 Chief Fiscal Officer of the State, to transfer the necessary appropriation
23 authorized for Extra Help and Maintenance and General Operation in Section 3
24 and 47.

25 The provisions of this section shall be in effect only from July 1, 2005
26 2007 through June 30, ~~2007~~ 2009.

27
28 SECTION 70. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
29 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. REFUND TO
30 EXPENDITURE. The Arkansas Forestry Commission is authorized to charge fees
31 to federal agencies and other states to reimburse the Commission for
32 expenditures made on behalf of these governmental units. These fees shall be
33 deposited into the State Forestry Fund in the State Treasury as a refund to
34 expenditure.
35 The provisions of this section shall be in effect only from July 1, 2007
36 through June 30, 2009.

1
2 SECTION 71. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
3 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.

4 ALLOCATION RESTRICTIONS. For the biennium ending June 30, 2009, the
5 Secretary of the Arkansas Department of Agriculture shall at no time
6 designate general revenue allocations to the State Plant Board, the Arkansas
7 Livestock and Poultry Commission and the Arkansas Forestry Commission at a
8 level less than the revenue distribution provided in the Official Forecast of
9 state general revenue in effect on June 30, 2007 for each of those agencies.

10
11 SECTION 72. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized
12 by this act shall be limited to the appropriation for such agency and funds
13 made available by law for the support of such appropriations; and the
14 restrictions of the State Procurement Law, the General Accounting and
15 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
16 Procedures and Restrictions Act, or their successors, and other fiscal
17 control laws of this State, where applicable, and regulations promulgated by
18 the Department of Finance and Administration, as authorized by law, shall be
19 strictly complied with in disbursement of said funds.

20
21 SECTION 73. LEGISLATIVE INTENT. It is the intent of the General Assembly
22 that any funds disbursed under the authority of the appropriations contained
23 in this act shall be in compliance with the stated reasons for which this act
24 was adopted, as evidenced by the Agency Requests, Executive Recommendations
25 and Legislative Recommendations contained in the budget manuals prepared by
26 the Department of Finance and Administration, letters, or summarized oral
27 testimony in the official minutes of the Arkansas Legislative Council or
28 Joint Budget Committee which relate to its passage and adoption.

29
30 SECTION 74. EMERGENCY CLAUSE. It is found and determined by the General
31 Assembly, that the Constitution of the State of Arkansas prohibits the
32 appropriation of funds for more than a two (2) year period; that the
33 effectiveness of this Act on July 1, 2007 is essential to the operation of
34 the agency for which the appropriations in this Act are provided, and that in
35 the event of an extension of the Regular Session, the delay in the effective
36 date of this Act beyond July 1, 2007 could work irreparable harm upon the

1 proper administration and provision of essential governmental programs.
2 Therefore, an emergency is hereby declared to exist and this Act being
3 necessary for the immediate preservation of the public peace, health and
4 safety shall be in full force and effect from and after July 1, 2007.
