     that any funds disbursed under the authority of the appropriations contained

| 8 | SECTION 6. EMERGENCY CLAUSE. It is found and determined by the General |
| 9 | Assembly, that funds provided by the General Assembly for the operations of |
| 10 | the Department of Health & Human Services - Division of Health are, due to |
| 11 | unforeseen circumstances, insufficient for the Department of Health & Human |
| 12 | Services - Division of Health to continue to provide essential governmental |
| 13 | services; that the provisions of this act will provide the necessary monies |
| 14 | for the Department of Health & Human Services - Division of Health to |
| 15 | continue such services; and that a delay in the effective date of this Act |
| 16 | could work irreparable harm upon the proper administration and provision of |
| 17 | essential governmental programs. Therefore, an emergency is hereby declared |
| 18 | to exist and this Act being necessary for the immediate preservation of the |
| 19 | public peace, health and safety shall be in full force and effect from and |
| 20 | after the date of its passage and approval. |
| 21 | If the bill is neither approved nor vetoed by the Governor, it shall become |
| 22 | effective on the expiration of the period of time during which the Governor |
| 23 | may veto the bill. If the bill is vetoed by the Governor and the veto is |
| 24 | overridden, it shall become effective on the date the last house overrides |
| 25 | the veto. |
