22	(f) The Division of Vital Records shall not use a certificate of birth		
23	resulting in stillbirth to calculate live birth statistics.		
24	(g) If a fetal death certificate was issued for a stillbirth, a parent		
25	may request that the Division of Vital Records issue a certificate of birth		
26	resulting in stillbirth without regard to the date on which the fetal death		
27	certificate was issued.		
28	(h) The Division of Vital Records shall prescribe the form and content		
29	of a certificate of birth resulting in stillbirth.		
30	(i) A parent may request the Division of Vital Records to prepare and		
31	issue a certificate of birth resulting in stillbirth without regard to		
32	whether the fetal death occurred on or before the effective date of this act.
