SECTION 23. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. FUNDING PROVISION. In the event the claims in Sections 21-22 of this Act are heard and approved for payment by the Arkansas State Claims Commission the appropriations shall be fully funded from the funds so designated in the amounts indicated. Any claims in Sections 21-22 of this act that are not approved for payment by the Arkansas State Claims Commission shall be considered null and void.

SECTION 24. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. CARRY FORWARD. Any balance remaining in the appropriations authorized by this Act that remain at the end of a fiscal year shall be carried forward into the next fiscal year there to be used for the same purpose.

SECTION 25. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. CARRYOVER OF CLAIMS. Any state agency which is affected by the allowed claim(s) provided for in this Act, and whose fund for the ~~2004-2005~~ 2006-2007 fiscal year are insufficient to allow for the payment of said claim(s) before June 30, ~~2005~~ 2007, is hereby authorized, upon certification by the Chief Fiscal Officer of the State, to make payment of said claim(s) after July 1, ~~2005~~ 2007, from funds appropriated for the ~~2005-2006~~ 2007-2008 fiscal year.

SECTION 26. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. DISBURSING OFFICER. The Clerk of the State Claims Commission is hereby made the disbursing officer for the purpose of paying the claims appropriated by this Act. The Clerk of the State Claims Commission is hereby authorized to receive all warrants prepared under the provisions of this Act from the Auditor of the State and to distribute same to the claimants.

SECTION 27. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. DEPARTMENT OF HEALTH AND HUMAN SERVICES. For any claims in this Act

1 appropriated to the Department of Health and Human Services, the Clerk of the
2 State Claims Commission shall consult with the Department of Health and Human
3 Services and the Chief Fiscal Officer of the State to determine the division
4 and funds to which liability should be assigned and from which the warrants
5 shall be drawn. The Clerk of the State Claims Commission shall initiate the
6 appropriate transfers as may be required and as approved by the Chief Fiscal
7 Officer of the State.

9 SECTION 28. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
10 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. CLAIMS
11 FROM CASH FUNDS. In the event that any claim authorized herein is determined
12 to be a valid claim against the State and the claim is to be paid from funds
13 not in the State Treasury, the Clerk of the State Claims Commission shall
14 notify the agency against which the claim is to be charged of the amount of
15 such claims. Upon receipt of such notification, the state agency shall
16 forthwith deliver a check to the Clerk of the State Claims Commission who
17 shall deposit the same as a non-revenue receipt into the Miscellaneous
18 Revolving fund from which he shall disburse the amount of the claim to the
19 claimant.

20

21 SECTION 29. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
22 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.
23 EMPLOYMENT COMPENSATION CLAIMS. The Clerk of the State Claims Commission
24 shall not distribute any warrants prepared under the provisions of this Act
25 for awards made by the Arkansas State Claims Commission for employment
26 compensation claims. Upon the award by the State Claims Commission of an
27 employment compensation claim, the Clerk of the State Claims Commission shall
28 notify the affected state agency and the Department of Finance and
29 Administration - Office of Personnel Management of such amounts that are due
30 and payable. The affected state agency shall then process the award through
31 the State Mechanized Payroll System.

32

33 SECTION 30. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
34 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. CLAIMS
35 AWARD REPORTING. It is the intent of the General Assembly that when any state
36 agency, board, commission or institution of higher education admits liability

1 to a claim filed with the State Claims Commission and the claim involves a
2 contract with a state agency, board, commission or institution of higher
3 education or the claim exceeds ten thousand dollars (\$10,000) that such
4 agency, board, commission or institution of higher education file a written
5 report thereof to the Litigation Subcommittee of the Arkansas Legislative
6 Council. Such a report shall include a concise statement of facts with an
7 explanation of the agency's liability. Provided further, such report shall
8 be filed with the Litigation Subcommittee within thirty (30) days after the
9 claim has been adjudicated by the State Claims Commission.

10
11 SECTION 31. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized
12 by this act shall be limited to the appropriation for such agency and funds
13 made available by law for the support of such appropriations; and the
14 restrictions of the State Procurement Law, the General Accounting and
15 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
16 Procedures and Restrictions Act, or their successors, and other fiscal
17 control laws of this State, where applicable, and regulations promulgated by
18 the Department of Finance and Administration, as authorized by law, shall be
19 strictly complied with in disbursement of said funds.

20
21 SECTION 32. LEGISLATIVE INTENT. It is the intent of the General Assembly
22 that any funds disbursed under the authority of the appropriations contained
23 in this act shall be in compliance with the stated reasons for which this act
24 was adopted, as evidenced by the Agency Requests, Executive Recommendations
25 and Legislative Recommendations contained in the budget manuals prepared by
26 the Department of Finance and Administration, letters, or summarized oral
27 testimony in the official minutes of the Arkansas Legislative Council or
28 Joint Budget Committee which relate to its passage and adoption.

29
30 SECTION 33. EMERGENCY CLAUSE. It is found and determined by the General
31 Assembly, that the Constitution of the State of Arkansas prohibits the
32 appropriation of funds for more than a two (2) year period; that the
33 effectiveness of this Act on July 1, 2007 is essential to the operation of
34 the agency for which the appropriations in this Act are provided, and that in
35 the event of an extension of the Regular Session, the delay in the effective
36 date of this Act beyond July 1, 2007 could work irreparable harm upon the

1 proper administration and provision of essential governmental programs.
2 Therefore, an emergency is hereby declared to exist and this Act being
3 necessary for the immediate preservation of the public peace, health and
4 safety shall be in full force and effect from and after July 1, 2007.
