34	SECTION 2. COMPLIANCE WITH	OTHER LAWS. Disbursement	of funds authorized

1 restrictions of the State Procurement Law, the General Accounting and 2 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary 3 Procedures and Restrictions Act, the Higher Education Expenditures 4 Restrictions Act, or their successors, and other fiscal control laws of this 5 State, where applicable, and regulations promulgated by the Department of 6 Finance and Administration, as authorized by law, shall be strictly complied 7 with in disbursement of said funds. 8 9 SECTION 3. LEGISLATIVE INTENT. It is the intent of the General Assembly that any funds disbursed under the authority of the appropriations contained 10 11 in this act shall be in compliance with the stated reasons for which this act 12 was adopted, as evidenced by the Agency Requests, Executive Recommendations 13 and Legislative Recommendations contained in the budget manuals prepared by 14 the Department of Finance and Administration, letters, or summarized oral 15 testimony in the official minutes of the Arkansas Legislative Council or 16 Joint Budget Committee which relate to its passage and adoption. 17 18 SECTION 4. EMERGENCY CLAUSE. It is found and determined by the General Assembly, that the Constitution of the State of Arkansas prohibits the 19 20 appropriation of funds for more than a two (2) year period; that the 21 effectiveness of this Act on July 1, 2007 is essential to the operation of 22 the agency for which the appropriations in this Act are provided, and that in 23 the event of an extension of the Regular Session, the delay in the effective date of this Act beyond July 1, 2007 could work irreparable harm upon the 24 25 proper administration and provision of essential governmental programs. 26 Therefore, an emergency is hereby declared to exist and this Act being 27 necessary for the immediate preservation of the public peace, health and 28 safety shall be in full force and effect from and after July 1, 2007. 29 30 31 32 33 34 35 36
