- 34 (7) A projected replacement schedule for technology systems,
- 35 instructional materials, and related academic equipment;
- 36 $\frac{(8)(6)}{(8)}$ Identification of issues with regard to public school

- 1 facility and program access to individuals with disabilities and, if
- 2 necessary, proposed methods for improving access;
- 3 $\frac{(9)(A)}{(7)(A)}$ Identification of committed projects within the
- 4 school district that includes, as applicable, a breakdown of the portion of
- 5 each project into maintenance, repair, and renovation activities and new
- 6 construction activities.
- 7 (B) The portion of a committed project pertaining to
- 8 maintenance, repair, and renovation activities shall identify, as applicable,
- 9 maintenance, repair, and renovation activities associated with academic
- 10 facilities and maintenance, repair, and renovation activities associated with
- 11 nonacademic public school facilities;
- 12 (10)(8) Annual expenditures of the school district for capital
- 13 outlay;
- 14 (11)(9) A description of planned new construction projects with
- 15 cost estimates for each public school facility within the school district and
- 16 needs prioritized as follows:
- 17 (A) Immediate needs that the school district intends to
- 18 address within three (3) years following the submission of the facilities
- 19 master plan;
- 20 (B) Short-term needs that the school district intends to
- 21 address within the four (4) to six (6) years following the submission of the
- 22 facilities master plan; and
- 23 (C) Long-term needs that the school district intends to
- 24 address within the seven (7) to ten (10) years following the submission of
- 25 the facilities master plan;
- 26 (12)(10) Evidence of the school district's insurance coverage,
- 27 including coverage amounts, types of coverage, identification of public
- 28 school facilities covered, policy renewal dates, and all riders.

- 30 SECTION 17. Arkansas Code § 6-21-806, concerning the Academic
- 31 Facilities Master Plan Program school district plan requirements, is amended
- 32 to add an additional subsection to read as follows:
- 33 (e)(1) A school district may amend its facilities master plans at any
- 34 time during the ten-year cycle specified in § 6-21-803.
- 35 (2) An amendment may be submitted out of the regular even-year
- 36 <u>cycle if the district:</u>

1	(A) Has encountered:

3	(ii) A major curriculum change;

5	(iv) An unforeseen occurrence; or
6	(B)(i) Has begun or completed a self-funded construction
7	project over which the Division of Public School Academic Facilities and
8	Transportation has only review authority.
9	(ii) An amendment submitted under subdivision
10	(c)(2)(B)(i) of this section may be submitted in the form of an appendix to
11	the existing district master plan.

13	SECTION 18. Arkansas Code § 6-21-811(a), concerning the Academic
14	Facilities Distress Program. is amended to read as follows:
15	(a) The Division of Public School Academic Facilities and
16	Transportation shall identify a public school or school district as being in
17	academic facilities distress if the division determines that the public
18	school or school district has engaged in actions or inactions that result in
19	any of the following:
20	(1) Any act or violation determined by the division to
21	jeopardize any academic facility used by a public school or school district,
22	including, but not limited to:
23	(A) Material failure to properly maintain academic
24	facilities in accordance with this subchapter and rules adopted by the
25	Commission for Public School Academic Facilities and Transportation;
26	(B) Material violation of local, state, or federal fire,
27	health, or safety code provisions or laws;
28	(C) Material violation of applicable building code
29	provisions or law;
30	(D) Material failure to provide timely and accurate
31	facilities master plans to the division;
32	(E) Material failure to comply with state law governing
33	purchasing or bid requirements in relation to academic facilities projects;
34	or
35	(F) Material default on any school district debt
36	obligation; or

1	(G) Material failure to plan and progress satisfactorily
2	toward accomplishing the priorities established by the division and the
3	approved school district master plans; or
4	(2) Any other condition of an academic facility or facilities in
5	a public school or school district that is determined by the division to have
6	a detrimental impact on educational services provided by that public school
7	or school district.
