12	SECTION 2. Arkansas Code Title 27, Chapter 24, Subchapter 13 is		
13	amended to add an additional section to read as follows:		
14	27-24-1311. Professional firefighters.		
15	(a) The Department of Finance and Administration shall create and		
16	issue a special license plate for professional firefighters under this		
17	section.		
18	(b)(1) The department shall seek the advice of the Arkansas		
19	Professional Firefighters Association regarding the design of the special		
20	license plate under this section.		
21	(2) The Arkansas Professional Firefighters Association may		
22	submit up to three (3) designs to the Department of Finance and		
23	Administration for its consideration.		
24	(c)(1) A professional firefighter may apply for and annually renew a		
25	special license plate issued under this section.		
26	(2) The fee for the initial application for a special license		
27	plate under this section is:		
28	(A) The fee required by law for the registration and		
29	licensing of the motor vehicle;		
30	(B) A handling and administrative fee in the amount of ter		
31	dollars (\$10.00); and		
32	(C) An additional fee of one dollar (\$1.00) to be		
33	deposited into the Fallen Firefighter's Memorial Fund.		
34	(3) The fee for the renewal of a special license plate under		
35	this section is the fee required by law for the registration and licensing of		
36	the motor vehicle and an additional fee of one dollar (\$1,00) to be denosited		

1	into the Fallen Firefighter's Memorial Fund.		
2	(d)(1) Upon the initial application for a special license plate issued		
3	under this section, the professional firefighter shall provide adequate proof		
4	to the department that he or she is a member in good standing with the		
5	Arkansas Professional Firefighters Association.		
6	(2) This subsection shall not require a person who has been		
7	issued a special license plate under this section to present adequate proof		
8	of his or her status as a professional firefighter to the department for the		
9	renewal of his or her license and registration.		
10	(e) The limitation on professional firefighter special license plates		
11	issued under this section is two (2) special license plates for each		
12	household.		
13	(f)(1) The fee remitted under subdivision (c)(2)(B) of this section		
14	shall be deposited into the State Central Services Fund as direct revenue to		
15	the Revenue Division of the Department of Finance and Administration.		
16	(2) The fee shall be credited as supplemental and in addition to		
17	all other funds as may be deposited for the benefit of the division.		
18	(3) The fee shall not be considered or credited to the division		
19	as direct revenue.
