3	SUBCHAPTER 2 CHARITABLE BINGO AND RAFFLES COMMISSION
4	
5	23-114-201. Charitable Bingo and Raffles Oversight Commission —
6	<u>Creation - Members.</u>
7	(a) There is created the Charitable Bingo and Raffles Oversight
8	Commission.
9	(b)(1) The commission shall consist of five (5) members appointed by
10	the Governor for terms of five (5) years.
11	(2) The term of office for each member shall begin on July 1 and
12	shall end on June 30 of the fifth year following the year in which the

8	agent under this subchapter;
9	(4) The rent to be charged is fair and reasonable and will be

12	from the lawful purposes under this chapter;
13	(6) The person whose signature or name appears in the
14	application is in all respects the real party in interest and is not an

19	23-114-303. Licensed agent's residence Authority.
20	(a) A licensed agent shall be an individual resident of Arkansas, a
21	partnership domiciled in Arkansas, or an Arkansas corporation.
22	(b) A Licensed agent has the authority on behalf of a multiple charity
23	unit to provide services. The licensed agent shall enter into individual
24	bingo leases with each charity and a management agreement with the unit, as
25	defined in § 23-115-501, to provide some or all of the following services:
26	(1) Leasing or otherwise obtaining a suitable piece of
27	real estate at which to conduct charitable bingo on behalf of the unit;
28	(2) Improving premise to accommodate bingo including
29	providing for street, exterior and interior signage; ceiling, floor, wall

29	(c) The licensed agent shall enter into individual bingo leases
30	with each charity and a management agreement with the unit. Sample documents
31	shall be promulgated.
32	
33	23-114-304. License fees and training.
34	(a) An authorized organization license may be issued to an authorized
35	organization. The applicant shall pay an annual fee of one hundred dollars
36	(\$100) and post financial security in the amount of five thousand dollars

1	<u>(\$5,000).</u>
2	(b) A licensed agent's license may be issued to a person as described
3	in § 23-114-401 et seq. The applicant shall pay an annual fee of five
4	thousand dollars (\$5,000) and post financial security in the amount of one
5	hundred thousand dollars (\$100,000).
6	(c) Before the issuance of licenses under subsections (a) or (b) of

12	(a) An applicant for a licensed agent license or an authorized

17	(1) The name and address of the applicant and each other person
18	who has a financial interest in or who is in any capacity a real party in
19	interest in the applicant's business as it pertains to this chapter;
20	(2) A designation and address of the premises intended to be
21	covered by the license;
22	(3) The lawful capacity of the premises for public assembly
23	purposes;
24	(4) A statement that a copy of the application has been sent to

28	(c) Any person applying for any license issued by the commission shall

34	23-114-401. Restrictions on premises providers.
35	A person shall not for direct or indirect consideration lease or

3	23-114-402. Single premises.
4	(a) Bingo shall not be conducted at more than one (1) premises on
5	property owned or leased by a licensed authorized organization.
6	(b) The Department of Finance and Administration shall not license
7	more than two (2) affiliated organizations to conduct bingo at the same
8	premises.
9	(c) Up to seven (7) licensed authorized organizations may conduct
10	bingo at the same premises if they have formed a unit, as defined in § 23-
11	115-501, and retained a licensed agent.
12	
13	23-114-403. Admission to bingo games.
14	(a) A person shall not be denied admission to a bingo game or the
15	opportunity to participate in a bingo game because of race, color, creed,
16	religion, national origin, sex, or disability or because the person is not a
17	member of the licensed authorized organization conducting the bingo game.
18	(b) Each license holder can set the age requirements for participating
19	in bingo sessions and being admitted to the bingo facility.
20	
21	<u>23-114-404. Bingo records.</u>
22	(a) The Charitable Bingo and Raffle Oversight Commission by rule may
23	provide for different recordkeeping procedures for licensed authorized
24	organizations by class based on the amount of gross receipts of the
25	organization.
26	(b) An organization conducting bingo shall record on a cash register
27	all transactions for which it receives bingo gross receipts in conformance
28	with Charitable Bingo and Raffle Oversight Commission rules relating to
29	transaction recording specifications.
30	
31	23-114-405. Advertisements.
32	(a) A person other than a licensed authorized organization, unit, or a
33	licensed agent shall not advertise bingo.
34	(b) A licensed authorized organization and a licensed agent may
35	include in an advertisement or promotion the amount of a prize or series of
36	prizes offered at a bingo session.

1	(c) A licensed authorized organization, unit, and licensed agent may
2	market bingo to the general public by utilizing any of the following tools:
3	(1) Advertising the playing times and prizes for its bingo hall
4	in any marketing channels, for example, print, radio, or television, which
5	accept such ads and in printed flyers prepared for that specific purpose;
6	(2) Providing targeted promotional and discounted pricing to
7	<u>attract bingo customers;</u>
8	(3) Providing gift certificates or bingo bucks or discount
9	coupons to attract bingo customers;
10	(4) Offer a door prize by means of a raffle with a value not to
11	exceed \$250 at each session of bingo; and
12	(5) Offering in cooperation with a snack bar, discounted or
13	promotional food pricing to attract bingo customers.
14	
15	23-114-406. Gift certificates.
16	(a) Nothing in this chapter prohibits a licensed authorized
17	organization from selling or redeeming a gift certificate that entitles the
18	bearer of the certificate to play a bingo game.
19	(b) A licensed authorized organization that sells or redeems a gift
20	certificate shall keep adequate records relating to the gift certificate as
21	provided by Charitable Bingo and Raffle Oversight Commission rule.
22	
23	<u>23-114-407. Bingo sessions.</u>
24	(a)(l) A bingo session begins when the first bingo game of that bingo
25	session is commenced by calling the first bingo ball drawn.
26	(2) A licensed authorized organization may conduct up to three
27	(3) bingo sessions on each of two (2) calendar days during a calendar week.
28	(b)(1) No more than two (2) licensed authorized organizations may
29	conduct bingo at the same premises during a twenty-four-hour period.
30	(2) If two (2) organizations conduct bingo at the same premises
31	during a twenty-four-hour period, the bingo sessions shall be announced
32	separately, and an intermission of at least ten (10) minutes shall occur
33	between the bingo sessions.

35	<u>23-114-408.</u> Prizes.
36	(a) A bingo prize shall not have a value of more than five hundred

1	<u>dollars (\$500) for a single game.</u>
2	(b)(1) For the total prizes of all bingo games, an authorized
3	organization shall not offer or award during a single bingo session prizes
4	with an aggregate value of more than one thousand five hundred dollars
5	<u>(\$1,500).</u>
6	(2) In addition to the prize limitation of one thousand five
7	hundred dollars (\$1,500) in subdivision (b)(l) of this section, an authorized
8	organization can play unlimited twenty-five dollar (\$25.00) bingo games
9	before and after the bingo session.
10	(c) A licensed authorized organization shall not award or offer to
11	award a door prize with a value of more than two hundred fifty (\$250) per
12	bingo session. This door prize value shall not accrue against the one
13	thousand five hundred dollar (\$1,500) bingo session prize limitation.
14	(d) A bingo prize, other than cash, may be merchandise with a
15	recognized wholesale cost not to exceed five hundred dollars (\$500). A copy
16	of the receipt for such merchandise shall be included in the charity's daily
17	report.
18	
19	23-114-409. Purchase of bingo paper.
20	Authorized organizations, units, and licensed agents may purchase bingo
21	paper directly from printers and suppliers and are not obligated to purchase
22	bingo paper from distributors.
23	
24	SUBCHAPTER 5 UNIT ACCOUNTING
25	
26	23-114-501. Definitions.
27	As used in this subchapter:
28	(1) "Unit" means two (2) or more licensed authorized organizations
29	that conduct bingo at the same location joining together to share revenues,
30	authorized expenses, and inventory related to bingo operations;
31	(2) "Unit accounting" means a method by which licensed authorized
32	organizations that are members of a unit account for the sharing of revenues,
33	authorized expenses, and inventory related to bingo operations;
34	(3) "Unit accounting agreement" means a written agreement by all the
35	licensed authorized organizations that are members of a unit that contains,

3	(B) The method by which the net proceeds of the bingo operations

7	(D) The methods by which the unit may be dissolved and by which
8	one or more members of the unit may withdraw from participation in the unit,

25	23-114-901. Imposition of penalty.
26	The Department of Finance and Administration may impose an
27	administrative penalty against a person who violates this chapter or a rule
28	or order adopted by the Charitable Bingo and Raffle Oversight Commission
29	under this chapter.
30	
31	23-114-902. Amount of penalty.
32	(a) The amount of the administrative penalty may not exceed one
33	thousand dollars (\$1,000) for each violation. Each day a violation continues
34	or occurs may be considered a separate violation for purposes of imposing a
35	penalty.
36	(b) In determining the amount of the penalty, the Director of Bingo

2	(1) The seriousness of the violation, including the nature,
3	circumstances, extent, and gravity of the prohibited acts;
4	(2) The history of previous violations;
5	(3) The amount necessary to deter future violations;

9	23-114-903. Notice of violation and penalty.
10	(a) If after investigating a possible violation and the facts
11	surrounding that possible violation the Director of Bingo Operations
12	determines that a violation has occurred, the director may issue a violation
13	report stating the facts on which the conclusion that a violation occurred is
14	based, recommending that an administrative penalty be imposed on the person
15	alleged to have committed the violation, and recommending the amount of the
16	proposed penalty. The director shall base the recommended amount of the
17	proposed penalty on the seriousness of the violation determined by
18	consideration of the factors set out in § 23-114-902(b).
19	(b) Not later than the fourteenth day after the date on which the
20	report is issued, the director shall give written notice of the report to the
21	person alleged to have committed the violation.
22	(c) The notice shall:
23	(1) Include a brief summary of the alleged violation;
24	(2) State the amount of the administrative penalty recommended;
25	and
26	(3) Inform the person of the person's right to a hearing on the
27	occurrence of the violation or the amount of the penalty, or both.

29	23-114-904. Penalty to be paid or hearing requested.
30	(a) Not later than the twentieth day after the date the person
31	receives the notice, the person may:
32	(1) Accept the recommendation of the Director of Bingo
33	Operations, including the recommended administrative penalty; or
34	(2) Make a written request for a hearing on the determination.
35	(b) If the person accepts the determination of the director, the
36	director by order shall approve the determination and impose the proposed

Hearing. 4 (a) If the person timely requests a hearing or does not respond to the 5 notice in the time allowed, the Director of Bingo Operations shall set a 6 hearing and give notice of the hearing to the person. 7 (b) The hearings examiner shall make findings of fact and conclusions 8 of law and promptly issue to the Department of Finance and Administration a 9 proposal for decision as to the occurrence of the violation and the amount of the proposed penalty, if a penalty is warranted. 10 11 12 23-114-906. Decision by Director of Bingo Operations. (a) Based on the findings of fact and conclusions of law and the 13 recommendations of the hearings examiner, the Director of Bingo Operations by 14 15 order: 16 (1) May find that a violation has occurred and may impose an 17 administrative penalty; or 18 (2) May find that a violation has not occurred. 19 (b) The director shall give notice of the order to the person. The 20 notice shall include: 21 (1) Separate statements of the findings of fact and conclusions 22 of law; 23 (2) The amount of any penalty imposed; 24 (3) A statement of the right of the person to judicial review of 25 the order; and 26 (4) Other information required by law. 27 28 23-114-907. Options following decision -- Pay or appeal. 29 (a) Not later than the thirtieth day after the date on which the order 30 becomes final, the person shall: 31 (1) Pay the administrative penalty; 32 (2) Pay the penalty and file a petition for judicial review contesting the finding that a violation occurred, the amount of the penalty, 33 34 or both; or 35 (3) Without paying the penalty, file a petition for judicial

review contesting the finding that a violation occurred or the amount of the 36

2	(b) Within the thirty-day period, a person who acts under subdivision
3	(a)(3) of this section may:
4	(1) Stay enforcement of the penalty by:
5	(A) Paying the penalty to the court for placement in an
6	escrow account; or
7	(B) Giving to the court a supersedeas bond approved by the
8	court for the amount of the penalty that is effective until all judicial
9	review of the order is final; or
10	(2) Request the court to stay enforcement of the penalty by:
11	(A) Filing with the court a sworn affidavit of the person
12	stating that the person is financially unable to pay the penalty and is
13	financially unable to give the supersedeas bond; and

16	(c) On receipt of a copy of the affidavit as provided by subdivision
17	(b)(2) of this section, the director may file with the court, not later than
18	the fifth day after the date the copy is received, a contest to the
19	affidavit. The court shall hold a hearing on the facts alleged in the
20	affidavit as soon as practicable and shall stay the enforcement of the
21	penalty on finding that the alleged facts are true. The person who files an
22	affidavit has the burden of proving that the person is financially unable to
23	pay the penalty and to give a supersedeas bond.

25	23-114-908. Collection of penalty.
26	If the person does not pay the administrative penalty and the
27	enforcement of the penalty is not stayed, the Director of Bingo Operations
28	may refer the matter to the Attorney General for collection of the penalty.
29	
30	23-114-909. Determination by court.
31	(a) If the court sustains the finding that a violation occurred, the
32	court may uphold or reduce the amount of the administrative penalty and order
33	the person to pay the full or reduced amount.
34	(b) If the court does not sustain the finding that a violation
35	occurred, the court shall order that a penalty is not owed.
36	

23-114-910. Remittance of penalty and interest. (a) If after judicial review the administrative penalty is reduced or not upheld by the court, the court, after the judgment becomes final, shall: (1) Order the appropriate amount, plus accrued interest, be remitted to the person if the person paid the penalty; or (2) If the person posted a supersedeas bond, order the release of the bond: (A) If the penalty is not upheld; or (B) After the person pays the reduced penalty, if the amount of the penalty is reduced. (b) The interest paid under subdivision (a)(1) of this section is accrued at the rate charged on loans to depository institutions by the Federal Reserve Bank of New York. The interest shall be paid for the period beginning on the date the penalty is paid and ending on the date the penalty is remitted. /s/ Faris
