9	(2) Providing targeted promotional and discounted pricing to
10	<u>attract bingo customers;</u>
11	(3) Providing gift certificates or bingo bucks or discount
12	coupons to attract bingo customers;
13	(4) Offer a door prize by means of a raffle with a value not to
14	exceed \$250 at each session of bingo; and
15	(5) Offering in cooperation with a snack bar, discounted or
16	promotional food pricing to attract bingo customers.
17	
18	23-114-406. Gift certificates.
19	(a) Nothing in this chapter prohibits a licensed authorized
20	organization from selling or redeeming a gift certificate that entitles the
21	bearer of the certificate to play a bingo game.
22	(b) A licensed authorized organization that sells or redeems a gift
23	certificate shall keep adequate records relating to the gift certificate as
24	provided by Charitable Bingo and Raffle Oversight Commission rule.
25	
26	23-114-407. Bingo sessions.
27	(a)(1) A bingo session begins when the first bingo game of that bingo
28	session is commenced by calling the first bingo ball drawn.
29	(2) A licensed authorized organization may conduct up to three
30	(3) bingo sessions on each of two (2) calendar days during a calendar week.
31	(b)(1) No more than two (2) licensed authorized organizations may
32	conduct bingo at the same premises during a twenty-four-hour period.
33	(2) If two (2) organizations conduct bingo at the same premises
34	during a twenty-four-hour period, the bingo sessions shall be announced
35	separately, and an intermission of at least ten (10) minutes shall occur
36	between the bingo sessions.

2	<u>23-114-408. Prizes.</u>
3	(a) A bingo prize shall not have a value of more than five hundred
4	<u>dollars (\$500) for a single game.</u>
5	(b)(1) For the total prizes of all bingo games, an authorized
6	organization shall not offer or award during a single bingo session prizes
7	with an aggregate value of more than one thousand five hundred dollars
8	<u>(\$1,500).</u>
9	(2) In addition to the prize limitation of one thousand five
10	hundred dollars (\$1,500) in subdivision (b)(l) of this section, an authorized

17	(d) A bingo prize, other than cash, may be merchandise with a
18	recognized wholesale cost not to exceed five hundred dollars (\$500). A copy
19	of the receipt for such merchandise shall be included in the licensed
20	authorized organization's daily report.

22	23-114-409. Purchase of bingo paper.
23	Authorized organizations, units, and licensed agents may purchase bingo
24	paper directly from printers and suppliers and are not obligated to purchase
25	<u>bingo paper from distributors.</u>

27	SUBCHAPTER 5 UNIT ACCOUNTING
28	
29	<u>23-114-501. Definitions.</u>
30	<u>As used in this subchapter:</u>
31	(1) "Unit" means two (2) or more licensed authorized organizations
32	that conduct bingo at the same location joining together to share revenues,
33	authorized expenses, and inventory related to bingo operations;
34	(2) "Unit accounting" means a method by which licensed authorized
35	organizations that are members of a unit account for the sharing of revenues,
36	authorized expenses, and inventory related to bingo operations;

1	(3) "Unit accounting agreement" means a written agreement by all the

6	(B) The method by which the net proceeds of the bingo operations
7	of the unit will be apportioned among the members of the unit;
8	(C) The name of the unit manager or designated agent of the
9	unit; and
10	(D) The methods by which the unit may be dissolved and by which
11	one or more members of the unit may withdraw from participation in the unit,
12	including the distribution of funds, records, and inventory and the
13	allocation of authorized expenses and liabilities on dissolution or
14	withdrawal of one or more members of the unit; and
15	(4) "Unit manager" means an individual licensed under this subchapter
16	to be responsible for the revenues, authorized expenses, and inventory of a
17	unit and represents the interests of the authorized organizations with the
18	licensed agent.
19	
20	23-114-502. Accounting unit formation.
21	(a) Two (2) or more licensed authorized organizations may form and
22	operate a unit as provided by this subchapter by executing a unit accounting
23	agreement that identifies the unit manager and the duties of that unit
24	manager.
25	(b)(1) This subchapter does not require a licensed authorized
26	organization to join a unit.
27	(2) Except as provided by subsection (c) of this section,
28	whether to join or withdraw from a unit is at the discretion of each licensed
29	authorized organization.
30	(c)(1) The members of a unit may determine whether to allow another
31	licensed authorized organization to join the unit.
32	(2) The terms of the withdrawal of a member from the unit are
33	governed by the unit accounting agreement.
34	
35	23-114-503. Applicability of chapter.
36	A licensed authorized organization that uses unit accounting is subject

1	to the other provisions of this chapter to the extent the provisions are
2	applicable and are not inconsistent with this subchapter.
3	
4	<u>23-114-504. Conduct of bingo.</u>
5	(a) Each licensed authorized organization that is a member of a unit
6	shall conduct its bingo games separately from the bingo games of the other
7	members of the unit.
8	(b) A unit may purchase or lease bingo supplies and equipment in the
9	same manner as a licensed authorized organization.
10	
11	23-114-505. Unit accounting.
12	(a) A unit:
13	(1) Shall establish and maintain one (1) checking account
14	designated as the unit's bingo account;
15	(2) Shall maintain one (1) inventory of bingo supplies and
16	equipment for use in the bingo operations of members of the unit; and
17	(3) May maintain an interest-bearing savings account designated
18	as the unit's bingo savings account.
19	(b) Each member of a unit shall deposit into the unit's bingo account
20	all funds derived from the conduct of bingo, less the amount awarded as cash
21	prizes. The deposit shall be made not later than the next business day after
22	the day of the bingo session on which the receipts were obtained.
23	(c) All authorized expenses and distributions of the unit and its
24	members shall be paid from the unit's bingo checking account.
25	
26	23-114-506. Disbursement of funds by dissolved unit.
27	(a) For purposes of this subchapter, the requirements that are
28	applicable to a licensed authorized organization shall be applied to a unit.
29	(b) A unit that has dissolved for any reason and has unexpended bingo
30	funds shall disburse those funds to the bingo account of each member of the
31	unit before the end of the next calendar quarter after the calendar quarter
32	in which the unit dissolves.
33	
34	23-114-507. Unit Manager License.
35	(a) If the unit accounting agreement of a unit states that a unit
36	manager is responsible for compliance with Charitable Bingo and Raffle

1	Oversight Commission rules and this chapter, the unit manager is responsible
2	<u>for:</u>
3	(1) The filing of one quarterly report for the unit on a form
4	prescribed by the commission; and
5	(2) The payment of fees and the maintenance of the bingo
6	inventory and financial records of the unit.
7	(b) A unit with a unit manager shall notify the Department of Finance
8	and Administration of the name of the unit manager and immediately notify the
9	Department of any change of unit manager.
10	(c)(l) A person shall not provide services as a unit manager to
11	licensed authorized organizations that form a unit unless the person holds a
12	unit manager license under this subchapter.
13	(2) A person designated as a licensed agent is not a unit
14	manager on account of that designation for purposes of this section.
15	(d) An applicant for a unit manager license shall file with the
16	department a written application on a form prescribed by the department that
17	includes:
18	(1) The name and address of the applicant;
19	(2) Information regarding whether the applicant, or any officer,
20	director, or employee of the applicant, has been convicted of a felony,
21	criminal fraud, gambling or gambling-related offense, or crime of moral
22	turpitude; and
23	(3) Any other information required by commission rule.
24	(e) A person who holds a unit manager license shall post a bond or
25	other form of security authorized by the commission.
26	(f) A person is not eligible for a unit manager license under this
27	subchapter if the person, or any officer, director, or employee of the
28	person:
29	(1) Has been convicted of a felony, criminal fraud, a gambling
30	or gambling-related offense, or crime of moral turpitude, if less than ten
31	(10) years has elapsed since the termination of a sentence, parole, or
32	community supervision served for the offense;
33	(2) Is an owner, officer, or director of a licensed agent, is
34	employed by a licensed agent, or is related to a licensed agent within the
35	second degree by consanguinity or affinity, unless the holder of the license
36	is a licensed authorized organization or an association of licensed

1	authorized organizations; or
2	(3) Holds or is listed on another license under this chapter,
3	unless the holder of the license is a licensed authorized organization or an
4	association of licensed authorized organizations.
5	(g) A unit manager shall complete the training required by

8	SUBCHAPTER 6 BINGO ACCOUNTS AND USE OF PROCEEDS

10	23-114-601. Organization bingo accounts.
11	(a)(l) A licensed authorized organization shall establish and maintain
12	one regular checking account designated as the bingo account.
13	(2) A licensed authorized organization may also maintain an
14	interest-bearing savings account designated as the bingo savings account.
15	(b)(1) A licensed authorized organization shall deposit into the bingo
16	account all funds derived from the conduct of bingo, less the amount awarded
17	as cash prizes. Except as provided by subdivision (b)(2) of this section, a
18	deposit shall be made not later than the next business day after the day of
19	the bingo session on which the receipts were obtained.
20	(2) A licensed authorized organization may deposit funds derived
21	from the conduct of bingo that are paid through a debit card transaction into
22	the bingo fund not later than seventy-two (72) hours after the transaction.
23	(c) A licensed authorized organization may lend money from its general
24	fund to its bingo account if the organization requests and receives the prior
25	approval of the Department of Finance and Administration. Except as provided
26	by this section, no other funds may be deposited into the bingo account.
27	(d) A licensed authorized organization shall not commingle gross
28	receipts derived from the conduct of bingo with other funds of the
29	organization.
30	(e) Except as permitted, the licensed authorized organization shall
31	not transfer gross receipts to another account maintained by the licensed
32	authorized organization.
33	(f) A licensed authorized organization shall maintain all of its
34	savings and checking accounts in a financial institution in this state.
35	
36	23-114-602. Withdrawals from bingo account.

1	(a)(1) Funds from the bingo account shall be withdrawn by preprinted,
2	consecutively numbered checks or withdrawal slips, signed by an authorized
3	representative of the licensed authorized organization and made payable to a
4	person.
5	(2) A check or withdrawal slip shall not be made payable to
6	"cash," "bearer," or a fictitious payee.
7	(3) The nature of the payment made shall also be noted on the
8	face of the check or withdrawal slip.
9	(b) The checks for the bingo account shall be imprinted with the words
10	"Bingo Account" and shall contain the licensed authorized organization's
11	bingo license number on the face of each check.
12	(c) A licensed authorized organization shall keep and account for all
13	checks and withdrawal slips, including voided checks and withdrawal slips.
14	
15	23-114-603. Authorized uses of bingo account.
16	(a) A licensed authorized organization may draw a check on its bingo
17	account only for:
18	(1) The payment of necessary and reasonable bona fide expenses,
19	including compensation of personnel incurred and paid in connection with the
20	conduct of bingo;
21	(2) The disbursement of net proceeds derived from the conduct of
22	bingo to charitable purposes; or
23	(3) The transfer of net proceeds derived from the conduct of
24	bingo to the licensed authorized organization's bingo savings account pending
25	a disbursement to a charitable purpose.
26	(b) A licensed authorized organization shall make the disbursement of
27	net proceeds on deposit in the bingo savings account to a charitable purpose
28	by transferring the intended disbursement back into the licensed authorized
29	organization's bingo account and then withdrawing an amount by a check drawn
30	on the bingo account.
31	
32	23-114-604. Use of net proceeds for charitable purposes.
33	(a) A licensed authorized organization shall devote to the charitable
34	purposes of the licensed authorized organization its net proceeds of bingo.
35	(b) Except as otherwise provided by law, the net proceeds derived from
36	bingo are dedicated to the charitable purposes of the licensed authorized

23	23-114-605. Use of proceeds by recipient.
24	<u>A person given bingo proceeds for a charitable purpose shall not use</u>
25	the donation:
26	(1) To pay for services rendered or materials purchased in connection
27	with the conduct of bingo by the donor organization; or
28	(2) For a purpose that would not constitute a charitable purpose if
29	the activity were conducted by the donor organization.

31	23-114-606. Use of proceeds by a licensed authorized organization.
32	<u>A licensed authorized organization shall not use the net proceeds from</u>
33	bingo directly or indirectly to:
34	(1) Support or oppose a candidate or slate of candidates for

5	(a) Expenses that are reasonable or necessary to conduct bingo may be

17	a Veteran's Administration medical center or a military hospital, solely for
18	the purpose of amusement and recreation of its members, residents, or
19	patients, when:
20	(A) No player or other person furnishes anything of more
21	than nominal value for the opportunity to participate; and
22	(B) The prizes awarded or to be awarded are nominal; or
23	(4) On behalf of a business conducting the game for promotional
24	or advertising purposes if:
25	(A) The game is conducted by or through a newspaper or a
26	radio or television station;
27	(B) Participation in the game is open to the general
28	public and is not limited to customers of the business;
29	(C) Playing materials are furnished without charge to a
30	person on request; and
31	(D) No player is required to furnish anything of value for
32	the opportunity to participate.
33	(b) A violation of subsection (a) of this section is a Class A
34	misdemeanor.

36	23-114-802. Fraudulent award of prizes Offense.

1	(a) A person commits an offense if the person knowingly participates
2	in the award of a prize to a bingo player in a manner that disregards, to any
3	extent, the random selection of numbers or symbols.
4	
5	(b) It is a defense to prosecution under this section that no
6	participant in the game furnished anything of value for the opportunity to
7	participate in the game.
8	(c) A violation of subsection (b) of this section is a Class A
9	misdemeanor.

12	23-114-803. Other offenses Revocation of License.
13	(a) A person commits an offense and the person's license is subject to
14	revocation under this chapter if the person:
15	(1) Makes a false statement or material omission in an
16	application for a license under this chapter;

32	23-114-902. Amount of penalty.
33	(a) The amount of the administrative penalty may not exceed one
34	thousand dollars (\$1,000) for each violation. Each day a violation continues
35	or occurs may be considered a separate violation for purposes of imposing a
36	penalty.

1	(b) In determining the amount of the penalty, the Director of Bingo
2	Operations shall consider:
3	(1) The seriousness of the violation, including the nature,
4	circumstances, extent, and gravity of the prohibited acts;
5	(2) The history of previous violations;
6	(3) The amount necessary to deter future violations;
7	(4) Efforts to correct the violation; and
8	(5) Any other matter that justice may require.

10	23-114-903. Notice of violation and penalty.
11	(a) If after investigating a possible violation and the facts
12	surrounding that possible violation the Director of Bingo Operations
13	determines that a violation has occurred, the director may issue a violation
14	report stating the facts on which the conclusion that a violation occurred is
15	based, recommending that an administrative penalty be imposed on the person
16	alleged to have committed the violation, and recommending the amount of the
17	proposed penalty. The director shall base the recommended amount of the
18	proposed penalty on the seriousness of the violation determined by

20	(b) Not later than the fourteenth day after the date on which the

31	(a) Not later than the twentieth day after the date the person

35	(2) Make a written request for a hearing on the determination.
36	(b) If the person accepts the determination of the director, the

5	(a) If the person timely requests a hearing or does not respond to the

9	of law and promptly issue to the Department of Finance and Administration a

14	(a) Based on the findings of fact and conclusions of law and the
15	recommendations of the hearings examiner, the Director of Bingo Operations by

19	(2) May find that a violation has not occurred.
20	(b) The director shall give notice of the order to the person. The

17	(c) On receipt of a copy of the affidavit as provided by subdivision
18	(b)(2) of this section, the director may file with the court, not later than
19	the fifth day after the date the copy is received, a contest to the
20	affidavit. The court shall hold a hearing on the facts alleged in the
21	affidavit as soon as practicable and shall stay the enforcement of the
22	penalty on finding that the alleged facts are true. The person who files an
23	affidavit has the burden of proving that the person is financially unable to
24	pay the penalty and to give a supersedeas bond.
25	
26	23-114-908. Collection of penalty.
27	If the person does not pay the administrative penalty and the
28	enforcement of the penalty is not stayed, the Director of Bingo Operations
29	may refer the matter to the Attorney General for collection of the penalty.
30	
31	23-114-909. Determination by court.
32	(a) If the court sustains the finding that a violation occurred, the
33	court may uphold or reduce the amount of the administrative penalty and order
34	the person to pay the full or reduced amount.
35	(b) If the court does not sustain the finding that a violation
36	occurred, the court shall order that a penalty is not owed.

2	23-114-910. Remittance of penalty and interest.
3	(a) If after judicial review the administrative penalty is reduced or
4	not upheld by the court, the court, after the judgment becomes final, shall:
5	(1) Order the appropriate amount, plus accrued interest, be
6	remitted to the person if the person paid the penalty; or
7	(2) If the person posted a supersedeas bond, order the release
8	of the bond:
9	(A) If the penalty is not upheld; or
10	(B) After the person pays the reduced penalty, if the
11	amount of the penalty is reduced.
12	(b) The interest paid under subdivision (a)(l) of this section is
13	accrued at the rate charged on loans to depository institutions by the
14	Federal Reserve Bank of New York. The interest shall be paid for the period
