8 **SENATE CONCURRENT RESOLUTION**

9 TO PROVIDE FOR RECESS OF THE EIGHTY-SIXTH GENERAL  
10 ASSEMBLY AT THE CLOSE OF BUSINESS ON APRIL 7,  
11 2007; TO PROVIDE FOR AN EXTENSION OF THE REGULAR  
12 SESSION OF THE EIGHTY-SIXTH GENERAL ASSEMBLY  
13 UNTIL 12:00 NOON, MAY 4, 2007; TO AUTHORIZE THE  
14 PRESIDENT PRO TEMPORE OF THE SENATE AND THE  
15 SPEAKER OF THE HOUSE OF REPRESENTATIVES, BY JOINT  
16 PROCLAMATION, TO RECONVENE THE GENERAL ASSEMBLY  
17 AT ANY TIME BEFORE 12:00 NOON, MAY 4, 2007, FOR  
18 THE PURPOSE OF CONSIDERING VETOES, CORRECTING  
19 ERRORS OR OVERSIGHTS, COMPLETING ITS WORK ON  
20 PROPOSED CONSTITUTIONAL AMENDMENTS, AND  
21 CONSIDERING THE NEED FOR FURTHER EXTENSION OF THE  
22 REGULAR SESSION OR TO ADJOURN THE EIGHTY-SIXTH  
23 GENERAL ASSEMBLY AT ANY TIME BEFORE THAT DATE IF  
24 THEY DETERMINE THAT THERE IS NO NEED TO  
25 RECONVENE; TO PROVIDE THAT IF THE GENERAL  
26 ASSEMBLY IS NOT RECONVENED OR ADJOURNED BEFORE  
27 12:00 NOON, MAY 4, 2007, THE REGULAR SESSION OF  
28 THE EIGHTY-SIXTH GENERAL ASSEMBLY IS ADJOURNED  
29 SINE DIE ON THAT DATE.

BE IT RESOLVED BY THE SENATE OF THE EIGHTY-SIXTH GENERAL ASSEMBLY OF THE STATE OF ARKANSAS, THE HOUSE OF REPRESENTATIVES CONCURRING THEREIN:

(a) That the Regular Session of the Eighty-sixth General Assembly of the State of Arkansas is extended until 12:00 noon, May 4, 2007;

(b) That the Regular Session of the Eighty-sixth General Assembly of the State of Arkansas shall enter into recess simultaneously at the close of business in each chamber on April 7, 2007, or at such earlier time as may be agreed upon by the House of Representatives and the Senate;

(c) That the Speaker of the House of Representatives and the President Pro Tempore of the Senate may, by joint proclamation:

(1) Reconvene the General Assembly at any time before 12:00 noon, May 4, 2007, for the purpose of:

- (A) Considering vetoes;
- (B) Correcting errors and oversights;
- (C) Completing its work on proposed constitutional amendments; and
- (D) Considering the need for further extension of the Regular Session of the Eighty-sixth General Assembly; or

(2) Adjourn the Regular Session of the Eighty-sixth General Assembly at any time before 12:00 noon, May 4, 2007 if they determine it is not necessary to reconvene; and

(d) That if the General Assembly is not reconvened or adjourned before 12:00 noon, May 4, 2007, the Regular Session of the Eighty-sixth General Assembly is adjourned sine die on that date.
