8	agreed upon by the House of Representatives and the Senate;	
9	(c) That the Speaker of the House of Representatives and the President	
10	Pro Tempore of the Senate may, by joint proclamation:	
11	(1) Reconvene the General Assembly at any time before 12:00	
12	noon, May 2, 2007, for the purpose of:	
13	(A) Considering vetoes;
