Section 19 of Article 7 of the Arkansas Constitution is 4 5 amended to read as follows: 6 § 19. Circuit clerks - Election - Term of office - Ex-officio duties -7 County clerks elected in certain counties. 8 The clerks of the circuit courts shall be elected by the qualified 9 electors of the several counties for the term of two four years, and shall be 10 ex-officio clerks of the county and probate courts and recorder; provided, 11 that in any county having a population exceeding fifteen thousand 12 inhabitants, as shown by the last Federal census, there shall be elected may elect a county clerk, in like manner as the clerk of the circuit court, for 13 14 the term of four years, and in such case the county clerk shall be ex-officio 15 clerk of the probate court Clerk of the Probate Court of such county until 16 otherwise provided by the General Assembly. 17 SECTION 2. Section 29 of Article 7 of the Arkansas Constitution is 20 18 19 amended to read as follows: § 29. County judge - Election - Term - Qualifications. 20 21 The Judge of the County Court shall be elected by the qualified 22 electors of the county for the term of two four years. He shall be at least 23 twenty-five years of age, a citizen of the United States, a man of upright 24 character, of good business education, and a resident of the State for two 25 years before his election; and a resident of the county at the time of his 26 election, and during his continuance in office. 27 28 SECTION 3. Section 38 of Article 7 of the Arkansas Constitution is 29 repealed. Justices of the peace - Election - Term - Oath. 30 The qualified electors of each township shall elect the Justices of the 31 32 Peace for the term of two years; who shall be commissioned by the Governor, 33 and their official oath shall be indorsed on the commission." 34 35 SECTION 4. Section 41 of Article 7 of the Arkansas Constitution is

2 A Justice of the Peace shall be a qualified elector and a resident of the township for which he is elected. 3 4 SECTION 5. Section 46 of Article 7 of the Arkansas Constitution is 5 6 amended to read as follows: 7 § 46. County executive officers - Compensation of county assessor. 8 The qualified electors of each county shall elect one Sheriff, who shall be 9 ex-officio collector of taxes, unless otherwise provided by law; one 10 Assessor, one Coroner, one Treasurer, who shall be ex-officio treasurer of 11 the common school fund of the county, and one County Surveyor; for the term of two four years, with such duties as are now or may be prescribed by law: 12 Provided, that no per centum shall ever be paid to assessors upon the 13 14 valuation or assessment of property by them. 15 16 SECTION 6. Amendment 41 of the Arkansas Constitution is amended to 17 read as follows: Election of county clerk. 18 19 The provisions for the election of a County Clerk upon a population basis are hereby abolished and there may be elected a County Clerk in like 20 21 manner as a Circuit Clerk, for the term of four years, and in such cases, the 22 County Clerk may be ex officio Clerk of the Probate Court of such county 23 until otherwise provided by the General Assembly. 24 25 SECTION 7. Section 2 of Amendment 55 of the Arkansas Constitution is 26 amended to read as follows: 27 § 2. Composition of quorum court - Power over elective offices. 28 (a)(1) No county's Quorum Court shall be comprised of fewer than nine 29 (9) justices of the peace, nor comprised of more than fifteen (15) justices 30 of the peace. 31 (2) A justice of the peace shall be elected for a term of four 32 (4) years, except that the term prior to an apportionment shall be a two-year 33 term. 34 (3) A justice of the peace shall be a qualified elector and a 35 resident of the district for which he or she is elected.

(4) A justice of the peace shall be commissioned by the

1	Governor, and his or her official oath shall be indorsed on the commission.
2	(5) The number of justices of the peace that comprise a county's
3	Quorum Court shall be determined by law.
4	(6) The county's Election Commission shall, after each decennial
5	census, divide the county into convenient and single member districts so that
6	the Quorum Court shall be based upon the inhabitants of the county with each
7	member representing, as nearly as practicable, an equal number thereof.
8	(b) The Quorum Court may create, consolidate, separate, revise, or
9	abandon any elective county office or offices except during the term thereof;
10	provided, however, that a majority of those voting on the question at a
11	general election have approved said action.
