32	Committee in 2003 and in 2005, and as President Pro Tempore of the Senate;
33	has served in the Senate since 1997; and served in the House of

11	President Pro Tempore of the Senate; has served in the Senate since 1999; and
12	served in the House of Representatives from 1995 until 1998; and

14	WHEREAS, Senators Hill, Argue, Bisbee, and Critcher should be commended
15	for their hard work, diligence, and faithful performance of the official
16	duties of office and have contributed to the vitality of this state and its
17	citizens with their excellent representation of their constituents; and

19	WHEREAS, their observance of the highest ethical standards and
20	leadership created an environment of progress and served as a shining example
21	of how the legislative process should work,
