30	effectiveness of this Act on July 1, 2009 is essential to	the operation of							
31	the agency for which the appropriations in this Act are p	rovided, and that in							
32	the event of an extension of the Regular Session, the dela	ay in the effective							
33	date of this Act beyond July 1, 2009 could work irreparab	le harm upon the							
34	proper administration and provision of essential governmental programs.								
35	Therefore, an emergency is hereby declared to exist and the	nis Act being
