21 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
22

23 SECTION 1. REGULAR SALARIES. There is hereby established for the
24 Crowley's Ridge Technical Institute for the 2009-2010 fiscal year, the
25 following maximum number of regular employees whose salaries shall be
26 governed by the provisions of the Uniform Classification and Compensation Act
27 (Arkansas Code §§21-5-201 et seq.), or its successor, and all laws amendatory
28 thereto. Provided, however, that any position to which a specific maximum
29 annual salary is set out herein in dollars, shall be exempt from the
30 provisions of said Uniform Classification and Compensation Act. All persons
31 occupying positions authorized herein are hereby governed by the provisions
32 of the Regular Salaries Procedures and Restrictions Act (Arkansas Code §21-5-
33 101), or its successor.

SECTION 2. EXTRA HELP. There is hereby authorized, for the Crowley's Ridge Technical Institute for the 2009-2010 fiscal year, the following maximum number of part-time or temporary employees, to be known as "Extra Help", payable from funds appropriated herein for such purposes: seventy six (76) temporary or part-time employees, when needed, at rates of pay not to exceed those provided in the Uniform Classification and Compensation Act, or its successor, or this act for the appropriate classification.

SECTION 3. APPROPRIATION - STATE. There is hereby appropriated, to the Crowley's Ridge Technical Institute, to be payable from the Crowley's Ridge Technical Institute Fund, for personal services and operating expenses of the Crowley's Ridge Technical Institute - State for the fiscal year ending June 30, 2010, the following:

15 SECTION 6. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
 16 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. PART-TIME
 17 FACULTY. The Technical Institutes are not required to remit a state
 18 contribution to the state employee insurance trust fund on Workforce
 19 Education part-time faculty positions unless the position will be utilized
 20 for more than 1,000 hours a year.

21 The provisions of this section shall be in effect only from July 1,
 22 ~~2007~~ 2009 through June 30, ~~2009~~ 2010.

24 SECTION 7. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
 25 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.
 26 ADDITIONAL TEACHING LOAD. Instructional staff in a postsecondary technical
 27 institute, as authorized for the various technical institutes, may be paid up
 28 to forty five dollars (\$45) per clock hour for the fiscal year ending June
 29 30, ~~2008~~ 2010 and up to fifty dollars (\$50) per clock hour for the fiscal
 30 ~~year ending June 30, 2009~~, for non-credit teaching assignments; or, up to
 31 five hundred dollars (\$500) per semester hour for the fiscal year ending June
 32 30, ~~2008~~ 2010, and up to five hundred fifty dollars (\$550) per semester hour
 33 ~~for the fiscal year ending June 30, 2009~~, for teaching courses beyond the
 34 defined teaching load; and the employee's maximum allowable salary may be
 35 exceeded by such amount; provided, however, that such additional teaching
 36 load may not exceed one hundred fifty (150) clock hours or nine (9) semester

1 credit hours per school year. Further, the provisions of this section shall
2 only apply to credit and noncredit courses that are funded by Private
3 Industry.

4 The provisions of this section shall be in effect only from July 1,
5 ~~2007~~ 2009 through June 30, ~~2009~~ 2010.

7 SECTION 8. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
8 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. EXTRA
9 HELP RESTRICTION. No employee of Crowley's Ridge Technical Institute, who is
10 employed as "Extra Help" may receive an amount to exceed eighty-five percent
11 (85%) of the maximum annual salary for a comparable position as authorized
12 under Arkansas Code 21-5-201 et seq. during any fiscal year, nor shall such
13 employee be employed for a period of time to exceed fourteen hundred (1400)
14 hours in any single fiscal year.

15 The provisions of this section shall be in effect only from July 1,
16 ~~2007~~ 2009 through June 30, ~~2009~~ 2010.

17
18 SECTION 9. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized
19 by this act shall be limited to the appropriation for such agency and funds
20 made available by law for the support of such appropriations; and the
21 restrictions of the State Procurement Law, the General Accounting and
22 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
23 Procedures and Restrictions Act, or their successors, and other fiscal
24 control laws of this State, where applicable, and regulations promulgated by
25 the Department of Finance and Administration, as authorized by law, shall be
26 strictly complied with in disbursement of said funds.

27
28 SECTION 10. LEGISLATIVE INTENT. It is the intent of the General Assembly
29 that any funds disbursed under the authority of the appropriations contained
30 in this act shall be in compliance with the stated reasons for which this act
31 was adopted, as evidenced by the Agency Requests, Executive Recommendations
32 and Legislative Recommendations contained in the budget manuals prepared by
33 the Department of Finance and Administration, letters, or summarized oral
34 testimony in the official minutes of the Arkansas Legislative Council or
35 Joint Budget Committee which relate to its passage and adoption.
