SECTION 4. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized 14 15 by this act shall be limited to the appropriation for such agency and funds 16 made available by law for the support of such appropriations; and the 17 restrictions of the State Procurement Law, the General Accounting and Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary 18 Procedures and Restrictions Act, or their successors, and other fiscal 19 control laws of this State, where applicable, and regulations promulgated by 20 21 the Department of Finance and Administration, as authorized by law, shall be 22 strictly complied with in disbursement of said funds.

SECTION 5. LEGISLATIVE INTENT.
