1 (3) No member is eligible to purchase service credit in more 2 than one (1) state-supported retirement system for service time in the Arkansas National Guard or in the armed forces reserve. 3 4 (4) Service credit in the system for active duty military 5 service under § 24-2-502 and for service in the Arkansas National Guard or in 6 the armed forces reserve shall not be given for the same period of time. 7 (5) A member's service in the Arkansas National Guard or armed 8 forces reserve shall not make the member eligible for any kind of benefit 9 under any other retirement system, including federal systems, except social 10 security and federal military retirement systems. 11 SECTION 2. Arkansas Code § 24-2-503 is amended to read as follows: 12 24-2-503. Arkansas National Guard and armed forces reserve service 13 14 credit. 15 (a) As used in this section, "armed forces reserve" means one (1) of 16 the reserve components of the armed forces of the United States. 17 (b)(1) A member of the Arkansas Public Employees' Retirement System a state-supported retirement system may purchase credited service in the system 18 19 for a period not to exceed one (1) year for compensated service rendered by the member in the Arkansas National Guard or in the armed forces reserve if 20 21 the member: 22 (A) Makes an application to the Board of Trustees of the 23 Arkansas Public Employees' Retirement System board of trustees of the 24 retirement system in which the member is an active member; 25 (B) Provides the board with satisfactory proof of that 26 person's service in the Arkansas National Guard or in the armed forces 27 reserve; and 28 (C)(i) For the year of service credit granted, pays to the 29 system the employee and employer contributions based on the greater of: 30 (a) The annual salary received by the member for the member's first full year of credited service that precedes the fiscal 31 32 year in which the service is purchased; or 33 (b) The average of the three (3) highest 34 annual salaries earned at the time of purchase. 35 (ii) The member shall pay interest from the end of 36 that year of credited service to the date of payment in full.

Credit for military service. 24 (a) Any person who is a member of the Arkansas State Highway 25 Employees' Retirement System shall be entitled to purchase creditable service 26 in the system for a period not to exceed three (3) five (5) years for active 27 service rendered by the member in the armed forces of the United States, 28 after the member's first employment in a position covered by a state-29 supported retirement system, excluding including active service for the 30 purpose of attending schools or other peacetime training of the member in the 31 military reserve or national guard, if the person: 32 (1) Has ten (10) five (5) years of creditable service with this 33 retirement system; 34 (2) Received an honorable discharge from the armed forces; and 35 (3) Is not receiving federal military service retirement pay, 36 excluding federal military disability retirement pay;

1 (4) Is not qualified to claim the military service in the system
2 under § 24-2-502 or § 24-5-101 et seq.; and

3 (5)(3) Contributes to the members' deposit account a sum of 4 money equal to the amount that would have been contributed during the term of 5 military service allowable, based upon the biweekly earnings of the member at 6 the time the member first reinstates membership in the system after 7 completing the period of active military service times a rate equal to the 8 sum of the contribution rates for both the member and the employer at the 9 time the membership was first reinstated after completion of the active military service. 10

(b)(1) Interest shall be paid at the rate of six percent (6%) per year from December 31, 1987, or six (6) months after the end of the month in which the member first has ten (10) years of creditable service, whichever is later.

15 (2) In no event may payments be extended beyond three (3) years16 from the date of application.

17 (3) It is further required that all payments must be completed
18 before this military service time can be used to compute annuity benefits at
19 time of retirement.

(c)(1) This section shall be supplemental to any other laws relating to the members of the system. Nothing in this section shall be construed to repeal or modify any existing provisions of this system's laws providing for creditable service in the system for military service, nor to diminish the right of any member of this system to obtain creditable service in the system for military service under existing laws.
