17 AN ACT FOR THE CROWLEY'S RIDGE TECHNICAL
18 INSTITUTE - CAPITAL IMPROVEMENT
19 SUPPLEMENTAL APPROPRIATION.

22 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

24 SECTION 1. APPROPRIATION. There is hereby appropriated, to the Crowley's
25 Ridge Technical Institute, to be payable from the General Improvement Fund or
26 its successor fund or fund accounts, for construction, renovation,
27 maintenance, repair, and equipment of the Crowley's Ridge Technical Institute
28 for the fiscal year ending June 30, 2009, which shall be supplemental and in
29 addition to those funds appropriated in Section 1 of Act 1274 of 2007, the
30 sum of\$211,967.

32 SECTION 2. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized
33 by this act shall be limited to the appropriation for such agency and funds
34 made available by law for the support of such appropriations; and the
35 restrictions of the State Procurement Law, the General Accounting and
36 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary



1 Procedures and Restrictions Act, or their successors, and other fiscal
 2 control laws of this State, where applicable, and regulations promulgated by
 3 the Department of Finance and Administration, as authorized by law, shall be
 4 strictly complied with in disbursement of said funds.

5
 6 SECTION 3. LEGISLATIVE INTENT. It is the intent of the General Assembly
 7 that any funds disbursed under the authority of the appropriations contained
 8 in this act shall be in compliance with the stated reasons for which this act
 9 was adopted, as evidenced by the Agency Requests, Executive Recommendations
 10 and Legislative Recommendations contained in the budget manuals prepared by
 11 the Department of Finance and Administration, letters, or summarized oral
 12 testimony in the official minutes of the Arkansas Legislative Council or
 13 Joint Budget Committee which relate to its passage and adoption.

 15 SECTION 4. EMERGENCY CLAUSE. It is found and determined by the General
 16 Assembly, that appropriations provided by the General Assembly for the
 17 Crowley's Ridge Technical Institute are, due to unforeseen circumstances,
 18 insufficient for the Crowley's Ridge Technical Institute to continue to
 19 provide essential governmental services; that the provisions of this act will
 20 provide the necessary appropriation for the Crowley's Ridge Technical
 21 Institute to continue such services; and that a delay in the effective date
 22 of this Act could work irreparable harm upon the proper administration and
 23 provision of essential governmental programs. Therefore, an emergency is
 24 hereby declared to exist and this Act being necessary for the immediate
 25 preservation of the public peace, health and safety shall be in full force
 26 and effect from and after the date of its passage and approval. If the bill
 27 is neither approved nor vetoed by the Governor, it shall become effective on
 28 the expiration of the period of time during which the Governor may veto the
 29 bill. If the bill is vetoed by the Governor and the veto is overridden, it
 30 shall become effective on the date the last house overrides the veto.
