28	enforcement officer if he or she knowingly employs or threatens to employ		
29	physical force against a code enforcement officer engaged in performing his		
30	or her official duties.		
31	(b)(1) Interference with a law enforcement officer or a code		
32	enforcement officer is a Class C felony if:		
33	(A) The per	rson uses or threatens t	to use deadly physical
34	force; or		
35	(B) The per	rson is assisted by one	(1) or more other
36	persons and physical injury to	o the law enforcement of	fficer or code

4	(c)(1) As used in this section, "code enforcement officer" means an

6	ordinance, or municipal regulation as defined by a municipal code, municipal		
7	ordinance, or municipal regulation.		
8	(2) "Code enforcement officer" includes a animal control		
9	officer.
