1 following rules apply to a disclaimer of an interest in property: 2 (1) The disclaimer takes effect as of the time the instrument 3 creating the interest becomes irrevocable, or, if the interest arose under 4 the law of intestate succession, as of the time of the intestate's death. 5 The disclaimed interest passes according to any provision in (2) 6 the instrument creating the interest providing for the disposition of the 7 interest, should it be disclaimed, or of disclaimed interests in general. 8 (3) If the instrument does not contain a provision described in 9 subdivision (b)(2), the following rules apply: 10 (A) If the disclaimant is an individual, the disclaimed 11 interest passes as if the disclaimant had died immediately before the time of 12 distribution. However, if, by law or under the instrument, the descendants of 13 the disclaimant would share in the disclaimed interest by any method of representation had the disclaimant died before the time of distribution, the 14 15 disclaimed interest passes only to the descendants of the disclaimant who 16 survive the time of distribution. 17 (B) If the disclaimant is not an individual, the disclaimed interest passes as if the disclaimant did not exist. 18 19 (A) If the disclaimant is not an individual, the 20 disclaimed interest passes as if the disclaimant did not exist. 21 (B) If the disclaimant is an individual, except as 22 otherwise provided in subparagraphs (C) and (D), the disclaimed interest 23 passes as if the disclaimant had died immediately before the time of 24 distribution. 25 (C) If by law or under the instrument, the descendants of 26 the disclaimant would share in the disclaimed interest by any method of 27 representation had the disclaimant died before the time of distribution, the 28 disclaimed interest passes only to the descendants of the disclaimant who 29 survive the time of distribution. 30 (D) If the disclaimed interest would pass to the 31 disclaimant's estate had the disclaimant died before the time of 32 distribution, the disclaimed interest instead passes by representation to the 33 descendants of the disclaimant who survive the time of distribution. If no 34 descendant of the disclaimant survives the time of distribution, the 35 disclaimed interest passes to those persons, including the state but excluding the disclaimant, and in such shares as would succeed to the 36
