24 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

26 SECTION 1. Arkansas Code § 12-30-205 is amended to read as follows:  
27 12-30-205. Purchase of goods by nonprofit organizations and other  
28 individuals.

29 (a) A nonprofit organization may purchase goods produced by the  
30 Department of Correction's Industry Division as provided for by this  
31 subchapter upon the condition that the goods may not be resold for profit.

32 (b)(1) Goods produced by the division as provided for by this  
33 subchapter may also be purchased by:

34 (A) Current employees and retirees of the Department of  
35 Correction;

36 (B) ~~(i)~~ All employees of the offices, departments,



1 institutions, school districts, and ~~agencies of~~ public agencies in this state  
2 ~~which are supported in whole or in part by this state;~~ and

3 ~~(ii) Subdivision (b)(1)(B)(i) of this section shall~~  
4 ~~not include members of the General Assembly; and~~

5 (C) Current and former members of the Board of  
6 Corrections.

7 (2) Goods purchased by an individual under subdivision (b)(1) of  
8 this section shall be for personal use only and not for resale.
