21 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

23 SECTION 1. Arkansas Code § 6-14-106(b) and (c) concerning voter access
24 to polling sites is amended to read as follows:

25 (b) If a school district has territory in more than one (1) county,
26 the county board of election commissioners of the county in which ~~it~~ the
27 school district is domiciled shall ~~either~~

28 ~~(1) Designate one (1) or more polling sites in each county in~~
29 ~~which any part of the school district lies; or~~

30 ~~(2) Designate one (1) or more polling sites in the county in~~
31 ~~which the school district is domiciled for administrative purposes, at which~~
32 ~~all qualified electors of the school district, regardless of their county of~~
33 ~~residence, may vote~~ designate one (1) or more polling sites in each county
34 containing a city of the second (2nd) class or larger and having registered
35 electors in a contested school election containing more than one county.

36 (c) ~~When the county board of election commissioners of any county in~~



1 ~~which a school district is domiciled for administrative purposes determines~~
2 ~~that a polling site shall not be designated in the other county in which a~~
3 ~~portion of the school district lies, it shall designate and publish in a~~
4 ~~paper of general circulation in that area the location of the polling site in~~
5 ~~the county in which the school district is administered for those electors of~~
6 ~~the school district in the other county to vote.~~ The county board of election
7 commissioners shall take appropriate action to assure that the necessary
8 precinct registration files are delivered to ~~that~~ each polling site in order
9 that the electors in ~~the nonadministering~~ each county may vote in the school
10 election.
