31 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

33 SECTION 1. APPROPRIATION - ARKANSAS STATE UNIVERSITY - JONESBORO. There
34 is hereby appropriated, to the Arkansas State University, to be payable from
35 the General Improvement Fund or its successor fund or fund accounts, the
36 following:



1 (A) For construction/renovation/maintenance/critical maintenance/
2 equipment/library resources, the sum of \$500,000.

3
4 SECTION 2. APPROPRIATION - ARKANSAS TECH UNIVERSITY. There is hereby
5 appropriated, to the Arkansas Tech University, to be payable from the General
6 Improvement Fund or its successor fund or fund accounts, the following:

7 (A) For construction/renovation/maintenance/critical maintenance/
8 equipment/library resources, the sum of \$500,000.

9
10 SECTION 3. APPROPRIATION - HENDERSON STATE UNIVERSITY. There is hereby
11 appropriated, to the Henderson State University, to be payable from the
12 General Improvement Fund or its successor fund or fund accounts, the
13 following:

14 (A) For construction/renovation/maintenance/critical maintenance/
15 equipment/library resources, the sum of \$500,000.

16
17 SECTION 4. APPROPRIATION - SOUTHERN ARKANSAS UNIVERSITY. There is hereby
18 appropriated, to the Southern Arkansas University, to be payable from the

1 SECTION 7. APPROPRIATION - UNIVERSITY OF ARKANSAS - LITTLE ROCK. There is
2 hereby appropriated, to the University of Arkansas at Little Rock, to be
3 payable from the General Improvement Fund or its successor fund or fund
4 accounts, the following:

5 (A) For construction/renovation/maintenance/critical maintenance/
6 equipment/library resources, the sum of \$500,000.

7
8 SECTION 8. APPROPRIATION - UNIVERSITY OF ARKANSAS - MONTICELLO. There is
9 hereby appropriated, to the University of Arkansas at Monticello, to be
10 payable from the General Improvement Fund or its successor fund or fund
11 accounts, the following:

12 (A) For construction/renovation/maintenance/critical maintenance/
13 equipment/library resources, the sum of \$500,000.

14
15 SECTION 9. APPROPRIATION - UNIVERSITY OF ARKANSAS FOR MEDICAL SCIENCES.
16 There is hereby appropriated, to the University of Arkansas for Medical
17 Sciences, to be payable from the General Improvement Fund or its successor
18 fund or fund accounts, the following:

19 (A) For construction/renovation/maintenance/critical maintenance/
20 equipment/library resources, the sum of \$500,000.

21 (B) For grants for construction, renovation, equipment, maintenance,
22 furnishing and finishing the Arkansas Children's Hospital new south wing
23 project \$2,000,000.

25 SECTION 10. APPROPRIATION - UNIVERSITY OF ARKANSAS - PINE BLUFF. There is
26 hereby appropriated, to the University of Arkansas at Pine Bluff, to be
27 payable from the General Improvement Fund or its successor fund or fund
28 accounts, the following:

29 (A) For construction/renovation/maintenance/critical maintenance/
30 equipment/library resources, the sum of \$500,000.

31
32 SECTION 11. APPROPRIATION - UNIVERSITY OF CENTRAL ARKANSAS. There is
33 hereby appropriated, to the University of Central Arkansas, to be payable
34 from the General Improvement Fund or its successor fund or fund accounts, the
35 following:

36 (A) For construction/renovation/maintenance/critical maintenance/

1 equipment/library resources, the sum of \$500,000.

2

3 SECTION 12. APPROPRIATION - ARKANSAS NORTHEASTERN COLLEGE. There is
4 hereby appropriated, to the Arkansas Northeastern College, to be payable from
5 the General Improvement Fund or its successor fund or fund accounts, the
6 following:

7 (A) For construction/renovation/maintenance/critical maintenance/
8 equipment/library resources, the sum of \$500,000.

9

10 SECTION 13. APPROPRIATION - ARKANSAS STATE UNIVERSITY - BEEBE. There is
11 hereby appropriated, to the Arkansas State University - Beebe, to be payable
12 from the General Improvement Fund or its successor fund or fund accounts, the
13 following:

14 (A) For construction/renovation/maintenance/critical maintenance/
15 equipment/library resources, the sum of \$500,000.

16

17 SECTION 14. APPROPRIATION - ARKANSAS STATE UNIVERSITY - MOUNTAIN HOME.
18 There is hereby appropriated, to the Arkansas State University - Mountain
19 Home, to be payable from the General Improvement Fund or its successor fund
20 or fund accounts, the following:

21 (A) For construction/renovation/maintenance/critical maintenance/
22 equipment/library resources, the sum of \$500,000.

23

24 SECTION 15. APPROPRIATION - ARKANSAS STATE UNIVERSITY - NEWPORT. There is
25 hereby appropriated, to the Arkansas State University - Newport, to be
26 payable from the General Improvement Fund or its successor fund or fund
27 accounts, the following:

28 (A) For construction/renovation/maintenance/critical maintenance/
29 equipment/library resources, the sum of \$500,000.

30

31 SECTION 16. APPROPRIATION - BLACK RIVER TECHNICAL COLLEGE. There is
32 hereby appropriated, to the Black River Technical College, to be payable from
33 the General Improvement Fund or its successor fund or fund accounts, the
34 following:

SECTION 17. APPROPRIATION - U OF A - COSSATOT COMMUNITY COLLEGE. There is hereby appropriated, to the Cossatot Community College of the University of Arkansas, to be payable from the General Improvement Fund or its successor fund or fund accounts, the following:

(A) For construction/renovation/maintenance/critical maintenance/equipment/library resources, the sum of \$500,000.

SECTION 18. APPROPRIATION - EAST ARKANSAS COMMUNITY COLLEGE. There is hereby appropriated, to the East Arkansas Community College, to be payable from the General Improvement Fund or its successor fund or fund accounts, the following:

(A) For construction/renovation/maintenance/critical maintenance/equipment/library resources, the sum of \$500,000.

SECTION 19. APPROPRIATION - MID-SOUTH COMMUNITY COLLEGE. There is hereby appropriated, to the Mid-South Community College, to be payable from the General Improvement Fund or its successor fund or fund accounts, the following:

(A) For construction/renovation/maintenance/critical maintenance/equipment/library resources, the sum of \$500,000.

SECTION 20. APPROPRIATION - NATIONAL PARK COMMUNITY COLLEGE. There is hereby appropriated, to the National Park Community College, to be payable from the General Improvement Fund or its successor fund or fund accounts, the following:

(A) For construction/renovation/maintenance/critical maintenance/equipment/library resources, the sum of \$500,000.

SECTION 21. APPROPRIATION - NORTH ARKANSAS COLLEGE. There is hereby appropriated, to the North Arkansas College, to be payable from the General Improvement Fund or its successor fund or fund accounts, the following:

(A) For construction/renovation/maintenance/critical maintenance/equipment/library resources, the sum of \$500,000.

SECTION 22. APPROPRIATION - NORTHWEST ARKANSAS COMMUNITY COLLEGE. There

1 is hereby appropriated, to the Northwest Arkansas Community College, to be
2 payable from the General Improvement Fund or its successor fund or fund
3 accounts, the following:

4 (A) For construction/renovation/maintenance/critical maintenance/
5 equipment/library resources, the sum of \$500,000.

7 SECTION 23. APPROPRIATION - OUACHITA TECHNICAL COLLEGE. There is hereby
8 appropriated, to the Ouachita Technical College, to be payable from the
9 General Improvement Fund or its successor fund or fund accounts, the
10 following:

11 (A) For construction/renovation/maintenance/critical maintenance/
12 equipment/library resources, the sum of \$500,000.

13
14 SECTION 24. APPROPRIATION - OZARKA COLLEGE. There is hereby appropriated,
15 to the Ozarka College, to be payable from the General Improvement Fund or its
16 successor fund or fund accounts, the following:

20 SECTION 25. APPROPRIATION - U OF A - PHILLIPS COMMUNITY COLLEGE. There is
21 hereby appropriated, to the Phillips Community College of the University of
22 Arkansas, to be payable from the General Improvement Fund or its successor
23 fund or fund accounts, the following:

24 (A) For construction/renovation/maintenance/critical maintenance/
25 equipment/library resources, the sum of \$500,000.

27 SECTION 26. APPROPRIATION - PULASKI TECHNICAL COLLEGE. There is hereby
28 appropriated, to the Pulaski Technical College, to be payable from the
29 General Improvement Fund or its successor fund or fund accounts, the
30 following:

31 (A) For construction/renovation/maintenance/critical maintenance/
32 equipment/library resources, the sum of \$500,000.

33
34 SECTION 27. APPROPRIATION - RICH MOUNTAIN COMMUNITY COLLEGE. There is
35 hereby appropriated, to the Rich Mountain Community College, to be payable
36 from the General Improvement Fund or its successor fund or fund accounts, the

1 following:

2 (A) For construction/renovation/maintenance/critical maintenance/
3 equipment/library resources, the sum of \$500,000.

4

5 SECTION 28. APPROPRIATION - SOUTH ARKANSAS COMMUNITY COLLEGE. There is
6 hereby appropriated, to the South Arkansas Community College, to be payable
7 from the General Improvement Fund or its successor fund or fund accounts, the
8 following:

9 (A) For construction/renovation/maintenance/critical maintenance/
10 equipment/library resources, the sum of \$500,000.

11

12 SECTION 29. APPROPRIATION - SOUTHEAST ARKANSAS COLLEGE. There is hereby
13 appropriated, to the Southeast Arkansas College, to be payable from the
14 General Improvement Fund or its successor fund or fund accounts, the
15 following:

16 (A) For construction/renovation/maintenance/critical maintenance/
17 equipment/library resources, the sum of \$500,000.

18

19 SECTION 30. APPROPRIATION - SOUTHERN ARKANSAS UNIVERSITY - TECH. There is
20 hereby appropriated, to the SAU-Tech, to be payable from the General
21 Improvement Fund or its successor fund or fund accounts, the following:

22 (A) For construction/renovation/maintenance/critical maintenance/
23 equipment/library resources, the sum of \$500,000.

24

25 SECTION 31. APPROPRIATION - U OF A - COMMUNITY COLLEGE - BATESVILLE.
26 There is hereby appropriated, to the University of Arkansas Community College
27 at Batesville, to be payable from the General Improvement Fund or its
28 successor fund or fund accounts, the following:

29 (A) For construction/renovation/maintenance/critical maintenance/
30 equipment/library resources, the sum of \$500,000.

31

32 SECTION 32. APPROPRIATION - U OF A - COMMUNITY COLLEGE - HOPE. There is
33 hereby appropriated, to the University of Arkansas Community College at Hope,
34 to be payable from the General Improvement Fund or its successor fund or fund
35 accounts, the following:

36 (A) For construction/renovation/maintenance/critical maintenance/

1 equipment/library resources, the sum of \$500,000.

2
3 SECTION 33. APPROPRIATION - U OF A - COMMUNITY COLLEGE - MORRILTON. There
4 is hereby appropriated, to the University of Arkansas Community College at
5 Morrilton, to be payable from the General Improvement Fund or its successor
6 fund or fund accounts, the following:

7 (A) For construction/renovation/maintenance/critical maintenance/
8 equipment/library resources, the sum of \$500,000.

9
10 SECTION 34. DISBURSEMENT CONTROLS. (A) No contract may be awarded nor
11 obligations otherwise incurred in relation to the project or projects
12 described herein in excess of the State Treasury funds actually available
13 therefor as provided by law. Provided, however, that institutions and
14 agencies listed herein shall have the authority to accept and use grants and
15 donations including Federal funds, and to use its unobligated cash income or
16 funds, or both available to it, for the purpose of supplementing the State
17 Treasury funds for financing the entire costs of the project or projects
18 enumerated herein. Provided further, that the appropriations and funds
19 otherwise provided by the General Assembly for Maintenance and General
20 Operations of the agency or institutions receiving appropriation herein shall
21 not be used for any of the purposes as appropriated in this act.

22 (B) The restrictions of any applicable provisions of the State Purchasing
23 Law, the General Accounting and Budgetary Procedures Law, the Revenue
24 Stabilization Law and any other applicable fiscal control laws of this State
25 and regulations promulgated by the Department of Finance and Administration,
26 as authorized by law, shall be strictly complied with in disbursement of any
27 funds provided by this act unless specifically provided otherwise by law.

28
29 SECTION 35. LEGISLATIVE INTENT. It is the intent of the General Assembly
30 that any funds disbursed under the authority of the appropriations contained
31 in this act shall be in compliance with the stated reasons for which this act
32 was adopted, as evidenced by the Agency Requests, Executive Recommendations
33 and Legislative Recommendations contained in the budget manuals prepared by
34 the Department of Finance and Administration, letters, or summarized oral
35 testimony in the official minutes of the Arkansas Legislative Council or
36 Joint Budget Committee which relate to its passage and adoption.
