 - (2) Malpractice or gross incompetency;
- 14 (3) The use in advertisements of untruthful or improbable 15 statements or flamboyant, exaggerated, or extravagant claims concerning the 16 licensee's professional excellence or abilities;
 - (4) Habitual drunkenness or habitual use of any illegal drugs;
- 18 (5) Serving or having a permit to serve alcoholic beverages at 19 the clinic or school;
- 20 (6) Engaging in moral turpitude or immoral or unprofessional conduct;

22	public. Therefore, an emergency is declared to exist and this act being
23	immediately necessary for the preservation of the public peace, health, and safety
24	shall become effective on:
25	(1) The date of its approval by the Governor;
26	(2) If the bill is neither approved nor vetoed by the Governor, the
27	expiration of the period of time during which the Governor may veto the bill; or
28	(3) If the bill is vetoed by the Governor and the veto is overridden,
29	the date the last house overrides the veto.
