8 AN ACT TO ALLOW THE PERMANENT REGISTRATION OF A
9 FLEET OF MOTOR VEHICLES; AND FOR OTHER PURPOSES.

Subtitle

12 TO ALLOW THE PERMANENT REGISTRATION OF A
13 FLEET OF MOTOR VEHICLES.

16 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

18 *SECTION 1. Arkansas Code Title 27, Chapter 14, Subchapter 6 is amended*
19 *to add an additional section to read as follows:*

20 *27-14-610. Permanent registration of a fleet of motor vehicles.*

21 *(a) As used in this section:*

22 *(1) "Affiliate" means any entity that directly or indirectly*
23 *owns or controls, is owned or controlled by, or is under common ownership or*
24 *control with another entity;*

25 *(2)(A) "Fleet of motor vehicles" means at least fifty (50) motor*
26 *vehicles that are:*

27 *(i) Owned or leased by a person or entity described*
28 *in § 26-26-1601(12)-(16) or affiliates of that person or entity; and*

29 *(ii) Used for business purposes.*

30 *(B) "Fleet of motor vehicles" includes commercial motor*
31 *vehicles that are base-plated in the State of Arkansas or passenger motor*
32 *vehicles otherwise subject to registration under this chapter.*

33 *(C) "Fleet of motor vehicles" does not include motor*
34 *vehicles registered and governed under § 27-14-502 or motor vehicles*
35 *registered under an international registration plan administered by a state*
36 *other than Arkansas; and*



1 (3) "Owns or controls" means owning or holding at least a
2 majority of the outstanding voting power of an entity.

3 (b) Notwithstanding any other provision of this chapter, the
4 registered owner or lessee of a fleet of motor vehicles may apply as provided
5 in this section to the Office of Motor Vehicle of the Revenue Division of the
6 Department of Finance and Administration for a license plate with a decal
7 identifying the vehicle as a fleet vehicle.

8 (c) The license plate issued under this section shall be the standard
9 license plate for the class and type of vehicle otherwise required under this
10 chapter, with a decal bearing the word 'fleet' at the bottom of the license
11 plate.

12 (d)(1) Payment of all registration fees and fleet
13 management fees under this section shall be paid in advance for a period of
14 three (3) years.

15 (2)(A) The fees for renewal of a vehicle registration under this
16 section shall be due and payable during the last month of the last year of
17 the registration period.

18 (B) Upon request, the Office of Motor Vehicle shall allow
19 the owner of a fleet of motor vehicles to set all renewals for the fleet to
20 occur in a month requested by the owner.

21 (3)(A) The Office of Motor Vehicle may shorten or lengthen the
22 term of any renewal period under this section by rule and upon notice to all
23 owners of a fleet registered under this section as necessary to provide for a
24 staggered system of renewal in which approximately one-third (1/3) of the
25 vehicles in a fleet shall be renewed in any given year.

26 (e)(1) The fees for registration and renewal of registration of a
27 vehicle under this section shall be the same amount as and shall be
28 distributed in the same manner as the fees otherwise required under this
29 chapter for the type and class of vehicle being registered.

30 (2)(A) In addition to the registration fees prescribed for
31 issuance or renewal under this chapter, an annual fleet management fee of ten
32 dollars (\$10.00) per motor vehicle in the fleet of motor vehicles shall be
33 charged.

34 (B) The annual fleet management fee shall be deposited as
35 special revenues into the State Central Services Fund to be used exclusively
36 for the benefit of the Revenue Division of the Department of Finance and

1 Administration.

2 (f)(1) Upon payment of the registration fees and fleet management fees
3 as provided under subsection (e) of this section, the owner or lessee of the
4 fleet of motor vehicles shall be issued a license plate with a decal for each
5 motor vehicle in the fleet of motor vehicles registered under this section.

6 (2) Each license plate with a decal issued under this section
7 shall bear a validation sticker as required for standard license plates
8 issued under this chapter reflecting the period that the owner or lessee of
9 the fleet of motor vehicles has paid in advance.

10 (g) A license plate with a decal issued under this section may be
11 transferred to another vehicle of the same type and class in the same fleet
12 of motor vehicles in the same manner and subject to the same fees prescribed
13 in §§ 27-14-902 and 27-14-914.

14 (h) A license plate with a decal issued under this section that has
15 been lost or destroyed may be replaced in the same manner and subject to the
16 same fees prescribed in § 27-14-602.

17 (i) The Office of Motor Vehicle may adopt rules for the
18 implementation, administration, and enforcement of this section.
