17 WHEREAS, Sergeant Monty Carmikle of Heber Springs, Arkansas, died on
18 November 16, 2008, at the age of forty-five (45) years; and

20 WHEREAS, Sergeant Carmikle's death occurred in the official line of
21 duty as a wildlife officer for the Arkansas State Game and Fish Commission;

24 WHEREAS, Sergeant Carmikle served as a wildlife officer for twenty-
25 three (23) years and was named the 1991 Wildlife Officer of the Year for the
26 Southeast Region; and

28 WHEREAS, Sergeant Carmikle created a search and rescue dive team for
29 the Arkansas State Game and Fish Commission and taught at the Wildlife
30 Officer Academy; and

32 WHEREAS, Sergeant Carmikle instilled in his cadets the same work ethic
33 he placed upon himself and served with honor and dedication; and

35 WHEREAS, Sergeant Carmikle attended Forrest City public schools and
36 later East Arkansas Community College; and

2 WHEREAS, Sergeant Carmikle was a member of the Heber Springs Baptist
3 Church and served as a leader in his community; and

5 WHEREAS, Sergeant Carmikle is survived by his wife, Mary Elizabeth
6 Giles Carmikle, and his son, Caleb Hunter Carmikle; and

8 WHEREAS, Sergeant Carmikle was a dedicated and loving husband and
9 father who was actively involved in Caleb's life and love of sports; and

11 WHEREAS, the House of Representatives of the Eighty-Seventh General
12 Assembly wishes to publicly remember Sergeant Darrell Monty Carmikle,
