23	WHEREAS, Thomas 09-17 $\#1$ -09 became the first producing well in the
24	Fayetteville Shale Play on September 23, 2004; and
25	
26	WHEREAS, the well is located at Section 9, Range 9, North Township 17,
27	in West Conway County; and
28	
29	WHEREAS, the well has a total depth of three thousand six hundred ten
30	feet (3610') and a producing depth of two thousand seven hundred fifty feet
31	(2750') to three thousand thirty-six feet (3036'); and
32	
33	WHEREAS, Southwestern Energy Company recognized early the importance of
34	the shale wells on the State of Arkansas; and
35	
36	WHEREAS, the production of shale from this well began one of the



1	largest economic development in Arkansas history; and
2	
3	WHEREAS, the economic impact on Arkansas has included the creation of a
4	significant number of jobs, increased sales tax revenues for cities and
5	counties, increased state sales tax collections, and increased property
6	values,

8	NOW THEREFORE,
