For An Act To Be Entitled

9 AN ACT TO ADJUST THE AMOUNT OF TIME FROM THIRTY
10 (30) DAYS TO ONE HUNDRED EIGHTY (180) DAYS THAT A
11 RETIRED MEMBER OF THE ARKANSAS TEACHER RETIREMENT
12 SYSTEM SHALL REMAIN RETIRED BEFORE *RETURNING TO*
13 *WORK WITH A COVERED EMPLOYER OF THE ARKANSAS*
14 *TEACHER RETIREMENT SYSTEM*; TO CLARIFY VARIOUS
15 SECTIONS OF ARKANSAS CODE TITLE 24, CHAPTER 7
16 PERTAINING TO THE TERMINATION OF COVERED
17 EMPLOYMENT REQUIREMENTS; AND FOR OTHER PURPOSES.

Subtitle

19 TO ADJUST THE AMOUNT OF TIME A RETIRED
20 MEMBER OF THE ARKANSAS TEACHER
21 RETIREMENT SYSTEM SHALL REMAIN RETIRED
22 BEFORE *RETURNING TO COVERED EMPLOYMENT*.

26 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
27

28 SECTION 1. Arkansas Code § 24-7-502(a), concerning the amount of time
29 a member of the Arkansas Teacher Retirement System is required to be
30 terminated from employment before becoming eligible for retirement benefits,
31 is amended to read as follows:

32 (a)(1) A member of the Arkansas Teacher Retirement System ~~must~~ shall
33 terminate covered employment to be eligible for retirement.

34 (2) Except for a member who accumulates eight (8) or more years
35 of participation in the Teacher Deferred Retirement Option Plan before July
36 1, 2009, effective July 2, 2009, A a member shall not be terminated from



1 employment for ~~retirement~~ purposes of retirement eligibility if within ~~thirty~~
 2 ~~(30)~~ one hundred eighty (180) days of the ~~person's~~ member's effective date of
 3 retirement the ~~person~~ member ~~returns to a position that would otherwise be~~
 4 ~~covered by the system;~~

5 (A) Becomes employed with an employer covered by the
 6 system; and

7 (B) Has not attained the system's normal retirement age.

8 (3) A ~~person failing~~ member who fails to meet the termination
 9 requirement of this subsection shall forfeit ~~the person's~~ all retirement
 10 benefits until the termination requirement is met.

11 (4)(A) A member shall repay to the system any retirement
 12 benefits that are paid to the member by the system during the waiting period
 13 of one hundred eighty (180) in subdivision (a)(2) of this section.

14 (B) The system may require the repayment of retirement
 15 benefits from the member indirectly under the system's standard withholding
 16 rule.

17 (5) For a member who fails to meet the termination requirement
 18 in subdivisions (a)(1) and (2) of this section, the member shall immediately
 19 become an active member of the system upon reemployment by a covered
 20 employer.

21
 22 SECTION 2. Arkansas Code § 24-7-701(a), concerning voluntary
 23 retirement, is amended to read as follows:

24 (a)(1) Except as provided under subdivision (a)(2) of this section, an
 25 active member who either attains ~~age~~ sixty (60) years of age and has five (5)
 26 or more years of actual and reciprocal service or who has twenty-eight (28)
 27 or more years of credited service regardless of age may voluntarily retire
 28 upon written application filed with the Board of Trustees of the Arkansas
 29 Teacher Retirement System.

30 (2)(A) A member shall ~~terminate covered employment~~ meet the
 31 termination of covered employment requirements under § 24-7-502 to be
 32 eligible for retirement except if the member has attained normal retirement
 33 age.

34 (B) A member ~~shall not be terminated from employment for~~
 35 ~~retirement purposes if the person returns to a position that would otherwise~~
 36 ~~be covered by the Arkansas Teacher Retirement System within thirty (30) days~~

1 ~~of the person's effective date of retirement.~~

2 ~~(C)~~ A person failing to meet the termination of employment
3 requirements of this subsection shall forfeit retirement benefits until the
4 requirements are met.

5
6 SECTION 3. Arkansas Code § 24-7-702(a), concerning early voluntary
7 retirement, is amended to read as follows:

8 (a)(1) Except as provided under subdivision (a)(2) of this section, an
9 active or inactive member who has twenty-five (25) or more years of credited
10 service but has not attained ~~age~~ sixty (60) years of age and is not eligible
11 for retirement under ~~the provisions of~~ § 24-7-701 may voluntarily retire
12 early upon written application filed with the Board of Trustees of the
13 Arkansas Teacher Retirement System.

14 (2)(A) A member shall ~~terminate~~ meet the termination of covered
15 employment requirements under § 24-7-502 to be eligible for retirement except
16 if the member has attained normal retirement age.

17 (B) ~~A member shall not be terminated from employment for~~
18 ~~retirement purposes if the person returns to a position that would otherwise~~
19 ~~be covered by the Arkansas Teacher Retirement System within thirty (30) days~~
20 ~~of the person's effective date of retirement.~~

21 ~~(C)~~ ~~A person failing~~ A member who fails to meet the
22 termination of covered employment requirements ~~of this~~ under subsection (a)
23 of this section shall forfeit retirement benefits until the requirements are
24 met.

25
26 SECTION 4. Arkansas Code § 24-7-704(a)(1)(B), concerning a disability
27 retirement, is amended to read as follows:

28 (B)~~(i)~~ An active member who has met the eligibility
29 requirement of subdivision (a)(1)(A) of this section shall ~~terminate~~ meet the
30 termination of covered employment requirements under § 24-7-502 to be
31 eligible for disability retirement benefits.

32 ~~(ii)~~ ~~If a member returns to work in a position~~
33 ~~covered by the Arkansas Teacher Retirement System within thirty (30) days of~~
34 ~~the person's effective date of disability retirement, then the member shall~~
35 ~~not be considered terminated from employment for retirement purposes and~~
36 ~~shall forfeit disability retirement benefits until the termination~~

1 ~~requirements are met.~~

2
3 SECTION 5. Arkansas Code § 24-7-704(c)(5), concerning a disability
4 retirant returning to full-time service, is amended to read as follows:

5 (5)(A) If a disability retirant returns to full-time service as
6 defined by rules determined by the board prior to attaining sixty (60) years
7 of age, his or her disability retirement shall terminate.

8 (B) If a disability retirant returns to full-time service
9 as defined by rules promulgated by the board after attaining sixty (60) years
10 of age, the retirant shall be treated as if he or she retired under § 24-7-
11 701 ~~and is subject to the limitations applicable to age and service~~
12 ~~retirants.~~

13
14 SECTION 6. Arkansas Code § 24-7-708 is amended to read as follows:

15 24-7-708. ~~Conditions subjecting annuities to limitations~~ Employment of
16 retired members by covered employers.

17 (a) ~~Except as provided in subsections (f) and (g) of this section, if~~
18 ~~a retirant is an employee of a public employer whose employees are covered by~~
19 ~~the Arkansas Teacher Retirement System, then, for each twelve month period~~
20 ~~ending June 30, the amount of his or her system annuity shall be subject to~~
21 ~~the limitations equivalent to twice the limitations imposed by the social~~
22 ~~security retirement test~~ Effective July 1, 2009, after terminating employment
23 under § 24-7-502 or reaching the age of normal retirement, a retirant may:

24 (1) Accept employment with an employer covered by the system
25 without a limitation of his or her retirement annuity; and

26 (2) Continue to receive his or her monthly retirement annuity.

27 (b) ~~For each year ending June 30, the social security retirement test~~
28 ~~to be considered shall be the test in effect for the calendar year beginning~~
29 ~~the January 1 immediately preceding June 30. The retirant's earnings shall be~~
30 ~~his or her remuneration for the employment for the year ending June 30~~

31 Employers covered by the system that hire an employee who meets the
32 conditions under subsection (a) of this section shall report the hiring of
33 the retirant to the system in a time and a manner that the system may
34 reasonably require.

35 (c) ~~The Board of Trustees of the Arkansas Teacher Retirement System~~
36 ~~shall establish equivalent limitations by appropriate rules and regulations.~~

1 ~~(d) Receiving remuneration as an employee from any private employer or~~
2 ~~as a member of the General Assembly shall not affect payment of an annuity.~~

3 ~~(e) During any period of employment in a position covered by the~~
4 ~~system, a A retirant that receives monthly benefits and is employed by a~~
5 ~~covered employer shall not accrue additional-credited service credit.~~

6 ~~(f)(1) In accordance with rules and regulations adopted by the State~~
7 ~~Board of Education, the Department of Education may request of the board of~~
8 ~~trustees or its designee a waiver of the conditions subjecting annuities to~~
9 ~~limitations. If approved by the board of trustees or its designee, the waiver~~
10 ~~shall be effective for a one year period, with the option to renew annually~~
11 ~~for up to a total of six (6) years as requested by the department.~~

12 ~~(2) A waiver of the conditions subjecting annuities to~~
13 ~~limitations may be requested if the retirant is hired by a public school~~
14 ~~district due to a shortage of certified teachers in a critical academic area~~
15 ~~in which the retirant is certified.~~

16 ~~(3) The critical academic areas in which there is a shortage of~~
17 ~~certified teachers shall be determined annually by the State Board of~~
18 ~~Education.~~

19 ~~(4) School districts shall maintain audit files identifying~~
20 ~~personnel granted a waiver and documenting the reasons for the waiver.~~

21 ~~(5) Beginning July 1, 2005, for any retired member employed in a~~
22 ~~position covered by the system pursuant to a waiver, an amount equal to the~~
23 ~~combined employer and employee contribution rate or rates to the system on~~
24 ~~behalf of the member shall recommence at the rate in effect at the time of~~
25 ~~the employment and shall be remitted by the employer.~~

26 ~~(d)(1) For a retired member employed in a position covered by the~~
27 ~~system, the covered employer shall remit the contributions on all salary paid~~
28 ~~to the retirant in an amount equal to the employer contribution *rate*~~
29 ~~*applicable to active members.*~~

30 ~~(2) Contributions shall be paid by the employer and are not the~~
31 ~~responsibility of the retirant.~~

32 ~~(e)(1) The Board of Trustees of the Arkansas Teacher Retirement System~~
33 ~~shall adopt rules to carry out the provisions of this section.~~

34 ~~(2) A covered employer that employs retirants is subject to the~~
35 ~~rules adopted by the board.~~

36 ~~(g) (1) A retired member entering into a position of employment with the~~

1 Department of Education is exempt from this section and shall be employed
2 with no limitations placed on his or her earnings.

3 ~~(2) For any retired member returning to work under subdivision~~
4 ~~(g)(1) of this section, the employer and employee contribution rate to the~~
5 ~~system on behalf of the member shall recommence at the rate in effect at the~~
6 ~~time of the employment and shall be remitted by the employer.~~

7
8 SECTION 7. Arkansas Code § 24-7-1303(a)(3)(A), concerning the
9 contributions to the Teacher Deferred Retirement Option Plan, is amended to
10 read as follows:

11 (a)(3)(A)(i) Beginning September 1, 2003, for members
12 whose effective date in the Teacher Deferred Retirement Option Plan is before
13 September 1, 2003, the employer contribution rate to the system on behalf of
14 all members in the Teacher Deferred Retirement Option Plan shall recommence
15 at the rate of:

16 ~~(i)(a)~~ One percent (1%) for the period from July 1,
17 2003, through June 30, 2005;

18 ~~(ii)(b)~~ Three percent (3%) for the period from July
19 1, 2005, through June 30, 2007;

20 ~~(iii)(c)~~ Six percent (6%) for the period from July
21 1, 2007, through June 30, 2009+.

22 ~~(iv)(ii)~~ Nine percent (9%) for the period from July
23 1, 2009, through June 30, 2011;

24 - - ~~(v)~~ Twelve percent (12%) for the period from July 1,
25 2011, through June 30, 2013; and

26 - - ~~(vi)~~ After July 1, 2013, the percentage rate
27 established by the entity having the authority to set the employer
28 contribution rate for the system pursuant to § 24-7-401. After July 1, 2009,
29 the covered employer shall remit the contributions on all salary paid to the
30 T-DROP participants in amount equal to the employer contribution rate
31 applicable to active members.

32
33 SECTION 8. EMERGENCY CLAUSE. It is found and determined by the
34 General Assembly of the State of Arkansas that certain provisions of the
35 Arkansas Teacher Retirement System Act are badly in need of revision and
36 updating to bring them into conformance with sound public pension policy;

1 that such revision and updating is of great importance to members of the
2 Arkansas Teacher Retirement System and to other citizens of the State of
3 Arkansas; and that this act is immediately necessary in order to maintain an
4 orderly system of benefits for the members of the Arkansas Teacher Retirement
5 System. Therefore, an emergency is declared to exist and this act being
6 necessary for the preservation of the public peace, health, and safety shall
7 become effective on July 1,2009.
