23 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

25 SECTION 1. Arkansas Code § 24-11-209(e)(3), concerning the Arkansas
26 Fire and Police Pension Guarantee Fund, is amended to read as follows:

27 (3) The Arkansas Fire and Police Pension Review Board shall
28 recommend financial assistance from the Arkansas Fire and Police Pension
29 Guarantee Fund according to the following priorities:

30 (A) Projected insolvent funds which are not expected to
31 have enough funds to provide benefits for the current year;

32 (B) Projected insolvent funds which are expected to
33 deplete their funds within the next three (3) years;

34 (C) Projected insolvent funds which are expected to
35 deplete their funds within the next ten (10) years;

36 (D) Funds that are determined to be actuarially unsound by



1 the Arkansas Fire and Police Pension Review Board; and

2 (E) Other pension funds covering municipal police officers
3 and fire fighters in Arkansas, without regard to:

4 (i) ~~subsection~~ Subsection (d) of this section, ~~or~~
5 ~~without regard to subdivision;~~

6 (ii) Subdivision (b)(2)(B)(iii) of this section for
7 funds administered by the Arkansas Local Police and Fire Retirement System;
8 or

9 (iii) Subdivision (b)(2)(B)(iv) of this section for
10 funds administered by the Arkansas Local Police and Fire Retirement System,
11 if the increase is an annual cost-of-living increase of three percent (3%) or
12 less.
