SECTION 2. EXTRA HELP - OPERATIONS. There is hereby authorized, for the Arkansas State Game and Fish Commission for the 2009-2010 fiscal year, the following maximum number of part-time or temporary employees, to be known as "Extra Help", payable from funds appropriated herein for such purposes: one hundred seventy (170) temporary or part-time employees, when needed, at rates of pay not to exceed those provided in the Uniform Classification and Compensation Act, or its successor, or this act for the appropriate classification.

SECTION 3. APPROPRIATION - OPERATIONS. There is hereby appropriated, to the Arkansas State Game and Fish Commission, to be payable from the Game Protection Fund, for personal services, operating expenses, acquisition, maintenance and improvements of the Arkansas State Game and Fish Commission - Operations for the fiscal year ending June 30, 2010, the following:

13	CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. PAYMENT					
14	OF REWARDS. Payment of rewards shall be from the Game Protection Fund from					
15	the Commission's Maintenance and General Operation appropriation as herein					
16	appropriated in Section 3, Item No. (05)(A).

20	SECTION 5. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS					
21	CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. EXTRA					
22	HELP RESTRICTION. No employee of the Arkansas Game and Fish Commission who is					
23	employed as extra help may receive an amount to exceed eighty-five percent					
24	(85%) of the maximum annual salary for a comparable position as authorized					
25	under § 21-5-201 et seq. during any fiscal year, nor shall such an employee					
26	be employed for a period of time to exceed one thousand eight hundred (1,800)					
27	hours in any single fiscal year.

29	SECTION 6. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS					
30	CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.					
31	PROFESSIONAL CERTIFICATION. The Arkansas Game and Fish Commission					
32	is hereby authorized, after prior review by the Arkansas Legislative Council,					
33	to grant a two percent (2%) increase to any Education Program Specialist,					
34	Education Program Coordinator or AGFC Nature Center Manager upon completion					
35	of the next higher certification level (Certified Interpretive Planner,					

Certified Interpretive Manager, Certified Heritage Interpreter) from the

- National Association of Interpretation. This pay increase will be awarded
- 2 <u>beginning</u> with the first bi-weekly pay period following submission of
- 3 <u>documented proof of such certification to the Commission Human Resources</u>
- 4 Office, provided the employee's most recent performance evaluation results in
- 5 a satisfactory rating. Employees not obtaining a satisfactory performance
- 6 evaluation rating will be granted the pay increase on their next eligibility
- 7 date, provided their new evaluation is satisfactory. New employees and
- 8 probationary employees shall be eligible for this pay increase after their
- 9 probationary period expires, provided the above requirements are met.
- 10 Employees being compensated at the maximum of their assigned grade shall be
- 11 eligible for the two percent (2%) increase in a lump sum payment, and such
- 12 payment shall not be construed as exceeding the maximum salary for the grade.
- 13 The provisions of this section shall be in effect only from July 1, 14 2009 through June 30, 2010.

SECTION 7. LEGISLATIVE INTENT. It is the intent of the General Assembly
that any funds disbursed under the authority of the appropriations contained
in this act shall be in compliance with the stated reasons for which this act
was adopted, as evidenced by the Agency Requests, Executive Recommendations
and Legislative Recommendations contained in the budget manuals prepared by
the Department of Finance and Administration, letters, or summarized oral
testimony in the official minutes of the Arkansas Legislative Council or

Joint Budget Committee which relate to its passage and adoption.

Assembly, that the Constitution of the State of Arkansas prohibits the appropriation of funds for more than a one (1) year period; that the effectiveness of this Act on July 1, 2009 is essential to the operation of the agency for which the appropriations in this Act are provided, and that in the event of an extension of the Regular Session, the delay in the effective date of this Act beyond July 1, 2009 could work irreparable harm upon the proper administration and provision of essential governmental programs.

Therefore, an emergency is hereby declared to exist and this Act being necessary for the immediate preservation of the public peace, health and
