HELP RESTRICTION. No employee of the Arkansas Game and Fish Commission who is employed as extra help may receive an amount to exceed eighty-five percent (85%) of the maximum annual salary for a comparable position as authorized under § 21-5-201 et seq. during any fiscal year, nor shall such an employee be employed for a period of time to exceed one thousand eight hundred (1,800) hours in any single fiscal year.

SECTION 7. LEGISLATIVE INTENT. It is the intent of the General 8 9 Assembly that any funds disbursed under the authority of the appropriations 10 contained in this act shall be in compliance with the stated reasons for 11 which this act was adopted, as evidenced by the Agency Requests, Executive 12 Recommendations and Legislative Recommendations contained in the budget 13 manuals prepared by the Department of Finance and Administration, letters, or 14 summarized oral testimony in the official minutes of the Arkansas Legislative 15 Council or Joint Budget Committee which relate to its passage and adoption. 16

17 SECTION 8. EMERGENCY CLAUSE. It is found and determined by the General Assembly, that the Constitution of the State of Arkansas prohibits the 18 appropriation of funds for more than a one (1) year period; that the 19 20 effectiveness of this Act on July 1, 2009 is essential to the operation of 21 the agency for which the appropriations in this Act are provided, and that in 22 the event of an extension of the Regular Session, the delay in the effective 23 date of this Act beyond July 1, 2009 could work irreparable harm upon the proper administration and provision of essential governmental programs. 24 Therefore, an emergency is hereby declared to exist and this Act being 25 26 necessary for the immediate preservation of the public peace, health and safety shall be in full force and effect from and after July 1, 2009. 27 28 29 */s/ Joint Budget Committee* 30 31 32 33 34
