The Commissioner shall 16 provide a quarterly report of the justification for the need to allocate titles from this growth pool to the Chief Fiscal Officer of the State and to 17 18 the Arkansas Legislative Council for review. The report shall also include 19 an accounting of the names, titles, and salaries of personnel whose salaries 20 have been adjusted under provisions of Subsections (a) and (b) of this 21 Section.

(e) If the Department of Education requests continuation of any "Position
Pool" position(s) as established herein during the next-biennium fiscal year,
the position(s) must be requested as a new position(s) in the agency's
biennial-budget request.

26 (f) Determining the number of personnel to be employed by a state agency is 27 the prerogative of the General Assembly and is usually accomplished by 28 delineating the maximum number of personnel by identifying job titles and the 29 maximum grade or salary attached to those titles. The General Assembly has 30 determined that the Arkansas Department of Education could be operated more 31 efficiently if some flexibility is given to that agency. That flexibility is 32 being accomplished by providing a position pool in Subsections (a) and (b) of 33 this Section and since the General Assembly has granted the agency broad 34 powers under the growth pool concept, it is both necessary and appropriate 35 that the General Assembly maintain oversight of the utilization of the 36 position pool by requiring review of the Legislative Council in the

Upon determination by 11 the Department of Education that a reduction in the amount of available 12 appropriation within the Department of Education Fund Account is required from the amount appropriated, the reduction in the available appropriation 13 14 from the full amount appropriated for the Arkansas Leadership Academy shall 15 be limited to the average percentage reduction in the other appropriations to 16 the Department of Education from the Department of Education Fund Account. 17 The provisions of this section shall be in effect only from July 1, 2007 18 2009 through June 30, 2009 2010.

26 SECTION 31. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized 27 by this act shall be limited to the appropriation for such agency and funds 28 made available by law for the support of such appropriations; and the 29 restrictions of the State Procurement Law, the General Accounting and 30 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary Procedures and Restrictions Act, or their successors, and other fiscal 31 32 control laws of this State, where applicable, and regulations promulgated by 33 the Department of Finance and Administration, as authorized by law, shall be 34 strictly complied with in disbursement of said funds.

36 SECTION 32. LEGISLATIVE INTENT. It is the intent of the General Assembly

that any funds disbursed under the authority of the appropriations contained in this act shall be in compliance with the stated reasons for which this act was adopted, as evidenced by the Agency Requests, Executive Recommendations and Legislative Recommendations contained in the budget manuals prepared by the Department of Finance and Administration, letters, or summarized oral testimony in the official minutes of the Arkansas Legislative Council or Joint Budget Committee which relate to its passage and adoption. SECTION 33. EMERGENCY CLAUSE. It is found and determined by the General Assembly, that the Constitution of the State of Arkansas prohibits the appropriation of funds for more than a one (1) year period; that the effectiveness of this Act on July 1, 2009 is essential to the operation of the agency for which the appropriations in this Act are provided, and that in the event of an extension of the Regular Session, the delay in the effective date of this Act beyond July 1, 2009 could work irreparable harm upon the proper administration and provision of essential governmental programs. Therefore, an emergency is hereby declared to exist and this Act being necessary for the immediate preservation of the public peace, health and safety shall be in full force and effect from and after July 1, 2009.
