- 32 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. EXPLOR-
- 33 NET CENTER FOR QUALITY TEACHING AND LEARNING FUNDING PROVISION. Of the total
- 34 appropriation authorized by this Act for Technology Grants the Department of
- 35 Education shall make available one hundred eighty seven thousand five hundred
- 36 seventy five dollars (\$187,575) each fiscal year for Explor Net Program

- 1 Center for Quality Teaching and Learning initiatives to teach students
- 2 computer repair in a hands-on environment. The Department of Education shall

The Department may contract with the Division of Child Care and Early Childhood Education to administer the program.

Determining the maximum number of employees and the maximum amount of appropriation and general revenue funding for a state agency each fiscal year is the prerogative of the General Assembly. This is usually accomplished by

- l delineating such maximums in the appropriation act(s) for a state agency and
- 2 the general revenue allocations authorized for each fund and fund account by
- 3 amendment to the Revenue Stabilization law. Therefore, it is both necessary
- 4 and appropriate that the General Assembly maintain oversight by requiring
- 5 prior approval of the Legislative Council or Joint Budget Committee as
- 6 provided by this section. The requirement of approval by the Legislative
- 7 Council or Joint Budget Committee is not a severable part of this section.

- 24 with that organization's deadlines for submission for their report "Rankings
- 25 <u>and Estimates" which includes state-by-state teacher salary comparisons</u>.

- 32 designated and retained for the Arkansas Better Chance for School Success
- 33 Program.
- 34 Any carry forward of unexpended balance of appropriation and/or funding as

The 25 appropriation contained herein for Public School Employee Insurance each 26 fiscal year shall be used to provide the state contribution for insurance 27 premiums for employees of the Cooperative Education Services Areas, 28 Vocational Centers, and the school operated by the Department of Correction 29 who participate in the Arkansas Public School Life and Health Insurance 30 Program. 31 In addition, the Department of Education shall pay the Employee Benefits 32 Division of the Department of Finance and Administration a minimum of sixty-33 one dollars (\$61) per month for each eligible employee electing to 34 participate in the public school employee health insurance program. 35 The provisions of this section shall be in effect only from July 1, 2007
