AN ACT TO CREATE THE COSMETOLOGY TECHNICAL
ADVISORY COMMITTEE; AND FOR OTHER PURPOSES.

Subtitle

AN ACT TO CREATE THE COSMETOLOGY
TECHNICAL ADVISORY COMMITTEE.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

SECTION 1. Legislative intent.

(a) The General Assembly declares that this act is necessary to:

(1) Improve the health of the citizens of Arkansas in an
effective and efficient manner; and

(2) Provide for effective administration of the delivery of
cosmetology-related programs.

(b) It is the intent of the General Assembly to provide for an orderly
transfer of powers, authorities, duties, and functions of the State Board of
Cosmetology to the State Board of Health and the Department of Health with a
minimum disruption of government services and functions and with a minimum
expense.

SECTION 2. TEMPORARY LANGUAGE. DO NOT CODIFY.

(a)(1) Effective July 1, 2009, the State Board of Cosmetology is
abolished and transferred to the State Board of Health and the Department of
Health by a type 3 transfer pursuant to § 25-2-106.

(2) As used in this act, the Department of Health shall be



1 considered a principal department established by Acts 1971, No. 38, § 11.

2 (b)(1) All authority, powers, duties, and functions as established by
 3 law for the State Board of Cosmetology, including all purchasing, budgeting,
 4 fiscal, accounting, human resources, payroll, legal, information systems,
 5 maintenance, program support, administrative support, and other management
 6 functions are transferred to the State Board of Health and the Department of
 7 Health, except as specified in this act.

8 (2) All records, personnel, property, unexpended balances of
 9 appropriations, allocations, or other funds are transferred to the Department
 10 of Health. All funds shall be deposited into the Public Health Fund.

11 (3) All powers, duties, and functions, including without
 12 limitation rulemaking, regulation, and licensing, promulgation of rules,
 13 rates, regulations, and standards, and the rendering of findings, orders, and
 14 adjudications as established by law for the State Board of Cosmetology are
 15 transferred to the State Board of Health, except as specified in this act.

16 (c) The Arkansas Code Revision Commission shall replace "State Board
 17 of Cosmetology" in the Arkansas Code with "State Board of Health", except as
 18 specified in this act.

19
 20 SECTION 3. Arkansas Code Title 17, Chapter 26, Subchapter 2 is amended
 21 to read as follows:

22 17-26-201. Creation – Members.

23 (a) There is created the ~~State Board of Cosmetology~~ Cosmetology
 24 Technical Advisory Committee.

25 (b)(1) The ~~board~~ committee shall consist of ~~ten (10)~~ five (5) members
 26 appointed by the ~~Governor~~ State Board of Health to ~~five-year~~ two-year terms.

27 (2) ~~Terms shall be staggered annually on January 15 and shall be~~
 28 ~~determined by lot.~~ A member may be removed from the committee by the board
 29 for cause.

30 ~~(3) A member may serve two (2) nonconsecutive terms.~~

31 ~~(4)(3) No~~ A member shall not serve more than ten (10) years on
 32 the ~~board~~ committee.

33 (c) The ~~board~~ committee shall be composed of the following
 34 representatives from within the cosmetology industry who are of good moral
 35 character and who are at least twenty-five (25) years of age:

36 (1) ~~Four (4) members~~ One (1) member shall be a licensed

~~cosmetologists~~ cosmetologist actively engaged in practicing the art of cosmetology for at least five (5) years at the time of appointment;

(2) One (1) member shall be a licensed nail technician;

(3) ~~Two (2) members~~ One (1) member shall be ~~owners~~ an owner of a licensed school of cosmetology or shall be a director of cosmetology at a state-supported school; and

~~(4) One (1) member shall be a director of cosmetology at a state-supported school who is also a licensed instructor; and~~

~~(5)~~ (4) One (1) member shall be a licensed aesthetician.

(d) One (1) member of the ~~board~~ committee shall be a consumer representative ~~who is at least sixty (60) years of age and~~ who is not actively engaged in or retired from the cosmetology industry.

(e) ~~(1) No~~ A member of the ~~board~~ committee shall not be directly or indirectly connected with the wholesale business of the manufacture, rental, sale, or distribution of cosmetological appliances or supplies.

(2) No member of the ~~board~~ committee shall have a contract or a pending bid for a contract with the ~~board~~ Department of Health concerning cosmetology.

(f) ~~Not more than Only three (3)~~ two (2) members of the ~~board~~ committee may be appointed from any one (1) congressional district. ~~The consumer representative may be appointed from the state at large.~~

(g) Vacancies occurring during a term shall be filled for the unexpired term.

(h) Before entering upon the discharge of his or her duties, each member shall make and file with the Secretary of State the oath of office prescribed by Arkansas Constitution, Article 19, § 20.

(i) Each member of the ~~board~~ committee may receive expense reimbursement and stipends in accordance with § 25-16-901 et seq. ~~All compensation and necessary traveling expenses shall be paid by the board out of the Cosmetology Operating Fund only.~~

(j) The State Board of Health shall promulgate by rule the duties and powers of the committee.

~~17-26-202. Officers.~~

~~(a) The members of the State Board of Cosmetology shall annually elect from among their number, a president, first vice president, second vice~~

1 ~~president, secretary, and treasurer.~~

2 ~~(b) The board shall by regulation prescribe the duties of these~~
 3 ~~officers.~~

 5 ~~17-26-203. Director.~~

6 ~~(a) The State Board of Cosmetology shall appoint a Director of~~
 7 ~~Cosmetology with secretarial qualifications, who shall not be a member of the~~
 8 ~~board and who shall have had at least five (5) years' experience in~~
 9 ~~secretarial and administrative employment in this state immediately prior to~~
 10 ~~appointment.~~

11 ~~(b) Immediately upon assuming the duties of his or her office, the~~
 12 ~~director shall give bond to the board in the amount of five thousand dollars~~
 13 ~~(\$5,000), with good and sufficient sureties, approved by the board and~~
 14 ~~conditioned upon the faithful performance of all duties required or which may~~
 15 ~~be required of him or her by law or the regulations of the board.~~

 17 ~~17-26-204. Inspectors and professional employees.~~

18 ~~(a) The State Board of Cosmetology, in accordance with this chapter,~~
 19 ~~Department of Health may employ inspectors and professional employees and fix~~
 20 ~~their compensation, which compensation and all reasonable expenses incurred~~
 21 ~~shall be paid from the Cosmetology Operating Fund only Public Health Fund~~
 22 ~~from fees generated by the program.~~

23 ~~(b) Immediately upon assuming their duties, all inspectors shall give~~
 24 ~~bond to the board in the amount of one thousand dollars (\$1,000) with good~~
 25 ~~and sufficient sureties approved by the board and conditioned upon the~~
 26 ~~faithful performance of all duties required or that may be required by law or~~
 27 ~~the regulations of the board.~~

28 ~~(c) All inspectors shall have had five (5) years' experience in the~~
 29 ~~licensed practice of cosmetology.~~

 31 ~~17-26-205. Powers and duties.~~

32 ~~(a) In addition to the other duties set forth in this chapter, the~~
 33 ~~State Board of Cosmetology Department of Health shall:~~

34 ~~(1) Prescribe the duties of its the department's employees with~~
 35 ~~all day to day and employment decisions to be made by the Director of~~
 36 ~~Cosmetology;~~

~~(2) Establish a principal office in Pulaski County where all records of its proceedings and other records and files of the board shall be kept and which shall, at all reasonable hours, be open to public inspection;~~

~~(3) Adopt a seal;~~

~~(4)~~(2) Hold examinations as to the qualifications of all applicants for registration whose applications have been submitted to it in proper form, unless otherwise provided;

~~(5)~~(3) Issue permits and licenses to ~~such~~ the applicants ~~as may be who are~~ entitled thereto;

~~(6)~~(4) Register cosmetological establishments and schools of cosmetology;

~~(7) At each regular meeting, approve disbursement of all funds;~~

~~(8) Report to the proper officials all known violations of this chapter; and~~

~~(9)~~(5) ~~Adopt reasonable~~ Implement the State Board of Health's rules ~~and regulations~~:

(A) For carrying out the provisions of this chapter;

(B) For conducting examinations of applicants for licensing;

(C) For governing the recognition and the credits to be given to the study of cosmetology or any of its branches, under a cosmetologist or in a school of cosmetology, licensed under the laws of another state; and

(D) For governing health and safety, as it ~~deems~~ considers necessary, in regard to the precautions to be employed to prevent the creating or spreading of infections or contagious diseases in cosmetological establishments, in schools of cosmetology, and in the practice of a cosmetologist and in any branch of cosmetology, provided the rules ~~and regulations~~ meet the minimum requirements of the law ~~and rules and regulations of the State Board of Health~~. A copy of all rules governing health and safety shall be ~~furnished~~ made available to each licensee. The rules ~~and regulations~~ adopted under this subsection shall have the force and effect of law.

(b) In addition to the powers conveyed upon the ~~board~~ department by this chapter, ~~it the department is empowered to~~ may enforce the provisions of this chapter or any reasonable rule ~~or regulation~~ adopted by ~~it the board~~

1 through injunctive process.

2 (c) The ~~board~~ department may incur reasonable expenses and perform
3 such other acts as may be necessary to carry out its duties and functions and
4 to administer this chapter.

6 17-26-206. Meetings – Examinations.

7 (a) The ~~State Board of Cosmetology inspectors~~ Department of Health or
8 a private testing entity shall administer licensing examinations for eligible
9 applicants ~~on a monthly basis~~.

10 (b) ~~No~~ A member of the ~~board~~ Cosmetology Technical Advisory Committee
11 shall not be permitted to participate in or have the powers and duties that
12 are related to the preparation of examinations ~~nor shall~~ or be permitted to
13 give or grade the examinations of applicants for licensing.

14
15 17-26-207. Registration record.

16 The ~~State Board of Cosmetology~~ Department of Health shall keep a
17 registration record containing the names, known places of business, and the
18 date and number of the license of every licensed cosmetologist and of those
19 engaged in the practice of any branch of cosmetology, together with the names
20 and addresses of all cosmetological establishments and schools of cosmetology
21 registered under this chapter. This record shall also contain such facts as
22 the applicants may have stated in their applications for examination for
23 permitting and licensing.

24
25 17-26-208. Investigations, hearings, or inspections.

26 (a) The ~~State Board of Cosmetology~~ Department of Health shall conduct
27 investigations and inspections as promulgated by rule.

28 (b)(1) Hearings conducted by the Cosmetology Technical Advisory
29 Committee may be held bimonthly for review of cases for which disciplinary
30 action may be required.

31 (2)(A) Except as provided in subdivision (b)(2)(B) of this
32 section, a hearing attended by two (2) or more members of the ~~board~~ committee
33 is a meeting.

34 (B) A final order shall not be imposed by fewer than ~~five~~
35 ~~(5)~~ three (3) members.

36 (C) A final order imposed by the committee may be appealed

1 to the State Board of Health within thirty (30) days of its receipt.

2
3 17-26-209. Fees – Method of payment.

4 (a) ~~The State Board of Cosmetology~~ State Board of Health shall
5 promulgate a fee schedule by rule and collect fees accordingly.

6 (b) In addition to any other method of payment acceptable to the ~~board~~
7 Department of Health, the ~~board~~ department shall accept personal or business
8 checks drawn on deposit accounts in financial institutions as payment for
9 fees collected by the ~~board~~ department.

10
11 17-26-210. Disposition of funds.

12 (a) All fees, fines, and penalties collected under this chapter and on
13 behalf of the ~~State Board of Cosmetology~~ State Board of Health and all
14 receipts of every kind and nature collected under this chapter shall be paid
15 into the State Treasury and shall be credited to the ~~Cosmetology Operating~~
16 Fund Public Health Fund.

17 ~~(b)(1) The fund shall be for the general uses of the board and out of~~
18 ~~it shall be paid all salaries and all other expenses necessarily incurred in~~
19 ~~carrying into effect the provisions of this chapter. The fees, fines,~~
20 penalties, and receipts shall be for the general uses of the Department of
21 Health.

22 (2) Salaries and other expenses necessarily incurred in carrying
23 into effect the provisions of this chapter and other programs administered by
24 the department shall be paid from the fees, fines, penalties, and receipts.

25 (c) Expenditures ~~from the fund~~ shall be substantiated by vouchers and
26 itemized statements at the end of each fiscal year or at any other time when
27 demand therefor is made by the Department of Finance and Administration.

31 (a) ~~Every~~ Each application for admission to examination and ~~every~~ each

33 shall be in writing on blanks prepared and furnished by the ~~State Board of~~
34 Cosmetology Department of Health.

35 (b) Each application shall be accompanied by the required fee and
36 shall contain proof of the qualifications of the applicant for examination

1 for registration and license.

2 (c) The application shall be verified by the oath of the applicant.

13 (2) Has completed two (2) years of high school in the public
14 schools of this state or its equivalent; and

27 17-26-306. Electrologists – Prerequisites to examination.

28 ~~The State Board of Cosmetology~~ Department of Health shall admit to
29 examination for a license as an electrologist ~~any~~ a person who has made
30 application to the board in proper form, has paid the fee required, and who:

31 (1) Is not less than eighteen (18) years of age;

32 (2) Has completed the twelfth grade or an accredited senior high
33 school in the public schools of this state or its equivalent; and

34 (3) Has completed ~~any~~ one (1) of the following:

35 (A) A course of three hundred fifty (350) ~~hours~~ hours of
36 practical training as a student in conjunction with a course of fifteen

1 hundred (1500) hours in cosmetology or for a licensed cosmetologist;

2 (B) A course of six hundred (600) ~~hours~~ hours of
 3 practical training as a student, when not in conjunction with a regular

 17 has made application to the ~~board~~ department in proper form, has paid the fee
 18 required, and who:

27 changing the address of his or her place of business as designated on the
28 books of the ~~State Board of Cosmetology~~ Department of Health, shall notify
29 the ~~State Board of Cosmetology administrative office~~ department of his or her
30 new place of business. Upon receipt of the notification, the ~~office~~
31 department shall make the necessary changes in the register.

33 SECTION 11. Arkansas Code § 17-26-319 is amended to read as follows:

34 17-26-319. Expiration, renewal, and reinstatement.

35 (a) Licenses of cosmetologists, instructors, electrologists,
36 aestheticians, and manicurists shall expire on the licensee's birthday on a

1 biennial basis.

2 (b) Licenses of schools and establishments shall expire in one (1) of
3 the following ways at the choice of the school or establishment owner:

4 (1) Annually on December 31;

5 (2) Biennially on December 31; or

6 (3) Biennially on the owner's birthday in conjunction with the
7 individual license.

8 (c) Application for license renewals shall be filed and the fee paid
9 not later than thirty (30) days following the expiration date established in
10 subsection (a) of this section.

11 (d) A licensee whose license has lapsed for failure to renew and who
12 is or was under the direct supervision of a physician for an extended or
13 long-term condition may request from the ~~State Board of Cosmetology~~
14 Department of Health a waiver of the reinstatement fee.

15 (e) After five (5) years from the date of its expiration, a license
16 may be reinstated upon the filing of an application as the ~~board~~ department
17 may prescribe, the payment of the examination fee, and the passing of the
18 examination required by the ~~board~~ department.

19 (f) The ~~board~~ department is authorized and directed to renew, upon
20 application and the payment of the necessary fees, the license of a
21 cosmetologist, manicurist, aesthetician, instructor, or electrologist who is
22 also a veteran of war who possessed the license but permitted it to lapse.
23 The renewal license shall be issued without the applicant's being required to
24 submit to any examination or to meet any additional schooling requirements.

25 (g)(1) A licensee who is sixty-five (65) years of age or older and has
26 been actively engaged in the practice or teaching of cosmetology for thirty
27 (30) or more years may apply for a lifetime license.

28 (2) The fee for a lifetime license shall be established by rule
29 of the board.

30 (3) The receipt of a lifetime license shall not exempt a
31 licensee from:

32 (A) Complying with any applicable law or rule; and

33 (B) Receiving a penalty for failing to comply with ~~any~~ an
34 applicable law or rule.

35
36 SECTION 12. Arkansas Code § 17-26-321 is amended to read as follows:

1 17-26-321. Reissuance and reinstatement.

2 For good cause shown and under such reasonable rules and regulations as
3 may be imposed, the ~~State Board of Cosmetology~~ Department of Health may
4 reissue or reinstate the license of any person whose license has been
5 previously revoked.

7 SECTION 13. Arkansas Code § 17-26-323 is repealed.

8 ~~17-26-323. Use of funds from penalties.~~

9 ~~Funds derived from penalties assessed by the State Board of Cosmetology~~
10 ~~pursuant to the authority granted in this chapter shall be maintained in a~~
11 ~~separate bank account and shall be used exclusively to defray the costs of~~
12 ~~disciplinary hearings and any other enforcement actions, including the~~
13 ~~investigation thereof, and all necessary costs for the development and~~
14 ~~staffing needs for educational training purposes under § 17-26-104(e)(5)(C).~~

18 (a) ~~Any~~ A person, firm, or corporation desiring to operate a
19 cosmetological establishment shall make an application to the ~~State Board of~~
20 ~~Cosmetology~~ Department of Health for a license.

21 (b) The application shall be accompanied by the required licensing
22 fee.

23
24 SECTION 15. Arkansas Code § 17-26-403 is amended to read as follows:

25 17-26-403. School of cosmetology – Application to operate – License.

26 (a) Schools of cosmetology shall be conducted as provided in this
27 subchapter.

28 (b) ~~(1) Any person, firm, or corporation, except the Department of~~
29 ~~Education, desiring to conduct a school of cosmetology shall make an~~
30 ~~application to the State Board of Cosmetology for approval. When an~~
31 ~~application is made after January 1, there shall be paid to the board that~~
32 ~~portion of the registration fee that the unexpired number of months in the~~
33 ~~year bears to the entire year, including the month in which the application~~

 11 ~~shall disqualify himself or herself from the consideration of applications~~
 12 ~~for new schools of cosmetology or license renewals.~~

13 ~~(d)~~(c) The license authorizes the school of cosmetology holding it to
 14 transact operations in this state during the year or fraction thereof for
 15 which it is issued subject to the rules of the ~~board~~ department.

16 ~~(e)~~(d) Nothing in this section shall be construed as authorization or
 17 permission to conduct a school of cosmetology without a valid, existing, and
 18 unexpired license.

 20 SECTION 16. Arkansas Code § 17-26-404 is amended to read as follows:

21 17-26-404. Licensing requirements – Expiration – Renewal.

22 (a) Licensing for cosmetological establishments and schools of
 23 cosmetology expires pursuant to § 17-26-319(b).

24 (b) An application for renewal of a license shall be filed with the
 25 ~~State Board of Cosmetology~~ Department of Health, accompanied by the required
 26 renewal fee.

27 (c) Thereupon, the ~~board~~ department shall renew the license for the
 28 appropriate time period.

29 (d) A license that has expired for failure of the registrant to renew
 30 within the time fixed by this section may for a period of one (1) year
 31 thereafter be renewed upon the filing of an application in such form as the
 32 ~~board~~ department may require and upon payment of the required renewal fee and
 33 the delinquency fee.

34 (e) After one (1) year from the date of its expiration, a certificate
 35 may not be renewed, and the establishment or school may again become entitled
 36 to a license only upon compliance with all of the provisions of this chapter

1 relating to the original issuance of a license.

8 are submitted to the ~~board~~ department in connection with a license
9 application, this in itself shall constitute sufficient grounds for the
10 refusal to grant any application under this subchapter. If an application is
11 granted and thereafter the ~~board~~ department discovers that false statements
12 were made in connection therewith, this shall constitute sufficient grounds
13 for the cancellation of the school license even though the false statements

20 authorized to accept service of notice from the ~~board~~ department and to
21 transact all business negotiations on behalf of the school, including answers
22 to citations for hearing and compliance with rulings issued by the ~~board~~
23 committee.

26 17-26-407. Inspection of school facilities.

27 (a) Before any school license ~~as provided in~~ under this subchapter
28 shall be finally granted, a second inspection shall be made after the
29 equipment has been installed and before the school is permitted to begin
30 operation.

31 (b) ~~No An~~ applicant shall not be granted a license to operate a school
32 unless the ~~State Board of Cosmetology~~ Department of Health finds that
33 sufficient equipment has been installed for the requirements of enrolling a
34 minimum of not fewer than twenty-five (25) bona fide students and that not
35 fewer than twenty-five (25) bona fide full-time student registration requests
36 have been received in the case of any new school. New schools of cosmetology

1 shall be required to contain not less than two thousand five hundred square

5 17-26-408. Duties of school.

6 ~~Every~~ Each school shall:

7 (1) Possess sufficient apparatus and equipment necessary for the
8 ready and full teaching of all the subjects or practices of cosmetology;

9 (2) Maintain licensed instructors competent to impart
10 instruction in all branches or practices of cosmetology;

11 (3) Keep a daily record of the attendance of each student and
12 the time devoted by each student to the various practices or branches of
13 cosmetology and electrology;

14 (4) Establish grades and hold examinations before issuing
15 diplomas; and

16 (5) Fix its tuition at an amount that will enable it to furnish
17 without further charge to the student all cosmetics, materials, and supplies

24 (a) ~~Every~~ Each person employed in a school to instruct students in the
25 school shall be a licensed cosmetologist, aesthetician, manicurist, or
26 electrologist who:

27 (1) Is twenty-one (21) years of age or older and has had six
28 hundred (600) hours of teacher training in a school of cosmetology over a
29 period of not less than four (4) months; and

30 (2) Has passed an instructor's examination given by the ~~State~~
31 ~~Board of Cosmetology~~ Department of Health and has received an instructor's
32 license.

33 (b) A licensed instructor shall not teach outside the profession in

SECTION 21. Arkansas Code § 17-26-411 is amended to read as follows:

17-26-411. Instructors – Duties – Number.

(a) All instructors shall be continuously engaged in teaching students in theoretical or practical work. Except when instructing a student, ~~no~~ an instructor may not practice upon a client, and any instructor who does so is subject to disciplinary action by the ~~State Board of Cosmetology~~ Cosmetology Technical Advisory Committee.

(b) The ~~board~~ State Board of Health shall promulgate reasonable rules ~~and regulations~~ concerning the number of instructors necessary to properly conduct a school of cosmetology.

SECTION 22. Arkansas Code § 17-26-412 is amended to read as follows:

17-26-412. School term – Cosmetology curriculum.

(a) ~~Every~~ Each school shall maintain a school term of not less than one thousand five hundred (1,500) hours, instruction of which shall not be in excess of eight (8) hours per day and six (6) days per week during the course. The school shall maintain a course of practical training and technical instruction equal to the requirements for examination for a license as a cosmetologist.

(b) It shall so arrange the courses devoted to each branch or practice of cosmetology as the ~~State Board of Cosmetology~~ Department of Health may from time to time adopt as the course to be followed by the schools.

SECTION 23. Arkansas Code § 17-26-413 is amended to read as follows:

17-26-413. Electrology course.

(a)(1) An electrology course established by a school of cosmetology shall consist of three hundred fifty (350) hours or six hundred (600) hours of practical training and technical instruction which shall extend over a period of not less than two (2) months for a three-hundred-fifty-hour course and four (4) months for a six-hundred-hour course.

(2) In no event shall the training extend over a period of more than six (6) months from the date of initial enrollment.

(b) The course shall be in accordance with a curriculum established by the ~~State Board of Cosmetology~~ Department of Health.

21 student, in work connected with any branch or any combination of the branches
22 of cosmetology taught in the school upon a client who is paying for service
23 or materials;

24 (2) A student for a license as a manicurist, after sixty (60)
25 hours of instruction, may engage, in the school as a student, in work
26 connected with manicuring taught in the school upon a client who is paying
27 for service or materials;

28 (3) A student for a license as an aesthetician, after sixty (60)

8 (B) The student has completed three-quarters (3/4) of the
9 course of study;

10 (C) The student is accompanied by and acts under the
11 direct supervision of a licensed instructor; and

12 (D) The student receives no credit hours toward the course

14 (2) Documentation shall be maintained in the student's school
15 file outlining the date, name, and location of the event and the number of
16 hours volunteered.

17 (3) A school shall provide a thirty-day notice to the ~~State~~

19 a natural disaster as proclaimed by the Governor.

20 (4) A student shall not provide services to an elderly person
21 who is confined to a hospital or nursing home.

22 (e)(1) A student providing services under this section shall apply for

24 (2) The ~~board~~ State Board of Health shall promulgate rules
25 concerning the issuance of student permits.

26 (3) A student permit shall contain a photograph of the student.

27 (4) The student permit shall be:

28 (A) Maintained by the owner of the school attended by the
29 student during the student's enrollment; and

30 (B) Returned to the ~~board~~ department along with a copy of
31 the student's Certificate of Training upon the conclusion of the student's
32 enrollment in the school.

35 17-26-418. Cosmetology courses in public schools.

36 (a) All public educational institutions operating cosmetological

1 schools shall comply with the standards, rules, and regulations promulgated
2 by the State Board of ~~Cosmetology~~ Health. However, the responsibility for
3 approval of cosmetological schools in public educational institutions shall
4 be the sole responsibility of the State Board of Workforce Education and
5 Career Opportunities.
