(5)(A) Adopt, publish, and, from time to time, revise such rules and regulations not inconsistent with the law as may be necessary to enable it to carry into effect the provisions of this chapter. (B) The rules under subdivision (5)(A) of this section shall state that an acupuncturist shall not administer, dispense, or prescribe a legend drug as defined under § 20-64-503; (6) Keep a record of all its proceedings, receipts, and disbursements: (7) Adopt standards for applicants wishing to take the licensing examination and conduct examinations or contract with persons or entities to conduct examinations of applicants; (8)(A) Grant, deny, renew, suspend, or revoke licenses to practice acupuncture and related techniques for any cause stated in this chapter. (B) Except as otherwise provided by this chapter, the board shall have exclusive jurisdiction to determine who shall be permitted to practice acupuncture and related techniques in the State of Arkansas; and (9) Conduct disciplinary proceedings as provided in under this chapter.
