15 SECTION 6. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 16 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. 17 REALLOCATION OF RESOURCES. Upon determination by the president or chancellor of an institution of higher education that a reallocation of resources for 18 purposes of reorganization or consolidation of administrative functions 19 within the institution is necessary for efficient and effective operations of 20 21 the institution, the president or chancellor, with approval of the 22 institution's board of trustees, may have the authority to transfer 23 positions, appropriations and related funds between campuses, divisions, 24 branches, and other budgetary units of the institution, after receiving prior approval of the Legislative Council or Joint Budget Committee. The transfers 25 26 of positions, programs, or activities shall be used for those purposes for 27 which the appropriations were approved by the General Assembly. The 28 transfers, consolidations, or reorganizations which involve academic programs 29 shall be reviewed by the Department of Higher Education prior to submission 30 to the Legislative Council or Joint Budget Committee. Provided, however, that 31 the institution shall be limited to submitting no more than $\frac{1}{1}$ two (2) 32 individual transaction transfer requests during any fiscal year and shall be 33 further limited to no more than five percent (5%) of the total General 34 Revenue and Special Revenue appropriation, funding, positions specific to 35 each institution and no Tobacco Settlement funds or appropriations may be 36 reallocated pursuant to this section.

1 Determining the maximum number of employees and the maximum amount of 2 appropriation and general revenue funding for institutions of higher education each fiscal year is the prerogative of the General Assembly. 3 This 4 is usually accomplished by delineating such maximums in the appropriation 5 act(s) for institutions of higher education and the general revenue 6 allocations authorized for each fund and fund account by amendment to the 7 Revenue Stabilization law. Further, the General Assembly has determined that 8 institutions of higher education may operate more efficiently if some 9 flexibility is provided to institutions of higher education authorizing broad 10 powers under this Section. Therefore, it is both necessary and appropriate 11 that the General Assembly maintain oversight by requiring prior approval of the Legislative Council or Joint Budget Committee as provided by this 12 section. The requirement of approval by the Legislative Council or Joint 13 14 Budget Committee is not a severable part of this section. If the requirement 15 of approval by the Legislative Council or Joint Budget Committee is ruled 16 unconstitutional by a court of competent jurisdiction, this entire section is 17 void.

18 The provisions of this section shall be in effect only from July 1, $\frac{2007}{19}$ 19 $\frac{2009}{1000}$ through June 30, $\frac{2009}{2010}$.

21 SECTION 7. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 22 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. LEASES. Notwithstanding any law to the contrary, the Board of Trustees of Arkansas 23 24 State University may hereafter lease facilities for operations for room and 25 board purposes for students only in any manner and upon terms the board deems 26 to be in the best interest of the university. Action taken under this act 27 shall be by written resolution adopted by at least a majority of the members 28 of the board.

29 The provisions of this section shall be in effect only from July 1, $\frac{2007}{30}$ 30 $\frac{2009}{2010}$ through June 30, $\frac{2009}{2010}$.

32 SECTION 8. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 33 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. FUND 34 BALANCES. The Board of Trustees in its official governing capacity charged 35 with the management or control of the institution of higher learning and the 36 President or Chancellor as the Chief Executive shall certify to the Chief

1 Fiscal Officer of the State and the Legislative Council that as of December 2 31 of each year that sufficient appropriations and funds are available, or will become available, to meet all current and anticipated obligations during 3 4 the fiscal year for the payment of the obligations when they become due. 5 This certification, signed by the Chair of the Board of Trustees and the 6 President or Chancellor will be forwarded by February 28 of each year or upon 7 release of the previous year's audit by Legislative Audit to the Chief Fiscal 8 Officer of the State and the Legislative Council accompanied by the Board 9 approved published annual financial statement for the preceding fiscal year. The provisions of this section shall be in effect only from July 1, 2007 10

13 SECTION 9. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized 14 by this act shall be limited to the appropriation for such agency and funds 15 made available by law for the support of such appropriations; and the 16 restrictions of the State Procurement Law, the General Accounting and 17 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary Procedures and Restrictions Act, the Higher Education Expenditures 18 19 Restrictions Act, or their successors, and other fiscal control laws of this State, where applicable, and regulations promulgated by the Department of 20 21 Finance and Administration, as authorized by law, shall be strictly complied 22 with in disbursement of said funds.

23

24 SECTION 10. LEGISLATIVE INTENT. It is the intent of the General Assembly 25 that any funds disbursed under the authority of the appropriations contained 26 in this act shall be in compliance with the stated reasons for which this act 27 was adopted, as evidenced by the Agency Requests, Executive Recommendations 28 and Legislative Recommendations contained in the budget manuals prepared by 29 the Department of Finance and Administration, letters, or summarized oral 30 testimony in the official minutes of the Arkansas Legislative Council or Joint Budget Committee which relate to its passage and adoption. 31

33 SECTION 11. EMERGENCY CLAUSE. It is found and determined by the General

34 Assembly, that the Constitution of the State of Arkansas prohibits the

35 appropriation of funds for more than a one (1) year period; that the

36 effectiveness of this Act on July 1, 2009 is essential to the operation of

1	the agency for which the appropriations in this Act are provided, and that in
2	the event of an extension of the Regular Session, the delay in the effective
3	date of this Act beyond July 1, 2009 could work irreparable harm upon the
4	proper administration and provision of essential governmental programs.
5	Therefore, an emergency is hereby declared to exist and this Act being
6	necessary for the immediate preservation of the public peace, health and
7	safety shall be in full force and effect from and after July 1, 2009.
