4	SECTION 2. LEGISLATIVE INTENT. It is the intent of the General Assembly
5	that any funds disbursed under the authority of the appropriations contained
6	in this act shall be in compliance with the stated reasons for which this ac
7	was adopted, as evidenced by the Agency Requests, Executive Recommendations
8	and Legislative Recommendations contained in the budget manuals prepared by
9	the Department of Finance and Administration, letters, or summarized oral
10	testimony in the official minutes of the Arkansas Legislative Council or
11	Joint Budget Committee which relate to its passage and adoption.
12	
13	SECTION 3. EMERGENCY CLAUSE. It is found and determined by the General
14	Assembly, that funds provided by the General Assembly for the operations of
15	the Arkansas State Game and Fish Commission are, due to unforeseen
16	circumstances, insufficient for the Arkansas State Game and Fish Commission
17	to continue to provide essential governmental services; that the provisions
18	of this act will provide the necessary monies for the Arkansas State Game an
19	Fish Commission to continue such services; and that a delay in the effective
20	date of this Act could work irreparable harm upon the proper administration
21	and provision of essential governmental programs. Therefore, an emergency is
22	hereby declared to exist and this Act being necessary for the immediate
23	preservation of the public peace, health and safety shall be in full force
24	and effect from and after the date of its passage and approval.
25	If the bill is neither approved nor vetoed by the Governor, it shall become
26	effective on the expiration of the period of time during which the Governor
27	may veto the bill. If the bill is vetoed by the Governor and the veto is
28	overridden, it shall become effective on the date the last house overrides
29	the veto.
