23	SECTION 1. APPROPRIATION - TRIAL PUBLIC DEFENDER OFFICE. There is hereby

26	Public Defender Commission which shall be supplemental and in addition to									
27	those funds appropriated in Section 6 of Act 1223 of 2007, the following:

3	SECTION 2. COMPLIANCE WITH OTHER LAWS. Disbursement	of	funds authorized
4	by this act shall be limited to the appropriation for su	.ch	agency and funds
5	made available by law for the support of such appropriat	ion	s; and the
6	restrictions of the State Procurement Law, the General A	.cco	unting and
7	Budgetary Procedures Law, the Revenue Stabilization Law,	th	e Regular Salary
8	Procedures and Restrictions Act, or their successors, an	d o	ther fiscal
9	control laws of this State, where applicable, and regula	tio	ns promulgated by
10	the Department of Finance and Administration, as authori	zed	by law, shall be
11	strictly complied with in disbursement of said funds.

13	SECTION 3. LEGISLATIVE INTENT. It is the intent of t	he	General Assembly
14	that any funds disbursed under the authority of the appr	opr	iations contained
15	in this act shall be in compliance with the stated reaso	ns	for which this act
16	was adopted, as evidenced by the Agency Requests, Execut	ive	Recommendations
17	and Legislative Recommendations contained in the budget	man	uals prepared by
18	the Department of Finance and Administration, letters, o	r s	ummarized oral
19	testimony in the official minutes of the Arkansas Legisl	ati	ve Council or
20	Joint Budget Committee which relate to its passage and a	dop	tion.

22	SECTION 4. EMERGENCY CLAUSE. It is found and determi	ned	by the General
23	Assembly, that funds provided by the General Assembly fo	r t	he operations of
24	the Arkansas Public Defender Commission are, due to unfo	res	een circumstances,
25	insufficient for the Arkansas Public Defender Commission	to	continue to
26	provide essential governmental services; that the provis	ion	s of this act will
27	provide the necessary monies for the Arkansas Public Def	end	er Commission to
28	continue such services; and that a delay in the effective	e d	ate of this Act
29	could work irreparable harm upon the proper administrati	on	and provision of
30	essential governmental programs. Therefore, an emergency	is	hereby declared
31	to exist and this Act being necessary for the immediate	pre	servation of the
32	public peace, health and safety shall be in full force a	nd	effect from and
33	after the date of its passage and approval.		
34	If the bill is neither approved nor vetoed by the Gove	rno	r, it shall become
35	effective on the expiration of the period of time during	wh	ich the Governor
36	may veto the bill. If the bill is vetoed by the Governo	r a	nd the veto is
