24	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
25	
26	SECTION 1. REGULAR SALARIES - SUSTAINABLE BUILDING DESIGN PROGRAM. There
27	is hereby established for the Arkansas Building Authority for the 2009-2010
28	fiscal year, the following maximum number of regular employees whose salaries
29	shall be governed by the provisions of the Uniform Classification and
30	Compensation Act (Arkansas Code §§21-5-201 et seq.), or its successor, and
31	all laws amendatory thereto. Provided, however, that any position to which a
32	specific maximum annual salary is set out herein in dollars, shall be exempt
33	from the provisions of said Uniform Classification and Compensation Act. All
34	persons occupying positions authorized herein are hereby governed by the
35	provisions of the Regular Salaries Procedures and Restrictions Act (Arkansas
36	Code §21-5-101), or its successor.

SECTION 4. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 5 6 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. 7 SUSTAINABLE BUILDING DESIGN PROGRAM - TRANSFER. In the event there is not 8 sufficient appropriation and/or funding provided for by the General Assembly 9 for any state agency, board or commission to participate in the Sustainable 10 Building Design Program for renovations of state owned property which exceeds 11 two hundred fifty thousand dollars (\$250,000), the agency may request a 12 transfer from the Sustainable Building Design Program appropriation authorized in Section 3 of this Act from the Chief Fiscal Officer of the 13 14 State. The request shall clearly state the amount required and such other 15 information as may be required by the Chief Fiscal Officer of the State 16 necessary to make a decision regarding the request. Upon approval of the 17 Chief Fiscal Officer of the State and prior review by the Arkansas 18 Legislative Council or Joint Budget Committee, the State Auditor shall be 19 notified as of the amount and the purposes for which the appropriation and/or 20 funding is to be transferred and shall be established upon the books of the Department of Finance and Administration and the State Auditor. If desired, 21 22 the appropriation may be supplemental to those regularly appropriated for 23 like purposes by the General Assembly for that agency. 24 Provided further, that all state agencies, boards or commissions shall have 25 prior approval by the Arkansas Building Authority as authorized for the 26 Sustainable Building Design Program in accordance with established Rules and 27 Regulations. 28 29 SECTION 5. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 30 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. SUSTAINABLE BUILDING DESIGN PROGRAM - REVOLVING LOAN FUND. The Sustainable 31 32 Building Design Program Appropriation is intended to provide additional 33 appropriation authority for the Sustainable Building Design Program. Funding 34 for the program may be made available by the Chief Fiscal Officer of the 35 State, in the form of a loan, from a transfer from the Sustainable Building

36 Design Revolving Loan Fund after the required review by the Arkansas

1	Legislative Council or Joint Budget Committee, approval by the Chief Fiscal
2	Officer of the State and approval through rules and regulations established
3	and administered by the Arkansas Building Authority. Moneys made available
4	for the repayment of a loan shall be deposited to the credit of the
5	Sustainable Building Design Revolving Loan Fund as a "Refund to Expenditure"
6	for the year in which the deposit is made. In the event that the funds for
7	the repayment of a loan are held in depositories other than the State
8	Treasury, the administrative head of the affected state agency shall issue a
9	check drawn against the funds, which shall be deposited in the Sustainable

12	SECTION 6. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
13	CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.
14	SUSTAINABLE BUILDING DESIGN PROGRAM - RULES AND REGULATIONS. Rules and
15	Regulations shall be established and administered by the Arkansas Building
16	Authority for the Sustainable Building Design Program prior to the
17	implementation of any transfers of appropriation and/or funding. The Rules
18	and Regulations shall be reviewed by the Legislative Council or Joint Budget
19	Committee prior to implementation.

21	SECTION 7. SPECIAL LANGUAGE. <u>Sustainable Building Design Revolving Loan</u>
22	<u>Fund.</u>
23	(a) There is hereby created on the books of the Treasurer of State, Auditor
24	of State, and Chief Fiscal Officer of the State a miscellaneous fund to be
25	known as the "Sustainable Building Design Revolving Loan Fund".
26	(b)(1) The fund shall consist of funds transferred to it from the General
27	Improvement Fund or other funds, gifts, bequests, foundation grants and
28	gifts, Governor's or other emergency funds, federal grants and matching
29	funds, proceeds from bond issues, service charges or fees, interagency
30	transfers of funds, and other funds as may be appropriated by the General
31	Assembly.
32	(2) The fund shall consist of funds received from agencies, boards or
33	commissions to repay loans for the Sustainable Building Design Program, funds
34	made available by the General Assembly from time to time and such revenues as
35	may be authorized by law.
36	(c) The fund shall be used to provide loans to agencies for the Sustainable

<u>Building Design Program as authorized by law and approved by the Chief Fiscal</u>
Officer of the State.

4 SECTION 8. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 5 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. FUNDING 6 TRANSFER. The Chief Fiscal Officer of the State may transfer from time to 7 time on his or her books and those of the State Treasurer and the Auditor of 8 the State funding which is made available from General Improvement Funds 9 allocated and distributed to the Arkansas Building Authority in an amount not 10 to exceed three million dollars (\$3,000,000) from the General Improvement 11 Fund or its successor fund or fund accounts to the Sustainable Building 12 Design Revolving Loan Fund to provide funds for the appropriation provided herein or for appropriation authority as may be provided by law to provide 13 14 loans to agencies for the Sustainable Building Design Program. 15

16 SECTION 9. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 17 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. FUNDING TRANSFER. From time to time, the Chief Fiscal Office of the State may 18 transfer on his or her books and those of the State Treasurer and the Auditor 19 20 of the State the sum not to exceed twelve million dollars (\$12,000,000) from 21 Federal Funds as determined by the Chief Fiscal Officer of the State to the 22 Sustainable Building Design Revolving Loan Fund to provide funds for the 23 appropriations herein.

24

25 SECTION 10. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized 26 by this act shall be limited to the appropriation for such agency and funds 27 made available by law for the support of such appropriations; and the 28 restrictions of the State Procurement Law, the General Accounting and 29 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary 30 Procedures and Restrictions Act, or their successors, and other fiscal control laws of this State, where applicable, and regulations promulgated by 31 32 the Department of Finance and Administration, as authorized by law, shall be 33 strictly complied with in disbursement of said funds.

34

35 SECTION 11. LEGISLATIVE INTENT. It is the intent of the General Assembly 36 that any funds disbursed under the authority of the appropriations contained

in this act shall be in compliance with the stated reasons for which this act was adopted, as evidenced by the Agency Requests, Executive Recommendations and Legislative Recommendations contained in the budget manuals prepared by the Department of Finance and Administration, letters, or summarized oral testimony in the official minutes of the Arkansas Legislative Council or Joint Budget Committee which relate to its passage and adoption.

8	SECTION 12. EMERGENCY CLAUSE. It is found and determined by the General
9	Assembly, that the Constitution of the State of Arkansas prohibits the
10	appropriation of funds for more than a one (1) year period; that the
11	effectiveness of this Act on July 1, 2009 is essential to the operation of
12	the agency for which the appropriations in this Act are provided, and that in
13	the event of an extension of the Regular Session, the delay in the effective
14	date of this Act beyond July 1, 2009 could work irreparable harm upon the
15	proper administration and provision of essential governmental programs.
16	Therefore, an emergency is hereby declared to exist and this Act being
17	necessary for the immediate preservation of the public peace, health and
18	safety shall be in full force and effect from and after July 1, 2009.
