31 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

33 *SECTION 1. Arkansas Code Title 6, Chapter 20, Subchapter 6 is amended*
34 *to add an additional section to read as follows:*

35 *6-20-606. Administrative consolidation or administrative annexation of*
36 *isolated school districts.*



1 The State Board of Education shall not administratively consolidate or
2 administratively annex a school district that qualifies for funding under §
3 6-20-604(c)-(e) if the land mass of the resulting district or receiving
4 district will exceed one thousand square miles (1,000 sq. mi.) after a
5 consolidation or annexation under the Public Education Reorganization Act, §
6 6-13-1601 et seq.
