### Subtitle

16 TO CORRECT REFERENCES TO BIENNIAL  
17 SESSIONS IN THE ARKANSAS CODE TO CONFORM  
18 TO ARKANSAS CONSTITUTION, AMENDMENT 86.  
19  
20  
21

22 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
23

24 *SECTION 1. Arkansas Code Title 1, Chapter 2, Subchapter 2 is amended*  
25 *to add a new section to read as follows:*

26 *1-2-208. "Fiscal session" and "regular session" defined.*

27 *As used in the Arkansas Code, an act of the General Assembly, and an*  
28 *initiated measure:*

29 *(1) "Fiscal session" means with respect to the General Assembly*  
30 *the legislative session in which the General Assembly may consider only*  
31 *appropriation bills under Arkansas Constitution, Article 5, § 5(c) and*

32 *(2) "Regular session" means with respect to the General Assembly*  
33 *the legislative session in which the General Assembly may consider any bill*  
34 *under Arkansas Constitution, Article 5, § 5(b).*  
35

36 *SECTION 2. Arkansas Code § 1-5-102(b), concerning the closure of state*



1 offices on holidays, is amended to read as follows:

2 (b) It is the specific intent of this section that all state offices  
3 be closed on all legal holidays even though one (1) or more legal holidays  
4 shall fall during a ~~general~~ regular session, a fiscal session, or a special  
5 session of the General Assembly, provided that, with respect to state offices  
6 located in Pulaski County, those offices shall not be closed for any legal  
7 holiday during ~~any general~~ a regular session, a fiscal session, or a special  
8 session of the General Assembly unless they are permitted to close by  
9 resolution of the General Assembly, but those offices shall maintain only a  
10 minimum number of employees necessary to carry on the business of the  
11 offices.

12

13 SECTION 3. Arkansas Code § 3-5-907(a), concerning grant payments to  
14 wineries in the state, is amended to read as follows:

15 (a) Grant payments as authorized in this subchapter shall be made by  
16 the Director of the Department of Finance and Administration from moneys  
17 appropriated by the General Assembly for that purpose at each ~~biennial~~  
18 regular session and fiscal session of the General Assembly.

19

20 SECTION 4. Arkansas Code § 6-43-223 is amended to read as follows:

21 6-43-223. Reports – Publication.

22 (a)(1) The Board of Trustees and the Superintendent of the Arkansas  
23 School for the Blind shall make a full and complete report, to be submitted  
24 to the Governor and the General Assembly, not later than January 15 of each  
25 year the General Assembly is in regular session.

26 (2) These reports shall deal with improvements made during the  
27 ~~biennial period covered by them~~ the previous two (2) fiscal years, together  
28 with the suggestions and recommendations covering the institution for the  
29 next ~~legislative~~ two-year period.

30 (3) The report of the board of trustees shall cover the  
31 preceding school year.

32 (4)(A) The board of trustees and the superintendent shall each  
33 make detailed reports biennially to the General Assembly of their  
34 proceedings, the condition of the school, the number of pupils, and other  
35 facts connected with the institution, including the exact receipts and  
36 expenditures of the board of trustees.

1                   (B) The superintendent shall report to the board of  
2 trustees prior to each regular session of the General Assembly a detailed  
3 statement of the number of pupils admitted and discharged, their place of  
4 residence and supposed cause of blindness, the amount of money expended and  
5 for what purpose, and the probable sum necessary to defray the current  
6 expenses of the institution until the ~~ensuing~~ next regular session of the  
7 General Assembly, which report shall be embodied in that of the board of  
8 trustees.

9                   (5)(A) The reports shall be made and printed together not later  
10 than January 15 of each year the General Assembly is in regular session.

11                   (B) There shall be, of each biennial report of the board  
12 of trustees to the General Assembly, one thousand five hundred (1,500) copies  
13 printed – one thousand (1,000) for the use of the General Assembly and five  
14 hundred (500) for the school.

15  
16                   SECTION 5. Arkansas Code § 6-43-311(a), concerning biennial reports of  
17 the Arkansas School for the Deaf, is amended to read as follows:

18                   6-43-311. Biennial reports.

19                   (a) The Board of Trustees and the Superintendent of the Arkansas  
20 School for the Deaf shall make a full and complete report to be submitted to  
21 the Governor, which shall be printed together and presented to the General  
22 Assembly not later than January 16 of each year the General Assembly is in  
23 regular session.

24  
25                   SECTION 6. Arkansas Code § 6-61-210(a), concerning the allocation of  
26 additional state funds, is amended to read as follows:

27                   (a) The Arkansas Higher Education Coordinating Board is authorized and  
28 directed to establish criteria and standards for the allocation of additional  
29 state funds provided for such purposes to state-supported institutions of  
30 higher learning experiencing enrollment increases greater than were  
31 anticipated at the time the board prepared its budget recommendations for  
32 allocations of funds to the respective institutions prior to each ~~biennial~~  
33 ~~legislative~~ regular session and fiscal session.

34  
35                   SECTION 7. Arkansas Code § 6-67-114(a), concerning biennial reports to  
36 the General Assembly from the University of Central Arkansas, is amended to

1 read as follows:

2 (a) The Board of Trustees of the University of Central Arkansas shall  
3 biennially make a report to the General Assembly at the beginning of its  
4 regular session.

5  
6 SECTION 8. Arkansas Code § 10-2-101 is amended to read as follows:  
7 10-2-101. Time for meeting.

8 (a)(1) The General Assembly shall meet in ~~regular biennial~~ regular  
9 session at 12:00 noon on the second Monday in January in each odd-numbered  
10 year.

11 (2)(A) However, in any odd-numbered year following the election  
12 of a nonincumbent governor, the General Assembly upon convening at 12:00 noon  
13 on the second Monday in January may remain in session only for such time not  
14 to exceed two (2) days as is necessary to open and publish the votes for  
15 various constitutional offices, to swear in the state constitutional officers  
16 and members of the General Assembly, to organize and select officers, and to  
17 otherwise prepare for the regular session.

18 (B) ~~It~~ The General Assembly may then stand in recess for a  
19 period of not to exceed thirty (30) days.

20 (b)(1) The General Assembly shall meet in a fiscal session at 12:00  
21 noon on the second Monday in February of each even-numbered year to consider  
22 appropriation bills.

23 (2) A bill other than an appropriation bill may be considered in  
24 a fiscal session if two-thirds (2/3) of the members of each house of the  
25 General Assembly approve consideration of the nonappropriation bill.

26  
27 SECTION 9. Arkansas Code § 10-2-102(b), concerning the employees of  
28 the Senate, is amended to read as follows:

29 (b) The employees of the Senate shall perform such duties during the  
30 regular session of the General Assembly and during the interim between the  
31 convening of special sessions, fiscal sessions, and the ~~next regular session~~  
32 regular sessions of the General Assembly as may be provided by the rules of  
33 the Senate or by the Senate Efficiency Committee, subject to the approval of  
34 the Senate.

35  
36 SECTION 10. Arkansas Code § 10-2-107(a), concerning the election of

1 the Speaker of the House, is amended to read as follows:

2 (a) If, after the biennial general election and prior to the convening  
3 of the ~~General Assembly~~ regular session, a statement signed by fifty (50) or  
4 more members of the House of Representatives who will serve at the next-  
5 following regular session of the General Assembly is filed with the current  
6 Speaker of the House of Representatives stating that the members believe that  
7 the formal election of the new Speaker of the House is in doubt, then the  
8 current Speaker of the House shall call a one-day organizational meeting of  
9 all members and members-elect of the House of Representatives who will serve  
10 at the next regular session. This meeting shall be held for the single  
11 purpose of designating the Speaker of the House for the next General  
12 Assembly.

13  
14 SECTION 11. Arkansas Code § 10-2-112(a)(1), concerning the prefiling  
15 of bills and resolutions, is amended to read as follows:

16 (a)(1) The Chief Clerk of the House of Representatives and the  
17 Secretary of the Senate, under the direction and supervision of the Speaker  
18 of the House of Representatives and the President Pro Tempore of the Senate,  
19 shall establish a system for the prefiling of bills and resolutions beginning  
20 on:

21 (A) November 15 of each year preceding a regular session  
22 of the General Assembly; and

23 (B)(1) The second Monday of January of each year of a  
24 fiscal session the General Assembly.

25 (2) A non-appropriation bill may not be pre-filed prior to a  
26 fiscal session due to the requirement in Amendment 86 of the Constitution of  
27 Arkansas that a concurrent resolution be approved by a vote of two-thirds  
28 (2/3) of the members elected to each house before either body may consider a  
29 non-appropriation bill.

30  
31 SECTION 12. Arkansas Code § 10-2-113(b), concerning senate  
32 confirmation of board and commission appointees, is amended to read as  
33 follows:

34 (b)(1) The Governor shall submit to the Senate within thirty (30) days  
35 after the General Assembly convenes in ~~regular~~ a regular session or a fiscal  
36 session the names of all appointments to boards and commissions of this state

1 made subsequent to adjournment of the Senate at the last regular session of  
2 the General Assembly.

3 (2) Upon the convening of a special session of the General  
4 Assembly, the Governor shall immediately submit the names of all appointments  
5 to boards and commissions of this state made subsequent to adjournment of the  
6 Senate at the last regular session, fiscal session, or special session of the  
7 General Assembly.

8 (3) All appointments of members of boards and commissions of  
9 this state made while the General Assembly is in session shall be submitted  
10 immediately to the Senate.

11  
12 SECTION 13. Arkansas Code § 10-2-115 is amended to read as follows:

13 10-2-115. Introduction of bills affecting public retirement programs.

14 (a) Any proposed legislation affecting any publicly supported  
15 retirement system or pension plan to be considered by the General Assembly at  
16 a regular ~~biennial~~ session shall be introduced in the General Assembly during  
17 the first fifteen (15) calendar days of a regular ~~biennial~~ session.

18 (b)(1) No such bill shall be introduced after the fifteenth day of a  
19 regular ~~biennial~~ session unless its introduction is first approved by a  
20 three-fourths ( $\frac{3}{4}$ ) vote of the full membership of each house of the General  
21 Assembly.

22 (2) Additionally, if the General Assembly recesses for longer  
23 than three (3) consecutive days during the first fifteen (15) days of a  
24 regular ~~biennial~~ session, the fifteen-day introduction deadline shall be  
25 extended for a time period equal to the recess.

26 (c) A bill affecting any publicly supported retirement system or  
27 systems shall not be introduced or considered at any special session or  
28 fiscal session of the General Assembly unless the introduction and  
29 consideration of the bill is first approved by a three-fourths ( $\frac{3}{4}$ ) vote of  
30 the full membership of each house of the General Assembly.

31  
32 SECTION 14. Arkansas Code § 10-2-127(b), concerning fiscal impact  
33 statements, is amended to read as follows:

34 (b) Any bill filed in the House of Representatives or Senate that will  
35 impose a new or increased cost obligation for education in grades  
36 kindergarten through twelve (K-12) on the State of Arkansas or any local

1 school district shall have a fiscal impact statement attached to it prepared  
2 and filed with the chair of the committee to which the bill is referred:

3 (1) At least three (3) days before the bill may be called up for  
4 final action in the committee during a regular session of the General  
5 Assembly; ~~and~~

6 (2) At least three (3) days before the bill may be called up for  
7 final action in the committee during a fiscal session; and

8 (3) At least one (1) day before the bill may be called up for  
9 final action in the committee during a special session of the General  
10 Assembly.

11  
12 SECTION 15. Arkansas Code § 10-2-131 is amended to read as follows:  
13 10-2-131. Internet broadcast of proceedings.

14 (a) During regular sessions, fiscal sessions, and special sessions of  
15 the General Assembly, the House of Representatives and the Senate may  
16 broadcast live audio and video of their proceedings on the Internet.

17 (b) This requirement includes only proceedings held in the House  
18 Chamber and the Senate Chamber.

19  
20 SECTION 16. Arkansas Code § 10-3-303(c)(2), concerning duties of the  
21 Bureau of Legislative Research, is amended to read as follows:

22 (2) Assist all members of the General Assembly upon request  
23 while the General Assembly is in regular session, fiscal session, or special  
24 session in drafting bills and resolutions, and making studies, preparing  
25 factual information, and by performing other services for members of the  
26 General Assembly as may be reasonably requested and which are in aid of the  
27 performance of the legislative duties of the members of the General Assembly;  
28

29 SECTION 17. Arkansas Code § 10-3-304, is amended to read as follows:  
30 10-3-304. Sessions – Studies – Cooperation of state agencies.

31 (a)(1) The Legislative Council shall convene at any time during the  
32 interim between regular sessions, fiscal sessions, or special sessions of the  
33 General Assembly and shall remain in session for such time as it considers  
34 necessary for the consideration of all matters relating to state government,  
35 not however, for more than a total of ninety (90) days which need not be  
36 continuous.

1           (2) *The Legislative Council shall convene and hold its sessions*  
2 *at the State Capitol at the seat of government or at other places as the*  
3 *Legislative Council may determine, and ample notice of all sessions ~~thereof~~*  
4 *shall be given by the Executive Secretary to the Legislative Council in*  
5 *advance of the sessions.*

6           (b) *The Legislative Council shall undertake such studies or*  
7 *investigations as may be directed by the General Assembly or either house*  
8 *~~thereof~~ of the General Assembly. In addition, any member of the General*  
9 *Assembly shall be privileged when the General Assembly is not in session to*  
10 *submit resolutions or study proposals to the Legislative Council for its*  
11 *consideration, study, and recommendations.*

12           (c) *The Legislative Council shall report any findings and*  
13 *recommendations to each regular session, fiscal session, or special session*  
14 *of the General Assembly for the repeal or amendment of existing laws or for*  
15 *the enactment of new laws with respect to the operation of the state*  
16 *government or with respect to any matter that is a subject for legislative*  
17 *consideration.*

18           (d) *All departments and agencies of the state government are directed*  
19 *to cooperate with the Legislative Council and with the Bureau of Legislative*  
20 *Research in providing assistance, information, or data when requested so that*  
21 *the General Assembly might be fully advised of all matters with respect to*  
22 *the operation of the various state agencies, departments, and institutions.*

23  
24           SECTION 18. *Arkansas Code § 10-3-308 is amended to read as follows:*  
25           10-3-308. *Presession budget briefings – Compensation.*

26           (a)(1) *The Legislative Council is authorized to conduct or cause to be*  
27 *conducted budget briefings for members and members-elect of the General*  
28 *Assembly during the presession budget hearings conducted by the Legislative*  
29 *Council and the Joint Budget Committee preceding each regular session and*  
30 *fiscal session of the General Assembly for the purpose of informing*  
31 *interested members and members-elect of the General Assembly concerning*  
32 *budget requests, executive recommendations, and Legislative Council and*  
33 *Committee recommendations regarding the budgets for the various state*  
34 *agencies, institutions, departments, and programs.*

35           (2) *If at any time during the Legislative Council and Joint*  
36 *Budget Committee ~~biennial~~ hearings preceding each regular session and fiscal*



1 session of the General Assembly it appears that there is not sufficient  
2 interest or attendance by members and members-elect of the General Assembly  
3 to justify continuation of budget briefings, the chairs and co-vice chairs of  
4 the Legislative Council are authorized to terminate any further briefings  
5 during that particular ~~biennial~~ budget session.

6 (b) Each member of the General Assembly who will serve during the  
7 upcoming regular session or fiscal session of the General Assembly and each  
8 member-elect of the General Assembly shall be entitled to attend the budget  
9 briefings conducted pursuant to the provisions of this section. Each member  
10 attending the budget briefings shall be entitled to per diem and mileage for  
11 attending briefings at the rate prescribed by law for members of the General  
12 Assembly who attend meetings of the interim committees of the General  
13 Assembly, to be payable from moneys appropriated for payment of per diem and  
14 mileage for attendance at meetings of interim committees.

15  
16 SECTION 19. Arkansas Code § 10-3-508 is amended to read as follows:  
17 10-3-508. Duties.

18 In addition to participation by members of the Joint Budget Committee  
19 in the presession budget hearings of the Legislative Council, as authorized  
20 in § 10-3-507, the Joint Budget Committee during ~~regular~~ a regular session,  
21 fiscal session, and a special sessions session of the General Assembly shall  
22 perform any duties as are provided by the Joint Rules of the House of  
23 Representatives and Senate.

24  
25 SECTION 20. Arkansas Code § 10-3-703(a), concerning the Joint  
26 Committee on Public Retirement and Social Security Programs, is amended to  
27 read as follows:

28 (a) Upon adjournment of each regular session, fiscal session, and  
29 special session of the General Assembly, the Joint Committee on Public  
30 Retirement and Social Security Programs is designated and constituted as a  
31 joint interim committee of the General Assembly to be known as the "Joint  
32 Interim Committee on Public Retirement and Social Security Programs".

33  
34 SECTION 21. Arkansas Code § 10-3-820(a), concerning the Joint Interim  
35 Committee on Energy, is amended to read as follows:

36 (a) The members of the House of Representatives and the Senate

1 appointed at each regular session of the General Assembly to the Joint  
2 Committee on Energy shall constitute a joint interim committee of the General  
3 Assembly to function in the interim between the sine die adjournment or  
4 extended recess of the regular session or fiscal session of each General  
5 Assembly until the convening of the next regular session or fiscal session of  
6 the General Assembly or reconvening of the current General Assembly during an  
7 extended recess. This joint interim committee shall be known as the "Joint  
8 Interim Committee on Energy" and shall function in addition to the other  
9 interim committees of the General Assembly established by law. In the event a  
10 vacancy shall occur on the joint interim committee, the vacancy shall be  
11 filled in the same manner as provided for the initial appointment.  
12

13 SECTION 22. Arkansas Code § 10-3-1103 is amended to read as follows:

14 10-3-1103. When committee functions – Administrative responsibilities.

15 (a) The Joint Interim Committee on Legislative Facilities shall  
16 function during the interim between regular sessions, fiscal sessions, or  
17 special sessions of the General Assembly and may function, if necessary,  
18 while the General Assembly is in regular session, fiscal session, special  
19 session, or an extension of a regular, fiscal, or special session, for the  
20 purpose of discharging its duties under this subchapter.

21 (b) The committee shall administer all provisions of this subchapter  
22 relating to repairs, improvements, and furnishing of committee rooms and  
23 legislative facilities in the State Capitol Building, including, if  
24 necessary, the payment of rental required for the housing of state agencies  
25 moved from the State Capitol Building as a result of any project undertaken  
26 by the committee pursuant to the provisions of this subchapter until space  
27 for the agencies may be provided in other public facilities.  
28

29 SECTION 23. Arkansas Code § 10-3-1320(a) and (b), concerning the  
30 Senate Interim Committee on Children and Youth, are amended to read as  
31 follows:

32 (a) The Senate Interim Committee on Children and Youth shall be  
33 composed of ten (10) members appointed pursuant to Senate Rules and shall  
34 function in the interim between the sine die adjournment or extended recess  
35 of the regular session or fiscal session of each General Assembly until the  
36 convening of the next regular session or fiscal session of the General

1 *Assembly or the convening of the current General Assembly during an extended*  
2 *recess.*

3 *(b) The committee shall make continuing studies pertaining to the*  
4 *safety, health, development, and problems of children. The studies may either*  
5 *be initiated by the committee or referred to it by either house of the*  
6 *General Assembly for study in the interim between sessions of the General*  
7 *Assembly. Interim study proposals and resolutions relating to children, which*  
8 *are filed with the Legislative Council under the provisions of § 10-3-214 for*  
9 *review and referral to the appropriate germane joint interim committee of the*  
10 *General Assembly, shall be referred to the committee. The committee shall*  
11 *undertake each study referred to it by members of the General Assembly or by*  
12 *the Legislative Council and shall submit a report of its findings and*  
13 *recommendations in regard to each study request prior to the convening of the*  
14 *next ~~regular~~ session of the General Assembly.*

15

16 *SECTION 24. Arkansas Code § 10-3-1602(2), concerning the duties of the*  
17 *Joint Interim Oversight Committee on Education Reform, is amended to read as*  
18 *follows:*

19 *(2) Reviewing policy issues affecting educational reform on or*  
20 *before November 15 of the year preceding a ~~regularly scheduled legislative~~*  
21 *regular session and making recommendations concerning any necessary*  
22 *legislative changes proposed by school districts, cooperatives, institutions*  
23 *of higher education, the Department of Education, the State Board of*  
24 *Education, the Department of Workforce Education, the State Board of*  
25 *Workforce Education and Career Opportunities, the Department of Higher*  
26 *Education, the Arkansas Higher Education Coordinating Board, the Governor's*  
27 *office, and private institutions;*

28

29 *SECTION 25. Arkansas Code § 10-3-1704(a) and (b), concerning the Joint*  
30 *Committee on Advanced Communications and Information Technology, is amended*  
31 *to read as follows:*

32 *(a) The members of the House of Representatives and the Senate*  
33 *appointed at each regular session of the General Assembly to the Joint*  
34 *Committee on Advanced Communications and Information Technology shall*  
35 *constitute a joint committee of the General Assembly to function during and*  
36 *in the interim between the sine die adjournment or extended recess of the*

1 regular session or fiscal session of each General Assembly, until the  
2 convening of the next regular or fiscal session of the General Assembly or  
3 reconvening of the current General Assembly, or during an extended recess.

4 (b)(1)(A) The committee shall make continuing studies concerning the  
5 development of access to a statewide public telecommunications network for  
6 distance learning, telemedicine, and universal access for governmental  
7 entities, and other issues concerning advanced communications and information  
8 technology, either initiated by the committee or referred to it by either  
9 house of the General Assembly for study, in the interim between sessions of  
10 the General Assembly.

11 (B)(i) Interim study proposals and resolutions filed with  
12 the Legislative Council under the provisions of § 10-3-214 for review and  
13 referral to the appropriate germane interim committee of the General  
14 Assembly, relating to advanced communications and information technology,  
15 shall be referred to the committee.

16 (ii) The committee shall undertake each study  
17 referred to it by members of the General Assembly or by the Legislative  
18 Council and shall submit a report of its findings and recommendations in  
19 regard to each study request to the General Assembly prior to the convening  
20 of the next ~~regular~~ session of the General Assembly.

21 (iii) The committee shall review any plan developed  
22 or updated by a public instrumentality.

23 (2) In addition, the committee shall exercise leadership in the  
24 interim between legislative sessions and shall attempt to coordinate for the  
25 various committees of the General Assembly the various activities, studies,  
26 and planning activities of the General Assembly which relate to the  
27 development of access to a statewide public telecommunications information  
28 infrastructure.

29 (3) The committee shall have the power and authority, upon  
30 approval of a majority of the members of the committee, to subpoena persons,  
31 documents, and records. However, no action of the committee regarding the  
32 exercise of the subpoena power shall be taken except upon notice of at least  
33 one (1) week to all members of the committee or upon a two-thirds (2/3) vote  
34 of the membership of the committee.

35 (4) The committee shall cooperate with the Governor, with public  
36 secondary and postsecondary institutions of education, with the appropriate

1 administrative agencies of this state, with legislative and administrative  
2 agencies and institutions of other states, and with the federal government  
3 and others in the planning and development of access to a statewide public  
4 telecommunications infrastructure linking institutions, businesses,  
5 government agencies, schools, hospitals, libraries, communities, and other  
6 public and private entities to the national information infrastructure.

7  
8 SECTION 26. Arkansas Code § 10-3-2204(a), concerning the Academic  
9 Facilities Oversight Committee, is amended to read as follows:

10 (a) The Academic Facilities Oversight Committee shall function during  
11 the interim between regular session, fiscal sessions, or special sessions of  
12 the General Assembly, while the General Assembly is in session, and while the  
13 General Assembly is in recess.

14  
15 SECTION 27. Arkansas Code § 10-4-405(b), concerning the Legislative  
16 Auditor, is amended to read as follows:

17 (b)(1) If the Legislative Auditor is selected while the General  
18 Assembly is not in session, he or she shall in all respects carry out the  
19 functions, powers, and duties as provided in this subchapter until the next  
20 regular session or fiscal session of the General Assembly.

21 (2)(A) During the next ~~regular legislative session~~ regular
