20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

22 *SECTION 1. Arkansas Code § 6-1-301(b), concerning the membership of*
23 *the Arkansas Commission for Coordination of Educational Efforts, is amended*
24 *to read as follows:*

25 *(b) The Arkansas Commission for Coordination of Educational Efforts is*
26 *composed of the following members:*

27 *(1) The Director of the Department of Higher Education;*

28 *(2) The Commissioner of Education;*

29 *(3) The Director of the Department of Workforce Education;*

30 *(4) The Director of the Division of Child Care and Early*
31 *Childhood Education of the Department of Human Services or his or her*
32 *designee;*

33 *(5) The Director of the Arkansas Economic Development*
34 *Commission;*

35 *(6) The Vice President for Agriculture of the University of*
36 *Arkansas System;*

2 *Authority;*
- 3 (8) *The Director of the Department of Information Systems or his*
4 *or her designee;*
- 5 (9) *The Governor or the Governor's designee;*

- 8 (11) *One (1) public school teacher appointed by the Governor;*
- 9 (12) *One (1) president or chancellor of a four-year university*
10 *appointed by the Presidents Council;*
- 11 (13) *One (1) president or chancellor of a two-year college or*
12 *two-year branch of a four-year university appointed by the council;*
- 13 (14) *One (1) member of the board of trustees of a four-year*
14 *university or system of colleges and universities appointed by the council;*
- 15 (15) *One (1) member of the board of trustees of a two-year*
16 *college or branch appointed by the council;*
- 17 (16) *One (1) member appointed by the President Pro Tempore of*
18 *the Senate from a list of three (3) nominees submitted by the Executive*
19 *Director of the Arkansas Education Association;*
- 20 (17) *One (1) member appointed by the Speaker of the House of*
21 *Representatives from a list of three (3) nominees submitted by the Executive*
22 *Director of the Arkansas Association of Educational Administrators;*
- 23 (18) *One (1) member appointed jointly by the Speaker of the*
24 *House of Representatives and the President Pro Tempore of the Senate from a*
25 *list of three (3) nominees submitted by the Executive Director of the*
26 *Arkansas School Boards Association; and*
- 27 (19) *One (1) representative of a predominantly black college or*
28 *university in Arkansas appointed by the Speaker of the House of*
29 *Representatives;*
- 30 (20) One (1) member appointed by the Speaker of the House of
31 Representatives who is from the private sector and has an interest in
32 science, technology, engineering, or math; and
- 33 (21) One (1) member appointed by the President Pro Tempore of
34 the Senate who is from the private sector and has an interest in science,
35 technology, engineering, or math.
