12	"convicted" includes a deferred conviction, deferred prosecution, deferred
13	sentence, finding or verdict of guilt, and admission of guilt, an alford
14	plea, or a plea of nolo contendere; and
15	$\frac{(10)}{(13)}$ Is in violation of any provisions of this chapter or
16	any regulation promulgated by the board.
17	(b) The procedure in all disciplinary actions shall be as prescribed
18	by the Arkansas Administrative Procedure Act,  25-15-201 et seq., and shall
19	include the power to subpoena documents and people.

21	SECTION 9. Arkansas Code § 17-93-312 is amended to read as follows:
22	17-93-312. Continuing education requirements.
23	(a)(1) A licensed physical therapist shall complete two (2) continuing
24	education units, equivalent to twenty (20) contact hours, in each biennium.
25	(2) A licensed physical therapist assistant shall complete one
26	(1) continuing education unit, equivalent to ten (10) contact hours, in each
27	biennium All licensed physical therapists and licensed physical therapist
28	assistants shall complete continuing education for licensure renewal as
29	established in the rules of the Arkansas Physical Therapy Board.
30	(b)(1) The Arkansas State Board of Physical Therapy board shall
31	approve continuing education units and their program content.
32	(2) The board may require the payment of reasonable fees for
33	review and approval of continuing education programs.
