11 OF STATE FROM THE FEDERAL GOVERNMENT FOR A SALE,
12 LEASE, ROYALTY, BONUS, OR RENTAL OF OIL, GAS, OR
13 MINERAL LANDS BELONGING TO THE FEDERAL GOVERNMENT
14 AND LOCATED IN THIS STATE; AND FOR OTHER
15 PURPOSES.

17 TO SIMPLIFY THE METHOD OF DISTRIBUTION
18 OF MONEYS RECEIVED BY THE STATE FOR OIL
19 AND GAS LEASES ON LAND BELONGING TO THE

25 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
26

27 *SECTION 1. Arkansas Code § 19-7-402(d)(1), concerning the receipt and*
28 *distribution of federal funds from the sale of public domain lands and leases*
29 *is amended to read as follows:*

30 *(d)(1) ~~It shall be the duty of the Department of Education to The~~*
31 *Treasurer of State shall distribute that portion of the funds ~~accruing that~~*
32 *accrue to the schools to the respective counties, and ~~the duty of the Auditor~~*
33 *~~of State~~ to distribute the funds ~~accruing that accrue~~ to the county road*
34 *funds.*

36 *SECTION 2. Arkansas Code § 19-7-801 is amended to read as follows:*



1 ~~19-7-801. Federal lands other than military Federal lands.~~

2 ~~(a) Such funds as are received from and after April 15, 1983, by the~~
 3 ~~Treasurer of State from the federal government on account of the sale of~~
 4 ~~minerals, oil, and gas or the lease of minerals, oil, and gas on lands other~~
 5 ~~than military lands belonging to the federal government located in the state~~
 6 ~~shall be deposited into the State Treasury, and the Treasurer of State shall~~
 7 ~~credit the funds as follows:~~

8 ~~(1) All these funds received during each calendar year shall be~~
 9 ~~first distributed to the respective counties in which the funds were~~
 10 ~~generated until the benefiting counties receive a distribution of these funds~~
 11 ~~equal to the amount of the funds received in the 1981-82 fiscal year, and all~~
 12 ~~moneys in excess of the amount generated in the counties in excess of the~~
 13 ~~amount received in the 1981-82 fiscal year shall be retained by the Treasurer~~
 14 ~~of State for distribution as provided in subdivision (a)(2) of this section.~~
 15 ~~Funds received by each benefiting county under this subsection shall be~~
 16 ~~allocated in the same proportion, to be used for the same purposes as funds~~
 17 ~~received by each county under the provisions of subdivision (a)(2) of this~~
 18 ~~section.~~

19 ~~(2) After the requirements of subdivision (a)(1) have been met~~
 20 ~~each year, all additional funds so deposited into the State Treasury shall be~~
 21 ~~credited by the Treasurer of State as follows:~~

 23 ~~the General Revenue Fund Account of the State Apportionment Fund, for~~

15 ~~shall be divided between the school districts based on the most recent~~
16 ~~average daily membership of each school district as defined in § 6-20-303~~

18 ~~(ii) Fifteen percent (15%) of the funds shall be~~
19 ~~distributed to the County Aid Fund, to be distributed by the Treasurer of~~
20 ~~State to the county road funds of the counties to which these moneys are~~
21 ~~allocated;~~

22 ~~(iii) Twenty five percent (25%) of the funds shall~~
23 ~~be distributed to the County Aid Fund, for distribution by the Treasurer of~~
24 ~~State to the county treasurer of the county to which the funds are to be~~
25 ~~distributed. Upon receipt of these funds, the county treasurer of the county~~
26 ~~shall distribute the funds to the county general fund and to the respective~~
27 ~~cities, towns, school districts, community college districts, and county and~~
28 ~~municipal libraries in the county in a proportion that each taxing unit~~
29 ~~shares in the real and personal property taxes collected in the county, with~~
30 ~~the exception that the school districts in the county and the county road~~

9 (b) Moneys received under subsection (a) of this section by and after
10 September 1, 2008, by the Treasurer of the State shall be credited by the
11 Treasurer of State as follows:

12 (1) Fifty percent (50%) of the moneys received shall be credited
13 to the General Revenue Fund Account of the State Apportionment Fund for
14 distribution to various funds that participate in the distribution of general
15 revenues in the respective proportion to each fund, to be used for the
16 purposes under the Revenue Stabilization Law, § 19-5-101 et seq.; and

17 (2) Fifty percent (50%) of the moneys received shall be
18 distributed to the counties in which the federal lands that generate the
19 moneys are located according to federal reports that identify the counties
20 with the federal lands that generate the moneys. Moneys under this
21 subdivision (b)(2) shall be distributed by the Treasurer of the State as
22 follows:

23 (A) Sixty percent (60%) of the moneys shall be distributed
24 to the County Aid Fund, to be distributed by the Treasurer of State to the
25 county treasurer of each county that has a school district with a boundary
26 that includes a portion of the federal lands that generate the moneys.

27 (i) A county is responsible for distributing moneys
28 under subdivision (b)(2)(A)(i) of this section to a school district with a
29 boundary that includes a portion of the federal lands that generate the
30 moneys.

31 (ii) If there is more than one (1) school district
32 with a boundary that includes a portion of the federal lands that generate
33 the moneys within a county receiving these moneys, then each school district
34 in that county shall receive a proportionate share of the moneys based on the
35 school district's portion of the acreage over the total acreage in all
36 districts in that county; and

1 (B) Fifteen percent (15%) of the moneys received under
 2 subdivision (b)(2) of this section shall be distributed to the County Aid
 3 Fund, to be distributed by the Treasurer of State to the county treasurer for
 4 credit to the county road funds of the counties to which these moneys are
 5 allocated; and

6 (C) Twenty-five percent (25%) of the moneys received under
 7 subdivision (b)(2) of this section shall be distributed to the County Aid
 8 Fund, for distribution by the Treasurer of State to the county treasurer of
 9 the county to which the moneys are to be distributed.

10 (i) Except as provided under subdivision
 11 (b)(2)(C)(ii) of this section, on receipt of the moneys under subdivision
 12 (b)(2)(C) of this section, the county treasurer of the county shall
 13 distribute the moneys to the county general fund and to the respective
 14 cities, towns, school districts, community college districts, and county and
 15 municipal libraries in the county in the proportion that each taxing unit
 16 shares in the real and personal property taxes collected in the county.

17 (ii) A school district in the county that receives a
 18 distribution of funds under subdivisions (b)(2)(A) and (B) of this section
 19 and the county road fund that receives a distribution of funds under
 20 subdivisions (b)(2)(A) and (B) of this section are not entitled to receive an
 21 additional distribution of the funds under subdivision (b)(2)(C) of this
 22 section.

26 ~~(a) Such funds as are received from and after April 15, 1983, by the~~
 27 ~~Treasurer of State from the federal government on account of the sale of~~

 30 ~~in this section as "federal military lands", shall be deposited into the~~
