17 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
18

19 *SECTION 1. Arkansas Code § 17-95-301(b), concerning the membership of*
20 *the Arkansas State Medical Board, is amended to read as follows:*

21 *(b)(1)(A) The board shall consist of ~~thirteen (13)~~ fourteen (14)*
22 *members appointed by the Governor for terms of six (6) years.*

23 *(B) The Governor shall consider diversity of practice*
24 *specialties and geographical areas of practice in making appointments to the*
25 *board.*

26 *(2)(A)(i) ~~Nine (9)~~ Ten (10) members shall be duly qualified,*
27 *licensed, and active medical practitioners and appointed upon the advice and*
28 *recommendation of the Arkansas Medical Society.*

29 *(ii) At least two (2) members shall be appointed*
30 *from each of the state's four (4) congressional districts.*

31 *(iii) ~~One (1) member~~ Two (2) members shall be*
32 *appointed at large.*

33 *(B) Congressional district representation required under*
34 *this subdivision (b)(2) shall be achieved by appointment as vacancies occur.*

35 *(3) One (1) member shall be a licensed practicing physician in*
36 *this state and shall be appointed upon the advice and recommendation of the*



1 *Physicians' Section of the Arkansas Medical, Dental, and Pharmaceutical*
2 *Association.*

3 *(4) Two (2) members of the board shall not be actively engaged*
4 *in or retired from the practice of medicine. One (1) member shall represent*
5 *consumers, and one (1) member shall be sixty (60) years of age or older and*
6 *shall represent the elderly. Both shall be appointed from the state at large*
7 *subject to confirmation by the Senate. The two (2) positions may not be held*
8 *by the same person. Both shall be full voting members but shall not*
9 *participate in the grading of examinations.*

10 *(5) One (1) member shall be a duly qualified, licensed, and*
11 *practicing osteopathic physician and appointed upon the recommendation of the*
12 *Arkansas Osteopathic Medical Association.*
