1 RECESS OF THE GENERAL ASSEMBLY. 2 3 4 BE IT RESOLVED BY THE SENATE OF THE EIGHTY-SEVENTH GENERAL ASSEMBLY OF THE 5 STATE OF ARKANSAS, THE HOUSE OF REPRESENTATIVES CONCURRING THEREIN: 6 7 (a) That the Regular Session of the Eighty-Seventh General Assembly of 8 the State of Arkansas is extended until 12:00 noon, May 1, 2009; 9 That under Arkansas Constitution, Article 6, § 15, prior to (b) adjournment of the General Assembly, the Governor is afforded five days after 10 11 receipt of a bill to sign a bill or veto a bill, therefore from April 9, 2009 12 to May 1, 2009, the House Representatives and the Senate shall be open so 13 that the office of the Chief Clerk of the House of Representatives and the 14 office of the Secretary of the Senate may receive communications, vetoes of 15 bills by the Governor, and notification of errors and oversights; 16 That the Regular Session of the Eighty-Seventh General Assembly of (c) 17 the State of Arkansas shall enter into recess simultaneously at the close of 18 business in each chamber on April 9, 2009, or at such earlier time as may be 19 agreed upon by the House of Representatives and the Senate; That the Speaker of the House of Representatives and the President 20 (d) 21 Pro Tempore of the Senate may, by joint proclamation: 22 (1) Reconvene the General Assembly at any time before 12:00 23 noon, May 1, 2009, for the purpose of: 24 (A) Considering vetoes; 25 (B) Correcting errors and oversights; 26 (C) Completing its work on proposed constitutional 27 amendments; 28 (D) Considering any issues that may arise from the passage 29 of the federal stimulus package; and 30 (E) Considering the need for further extension of the 31 Regular Session of the Eighty-Seventh General Assembly; or 32 (2) Adjourn the Regular Session of the Eighty-Seventh General 33 Assembly at any time before 12:00 noon, May 1, 2009, if they determine it is not necessary to reconvene; and 34 35 (e) That if the General Assembly is not reconvened or adjourned before 36 12:00 noon, May 1, 2009, the Regular Session of the Eighty-Seventh General
