29	SECTION 5. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS		
30	CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.		
31	APPROPRIATION RESTRICTIONS - LAND ACQUISITION. In no event shall any funds		
32	appropriated to the War Memorial Stadium Commission be used for the		
33	acquisition of real estate without the prior review and approval of the		
34	Arkansas Legislative Council or Joint Budget Committee.		
35	Determining the maximum number of employees and t	he maximum amount of	
36	appropriation and general revenue funding for a stat	e agency each fiscal year	

- 1 is the function of the General Assembly. This is usually accomplished by
- 2 delineating such maximums as the appropriation in the appropriation act(s)
- 3 for a state agency and the general revenue allocations authorized for each
- 4 fund and fund account by amendment to the Revenue Stabilization law.
- 5 Therefore, it is both necessary and appropriate that the General Assembly
- 6 maintain oversight by requiring prior approval of the Legislative Council or
- 7 Joint Budget Committee as provided by this section. The requirement of
- 8 approval by the Legislative Council or Joint Budget Committee is not a
- 9 severable part of this section. If the requirement of approval by the
- 10 Legislative Council or Joint Budget Committee is ruled unconstitutional by a
- 11 court of competent jurisdiction, then the authority of the Commission to
- 12 acquire real estate is void.
- The provisions of this section shall be in effect only from July 1,
- 14 2007 2010 through June 30, 2009 2011.

- 16 SECTION 6. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized
- 17 by this act shall be limited to the appropriation for such agency and funds
- 18 made available by law for the support of such appropriations; and the
- 19 restrictions of the State Procurement Law, the General Accounting and
- 20 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
- 21 Procedures and Restrictions Act, or their successors, and other fiscal
- 22 control laws of this State, where applicable, and regulations promulgated by
- 23 the Department of Finance and Administration, as authorized by law, shall be
- 24 strictly complied with in disbursement of said funds.

- 26 SECTION 7. LEGISLATIVE INTENT. It is the intent of the General Assembly
- 27 that any funds disbursed under the authority of the appropriations contained
- 28 in this act shall be in compliance with the stated reasons for which this act
- 29 was adopted, as evidenced by the Agency Requests, Executive Recommendations
- 30 and Legislative Recommendations contained in the budget manuals prepared by
- 31 the Department of Finance and Administration, letters, or summarized oral
- 32 testimony in the official minutes of the Arkansas Legislative Council or
- 33 Joint Budget Committee which relate to its passage and adoption.

- 35 SECTION 8. EMERGENCY CLAUSE. It is found and determined by the General
- 36 Assembly, that the Constitution of the State of Arkansas prohibits the

1	appropriation of funds for more than a one (1) year period; that the
2	effectiveness of this Act on July 1, 2010 is essential to the operation of
3	the agency for which the appropriations in this Act are provided, and that in
4	the event of an extension of the legislative session, the delay in the
5	effective date of this Act beyond July 1, 2010 could work irreparable harm
6	upon the proper administration and provision of essential governmental
7	programs. Therefore, an emergency is hereby declared to exist and this Act
8	being necessary for the immediate preservation of the public peace, health
9	and safety shall be in full force and effect from and after July 1, 2010.
